# Race 1 HAWKE'S BAY HUNT MAIDEN HURDLE

WEE BISKIT (M Cropp) and JUST COLLIE (G Walsh) were slow away.

GET FLASH (S Fannin) jumped the first fence awkwardly when racing in restricted room between runners.

BACK IN BLACK (M Mitchell) put in a poor jump and landed awkwardly at the third fence.

**RUSSIANOV** (A Kuru) which was racing keenly had to be restrained passing the winning post on the first occasion when awkwardly placed inside the heels of **STUERTZER** (T Harris).

BACK IN BLACK blundered jumping the fence near the 1200 metres almost dislodging its rider.

**SUNSET PASS** (D Miller) misjudged the fence near the 1200 metres then put in poor jump at the next fence near the 1050 metres losing ground.

**WEBBY** (I Lupton) misjudged the fence near the 600 metres landing awkwardly and falling with both horse and rider making contact with the inside running rail. I Lupton was attended to by ambulance personnel and found to be uninjured. **WEBBY** incurred minor abrasions as a result of the fall.

**JUST COLLIE** put in a poor jump at the fence near the 600 metres before running wide rounding the final turn hampering **RUSSIANOV**. Rider G Walsh advised that the gelding had felt indifferent in its action for a short distance following its poor jump and in his opinion may have struck itself. **JUST COLLIE** was then retired from the race prior to jumping the last fence when out of contention.

A post-race veterinary of **SUNSET PASS** did not reveal any abnormalities other than a slow recovery rate.

A post-race veterinary check of **WEBBY** failed to reveal any abnormality.

Race 2 DESERT GOLD CLUB MAIDEN HURDLE

PROLOGUE (I Lupton) stood flat footed in its gate and as a result lost several lengths at the start.

**SOCIETY ROSE** (M Cropp) hesitated reaching the first fence running wide and jumping the hurdle awkwardly losing ground. **SOCIETY ROSE** continued to be inclined to run its fences down throughout the race.

**TEQUILA AT MIDNIGHT** (D Miller) was taken out by **SONNY BEN** (M Gillies) jumping the second fence making contact with **SKAI GLEN** (A Kuru).

**SELAMAT** (S Fannin) became awkwardly placed on the heels of **HUNTERS CREEK** (M Mitchell) when over-racing near the 1500 metres and when being steadied shifted out across the heels of **HUNTERS CREEK** hampering **TEQUILA AT MIDNIGHT**. S Fannin was advised to exercise more care.

PARTY HORSE (C Singer) put in a poor jump at the fence near the 1050 metres unbalancing its rider.

**PYCOK FLYER** (T Harris) landed awkwardly and blundered after jumping the fence at the 600 metres losing considerable ground and badly hampering **TEQUILA AT MIDNIGHT** which struck a heel and blundered. Also severely hampered as a result when crowded onto the running rail was **NOAH JON** (G Walsh).

**HUNTERS CREEK** misjudged the fence near the 600 metres when tiring and was not preserved with from that point when well beaten being retired from the race. A post-race veterinary inspection of **HUNTERS CREEK** did not reveal any abnormality.

#### Race 3 TE WHANGAI ROMNEY'S HAWKES BAY HURDLE

KING OF ROCK (C Studd) began very awkwardly losing several lengths.

**MONI NUI** (T Harris) jumped outwards at the first fence making solid contact with **BRER** (D Miller). **MONI NUI** also ran down the second fence again hampering **BRER**.

MAHANADI (M Gillies) jumped the first three fences indifferently and continued to mix its jumping throughout.

**AINTREE** (I Lupton) put in a poor jump near the 250 metres on the first occasion.

BRER jumped the fence near the 1800 metres awkwardly.

MALACHITE (M McNelis) hit the fence near the 1050 metres. MONI NUI also put in a poor jump at that fence.

**AINTREE** jumped the fence near the 900 metres awkwardly hampering **MONI NUI** which made contact with the running rail. **MONI NUI** then failed to respond when placed under pressure and was not persevered with from the 800 metres being retired from the race. Rider T Harris advised that after its poor jump at the 1050 metres the gelding had been quickly beaten. A post-race veterinary inspection did not reveal any abnormality.

AINTREE badly misjudged the second last fence.

**JUST GOT HOME** (C Singer) landed awkwardly after jumping the second last fence.

When questioned into the disappointing performance of **AINTREE** rider I Lupton stated that the gelding jumped indifferently throughout and was disappointing. Stewards ordered a veterinary inspection which failed to reveal any abnormality.

## Race 4 TARADALE CLUB MAIDEN SPRINT

KAYLEEN (L Magorrian) was slow to begin.

RUNWAY (M Dravitzki) began awkwardly.

ROCKY (A Taylor) and SUPER SCOT (S Doyle) over-raced when being restrained near the 1000 metres.

S Doyle (SUPER SCOT) dropped his whip early in the final straight.

**SUPER SCOT** shifted inwards near the 200 metres hampering **KAYLEEN**. S Doyle was issued with a warning.

**SANJARA** (V Johnston) had to be steadied over the final 50 metres when crowded between **BASTION** and **ROCKY.** Prior to the authorisation of dividends V Johnston viewed Stewards footage before electing not to proceed with a protest. Apprentice M Dee defended a subsequent charge of careless riding in that he permitted his mount **BASTION** to shift outwards over the concluding stages when not sufficiently clear of **SANJARA.** After hearing submissions the Judicial Committee found the charge to be proven with M Dee being suspended from the conclusion of racing on Saturday 5 July until the conclusion of racing on Wednesday 16 July, 4 riding days.

When questioned regarding the performance of **SILVER SHADOW** rider D Walsh stated that the filly had to work hard over the early stage to obtain the lead which told when placed under pressure in the final straight. A post-race veterinary inspection failed to reveal any abnormality.

# Race 5 JUST A SWAGGER HAWKE'S BAY HUNT MAIDEN CHASE

**HE'S INFRARED** (C Studd) began very awkwardly getting its head up, racing very ungenerously and being retired from the race. Rider C Studd advised that the gelding had refused to hit out after leaving the barriers very awkwardly. Trainer S Cann was advised that **HE'S INFRARED** is required to barrier trial satisfactorily prior to racing next.

AND THATZ SCOTTY (G Walsh) ran down the first fence.

**RADINKA** (I Lupton) jumped the first fence poorly.

**ANYTHING GOES** (N Quinn) jumped slowly early becoming tailed off and continued to jump indifferently throughout the race.

**DOUBLED UP** (T Harris) over-raced in the early stages before jumping poorly through the middle stages and being retired from the race. A post-race veterinary failed to reveal any abnormality.

D Miller (**AUTHENTIC**) lost his right iron at the fence near the 1000 metres on the first occasion and did not regain the use of the iron until near the 700 metres.

**AND THATZ SCOTTY** put in a poor jump at the fence near the 800 metres on the first occasion.

**RADINKA** put in a poor jump at the fence near the 1400 metres on the second occasion hampering **RIPDIDDLER** and **AND THATZ SCOTTY**.

**ANYTHING GOES** and **AND THATZ SCOTTY** were both retired from the race when well beaten.

**RIPDIDDLER** made contact with **MONTIPOLI** (M Mitchell) approaching the fence near the 800 metres prior to putting in a bad jump.

**RIPDIDDLER** and **AUTHENTIC** came together rounding the final turn.

RIPDIDDLER shifted outwards away from AUTHENTIC near the 300 metres hampering ATHENRY.

D Miller was fined \$250 by the Judicial Committee after admitting a charge of excessive use of the whip prior to the 200 metres on his mount **AUTHENTIC**.

#### Race 6 ANIMAL HEALTH DIRECT HAWKE'S BAY STEEPLECHASE

MR COMPOSED (E Farr) put in a poor jump at the first fence and fell. Rider E Farr was uninjured. A veterinary inspection found MR COMPOSED to be uninjured. Hampered as a result were DANE RULER (M Cropp), I'M ISAAC (D Miller) and with the worst affected being TOBOUGGIE NIGHTS (S Phelan) which had to take evasive action becoming tailed off. TOBOUGGIE NIGHTS never recovered and was retired from the race on the second circuit.

**CAPE KINAREVAL** (A Kuru) and **RANGATIRA** (C Perrett) came together jumping the second fence becoming unbalanced. **WOTABUZZ** (M Mitchell) ducked inwards approaching the fence near the 1400 metres jumping the fence slowly losing momentum.

**RANGITIRA** put in a poor jump at the fence near the 1000 metres on the second occasion.

**DUMINY** (I Lupton) was retired from the race after jumping the fence near the 800 metres when well beaten. When questioned rider I Lupton was of the opinion the gelding was better suited to a more rain affected track.

TIM (T Harris) misjudged the last fence.

A Kuru was spoken to regarding his whip use.

## Race 7 WAIROA WANDERERS PREMIER WINTER STAYERS

**FASTFOOT** (K Smith) jumped outwards abruptly from the barriers into the line of **DELECTA DREIMS** (M Dee) which made contact with **NGARIO** (J Parkes). This resulted in **DELECTA DREIMS** settling back.

LIKEAPINS (L Magorrian) jumped inwards and bumped JOSEPHINE (C O'Beirne).

FASTFOOT made contact with LIV'N PARADISE (V Johnston) near the 300 metres.

**FASTFOOT** was then hampered when **LIKEAPINS** (L Magorrian) shifted outwards under pressure. Apprentice L Magorrian was issued with a warning.

# Race 8 SPRING CARNIVAL STARTS 30 AUGUST STAYERS

SUNDAY'S NEWS (M Dravitzki) shifted inwards leaving the barriers hampering KIPKEINO (A Taylor).

SEA EAGLE (B Murray) was slow away.

ACUTELYGOLD (B Lammas) over-raced in the middle stages.

SELWYN (D Walker) had to be firmly restrained when awkwardly placed on heels near the 1500 metres

**SELWYN** was not persevered with in the final straight finishing a distant last. A post-race veterinary examination of **SELWYN** revealed cardiac arrhythmia. Connections were advised that **SELWYN** is required to trial with a veterinary

certificate of fitness including satisfactory ECG results to be provided.

Race 9 www.hawkesbayracing.co.nz SPRINT

GOLD WEDDING (M Dravitzki) began awkwardly.

PARTY ICE (K Chiong) shifted inwards on jumping away crowding VEGA (A Morgan) onto SUPERCEDE (B Lammas).

**SIR JACK REMINGTON** (L Magorrian) over-raced in the early and middle stages.

**FLINT** (A Taylor) raced three wide without cover.

**PONEKE** (D Turner) was steadied when awkwardly placed on the heels of **FLINT** near the 350 metres.

## Race 10 HAWKE'S BAY RACING MEMBER'S WINTER SPRINT FINALE

**GALWAY** (A Taylor) began awkwardly and was further hampered when crowded shortly after leaving the barriers losing ground.

**HESALLJAZZ** (J Riddell) jumped inwards abruptly at the start dictating **JIMMY MAC** (S Doyle) into the line of **LAVISH PRINCE** (C Anderson) which clipped that runner's heel and blundered.
