RACE COMMENTS:

Race 1THE BULLERITES & PIRATES ISLAND MINI GOLF MAIDEN (1400m)LA CROUPIER was slow to begin.Passing the 1200 metres DECANTER got its head up when being steadied to obtain a position closer to the rails.Rider S Muniandy defended a charge under Rule 638(1)(d) in that near the 1000 metres he allowed his mount UNICORN

POWER which was hanging in to shift inwards when insufficiently clear of **MERCI CHERIE** and **MISS ALICE**, both of which were crowded and had to be checked. After hearing evidence the JCA upheld the charge and suspended S Muniandy's licence to ride at race meetings for 3 days effective 25 March to 10 April inclusive.

Passing the 300 metres **KIATERE** which was weakening had to be steadied between **MERCI CHERIE** which was racing greenly and shifted out slightly, and **ROYALTY** (K Williams) which shifted in when placed under pressure. As Stewards were satisfied that K Williams reacted quickly when her mount shifted in, no further action was taken. **UNICORN POWER** lost the near hind plate during the running.

Race 2 DAN REARDON RACING STABLES BENCHMARK 75 (2000m)

RYAN JOHN and GOSSIP GIRL were slow to begin.

When the pace eased near the 1700 metres, COMMANDING OAK got its head up when being steadied.

LOCKET raced wide without cover for the majority of the race.

STINGRAY and RYAN JOHN improved wide rounding the home turn.

Shortly after straightening **CAPO** (D Bradley) shifted inwards abruptly and had to be straightened. When being straightened **CAPO** which was racing greenly shifted outwards and in doing so crowded **RED MAGIC** out onto **LOCKET** which in turn carried **COMMANDING OAK** out onto **SHE'S INSATIABLE** which bumped **STINGRAY**, with all horses becoming momentarily unbalanced. D Bradley was issued with a warning.

SHE'S INSATIABLE, THE GROOMSMAN and **COMMANDING OAK** were held up for clear running in the early part of the straight.

Approaching the 100 metres **LOCKET** which was weakening was crowded between **RED MAGIC** and **COMMANDING OAK**, both of which shifted ground.

D Bradley, the rider of **CAPO**, reported that in his opinion the gelding raced greenly and got to the front too soon in the early part of the straight and he will be advising connections to ride **CAPO** further back and to add blinkers to its gear. A post race veterinary examination of **COMMANDING OAK** which returned to the birdcage with blood present in its mouth revealed a small laceration to the tongue.

D Walsh, the rider of **GOSSIP GIRL**, reported that the mare received some crowding in the early stages of the race, after which she raced keenly for some distance. He advised that in the middle stages when the pace quickened **GOSSIP GIRL** was unable to maintain her position with the main body of the field, however once balanced up near the 500 metres the mare ran home nicely. He added that **GOSSIP GIRL** was not suited to today's pace of the race and is better suited in a fast run race.

Race 3 CANTERBURY EQUINE CLINIC 'PETERSENS JEWELLERS LADIES BRACELET' (1000m)

On jumping **BIG KAHUNA** was crowded between **DUNOON** and **HURUNUI**, both of which jumped awkwardly. As a result all three runners became momentarily unbalanced.

Near the 300 metres **GIRL OF MY DREAMS** and **PATRICIO** bumped on several occasions when both riders attempted to improve into the same run forward of them. Shortly after, **PATRICIO** which commenced to weaken was steadied when crowded by **NO SURRENDA** which when hanging inwards shifted in despite the efforts of its rider.

D Bradley reported that **NO SURRENDA** hung in throughout the home straight and proved difficult to ride.

Race 4

SELWYN RAKAIA VET SERVICES OPEN SPRINT (1200m)

PINSGOLD and **VALIANT** raced keenly in the early stages.

Approaching the 200 metres **PINSGOLD** and **TOMA VALEA**, both of which shifted ground, bumped. Shortly after **PINSGOLD** had to steady when it became awkwardly placed on the heels of **TACTICALL** which shifted out slightly.

D Walsh, the rider of **TOMA VALEA**, defended a charge under Rule 638(1)(d) in that near the 150 metres he allowed his mount which was hanging in to shift inwards when insufficiently clear of **TACTICALL**, resulting in that horse having to be checked. D Walsh continued to allow his mount to shift in and near the 100 metres shifted in across the line of **CANGOWEST** which was steadied. After hearing evidence the JCA upheld the charge and suspended D Walsh's licence to ride at race meetings for 3 days effective 26 March to 29 March inclusive.

Approaching the winning post **VALIANT** (T Direen) shifted inwards to obtain clear running and in doing so momentarily hampered **EL CHICO**. T Direen was issued with a warning.

Race 5

FLORENCE HILTON blundered on leaving the barriers.

ROSE TATTOO raced three wide without cover throughout.

Approaching the 200 metres **PHEASANT** had to be checked when disappointed for a run behind **DHAULAGIRI** and to the inside of **BLU MACH**.

C Harris, trainer of **KAAPFLEUR**, advised that after the race they found the mare to be in season.
