RACE COMMENTS:

Race 1	NZB 2014 SOUTH ISLAND SESSION APRIL 13 RATING 75 (1400m)		
FRAGRANT raced wide without cover for the majority of the race.			
KARAKA JACK improved wide rounding the home turn.			

Passing the 400 metres **MIKABELLA** was momentarily held up behind the weakening **HAPPY DAYS**. From the 400 metres until near the 300 metres **GOLD ROCK** had difficulty obtaining clear running. Approaching the winning post **KARAKA JACK** was momentarily placed in restricted room to the inside of **PHEASANT**. Approaching the winning post Apprentice A Morgan, rider of **MIKABELLA**, accidentally dropped her right rein. **KARAKA JACK** lost the near front plate during the running.

Race 2 SEARELLS MAIDEN (1400m)

The start of this race was delayed when the buckle on the stirrup leather of **ALFIE RIVER** broke en route to the barrier and was further delayed when **MARIA SANTOS** which proved difficult to load was late scratched at 1.17 pm. The connections of **MARIA SANTOS** were advised that the filly must barrier trial to the satisfaction of the Stewards prior to racing again. **COLONEL ANNE** blundered on jumping.

D'CHAPARRAL and HI YO KO both jumped awkwardly and lost ground.

Shortly after the start SATANYA was buffeted between runners.

TRUTH raced keenly in the early stages.

HOME MADE HALO raced keenly in the early and middle stages.

RAPT raced wide without cover for the majority of the race.

DECANTER raced wide throughout.

WHY WAIT and D'CHAPARRAL raced wide rounding the home turn.

In the early part of the straight KIATERE was held up for clear running.

In the early part of the straight **SATANYA** when attempting to shift out to obtain clear running bumped **DECANTER** on several occasions and was unable to obtain complete clear running for the majority of the home straight and went to the line without being fully tested.

Approaching the 250 metres **SETYOURSPIRITFREE** which commenced to weaken had to be steadied when crowded momentarily by **ALFIE RIVER** (R Bishop) which shifted out to improve. Rider R Bishop was issued with a warning. **ROYALTY** had difficulty obtaining complete clear running for the majority of the home straight, with rider K Williams

advising she was unable to completely test the gelding until the shadows of the post.

When questioned regarding the riding tactics adopted on **WHY WAIT**, rider D Bothamley advised he was instructed to ride the gelding back and patiently as **WHY WAIT** only has a short sprint. He added that after improving wide rounding the home turn the gelding travelled into the race nicely and when let down approaching the 200 metres continued to make ground.

Race 3 nztba.co.nz PROMOTES SOUTH ISLAND RACING RATING 65 (1600m)

The start of this race was delayed when **SEDUISANTE** dislodged rider T Moseley en route to the barriers and took some time to be captured. **SEDUISANTE** was subsequently late scratched at 1.39 pm by order of the Stewards, with the connections advised that the mare must trial to the satisfaction of the Stewards prior to racing again. T Moseley was attended to by St John Ambulance Paramedics and cleared to continue with his riding engagements.

The race was further delayed when **WESTERN WARRIOR** which underwent a veterinary inspection at the start was found to have an uneven stride behind and was late scratched at 1.50 pm on veterinary advice. The connections were advised that a veterinary clearance is required prior to the gelding racing again.

CHAIROS begin awkwardly, shifted outwards and bumped **FALZANO**.

ARE YOU MINE shifted outwards abruptly on jumping.

ISHIGOLD raced keenly in the early and middle stages.

KAAPFLEUR and KINGS PAL improved wide rounding the home turn.

ISHIGOLD hung out over the concluding stages.

Apprentice A Morgan, the rider of **CARNIVA BOY**, admitted a charge of careless riding under Rule 638(1)(d) in that near the 1400 metres she allowed her mount to shift inwards when insufficiently clear of **ISHIGOLD** which was crowded inwards onto **FALZANO** resulting in both horses having to be checked. After hearing evidence the JCA suspended A Morgan's licence to ride in races for 3 days effective 6 April to 17 April inclusive.

Race 4 PGG WRIGHTSON SEEDS OPEN SPRINT (1000m)

On jumping **MILO** was crowded between **VENETIAN RAIDER** and **GIRL OF MY DREAMS**, both of which shifted ground. Near the 500 metres **GIRL OF MY DREAMS** and **EL DORADO SUN** bumped.

GIRL OF MY DREAMS lost the near hind plate during the running.

Apprentice A Morgan defended a charge under Rule 636(1)(d) alleging that she failed to ride **THE GOVERNATOR** out until the end of the race when she had a reasonable chance of finishing in 4th place for which there was prize money and a dividend declared. After hearing evidence the JCA upheld the charge and suspended A Morgan's licence to ride at race meetings for 3 days effective after the completion of her previous suspension ending 17 April, ie 18 April to 24 April inclusive. C Johnson, the rider of favoured runner **MILO**, advised that the gelding travelled well in the early stages but failed to let down and finished a distant last. Trainer M Pitman advised it was the geldings first run in some time and went will derive benefit from the run and over more ground. A post race veterinary examination of **MILO** did not reveal any obvious abnormalities.

Near the 700 metres **RYAN JOHN** was eased when placed in restricted room to the inside of **SOMETHING ZED**.

R Hannam, the rider of **SHEZASTUNNA**, advised that after losing ground at the start the mare obtained a favourable run however proved disappointing when let down. A subsequent veterinary examination did not reveal any obvious abnormalities.
