RACE COMMENTS:

Race 1 TE AWAMUTU TRAINING CENTRE 1150

FREE AND BOLD (B Murray) and BOUBALOS (K Leung) were both slow to begin.

JACQUI ICKX (A Taylor) raced wide without cover throughout.

Near the 250 metres **FREE AND BOLD** had to steady when awkwardly placed on the heels of **MONGOLIAN STORM** (R Hutchings).

FREE AND BOLD shifted in under pressure passing the 200 metres dictating **BOUBALOS** (K Leung) inwards. Apprentice jockey B Murray was advised he must make a greater effort to straighten his mount.

Race 2 GOURMET DELICIOUS LTD 1150

Shortly after jumping away **ROC THAT** (B Grylls) had to be steadied off the heels of **PIPI BEEL** (R Smyth) which shifted in abruptly.

PIPI BEEL ran wide around the bend near the 800 metres taking **LOWRIDER** (C Dell) which was improving forward, wider on the track

SKIPPER (K Leung) had to be steadied off heels passing the 700 metres.

SKIPPER shifted in under pressure passing the 200 metres inconveniencing **ZAMORA** (S McKay).

A protest was instigated by Mr S Ralph the trainer of **MARTINIZ SPECIAL** (A Forbes) the second placed horse alleging interference over the final 100 metres by the first placed horse **PENZANCE** (Z Moki). After viewing all relevant videos and hearing submissions from the connections of both runners the protest was dismissed. Z Moki was issued with a warning.

Race 3 WWW.RACINGTEAWAMUTU.CO.NZ

MY SHANTILLY (A Jones), SECRET KEEPER (M Dee) and JET FIGHTER (M Dravitzki) were all slow to begin.

MY SHANTILLY over-raced in the early stages, and then had to be firmly restrained off the heels of REYNEN ROSE (B Grylls) near the 700 metres.

Race 4 WAIPARACING@VODAFONE.CO.NZ

APPLAUD (D Turner) began awkwardly and shifted in crowding CHLOE KEEPER (A Taylor) which lost ground. APPLAUD was then taken in by XINGYUN BA (J Shackleton) hampering DAREYOUTO (A Forbes), MYTHS AND LEGENDS (T Wenn) and severely hampering INA JAM (L Magorrian). Contributing was sharp outward movement from HEZANAKILAD (M Dravitzki) with rider M Dravitzki losing the use of her right stirrup iron for approximately 200 metres before regaining it.

HIDDEN KEY (B Grylls) shifted out on jumping away hampering ST RHYTHM (K Leung).

SIDI REZEGH (A Jones) raced wide without cover throughout.

Race 5 RED BINS 2000

SHEZ KAPABLE (A Jones) was slow away.

PERFECTLY CLEVER (B Grylls) raced keenly in the early stages.

The favourite **TOKOMUTU JUDGE** (P Turner) raced disappointingly. When questioned rider P Turner felt the gelding may have not backed up from its run at Avondale the previous Wednesday and also believed that the gelding was unsuited by today's existing track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

J Oliver the rider of **ALAGINT** dropped his whip near the 400 metres.

Race 6 VE VETERINARY SERVICES 1150

ALEZAN (R Hutchings) was slow to begin.

HARP (K Leung) jumped in the air at the start after being fractious in the barriers.

SATANICO (R Smyth) was inclined to lay inwards in the final straight when placed under pressure.

ALEZAN raced in restricted room to the inside of **PRINCESS NICOLE** (A Jones) near the 200 metres.

Race 7 COMMERCIAL HOTEL TE AWAMUTU 1150

POPPAS DELIGHT (M Ulucinar) jumped away awkwardly losing ground.

SUNBEAM (A Jones) was slow to begin.

POPPAS DELIGHT made contact with the running rail near the 800 metres.

Race 8 TE AWAMUTU COURIER 1400

ETONIAN (U Holmquist) and COPPER QUEEN (J Oliver) were slow to begin.

HEART OF GRACE (J Shackleton) was crowded on jumping away between **RACQUETOR** (M Dravitzki) and **CONSPIRACY** (P Turner) when both those runners shifted ground.

SIR SUNNY (K Leung) made contact with the running rail passing the 600 metres.

SIR SUNNY when attempting a marginal run to the inside of the weakening **LA ROCHELLE** (Z Moki), had to steady and shift out when becoming awkwardly placed on the heels of that runner.

J Oliver the rider of **COPPER QUEEN** was fined \$450 by the Judicial Committee for failing to wear a body protector.
