RACE COMMENTS:

Race 1MCRAE RACING FAREWELL 2200AMANOOD LAD (A Kuru) knuckled leaving the barriers.GOGINGA (T Harris) began awkwardly losing ground.Passing the 1800 metres IMA PERFECT GUY (R Cave) had to steady when crowded by THENAMESBOND (M McNelis). RiderM McNelis was reprimanded and advised he must exercise greater care.IMA PERFECT GUY underwent a post-race veterinary examination which could find no obvious abnormality.M McNelis (THENAMESBOND) admitted a breach of Rule 638(3)(b) for excessive use of the whip and was fined \$275.D Miller (MAEVE DAVONE) admitted a breach of Rule 638(3)(b) for excessive use of the whip and was fined \$150.

Trainer Mr B Foote was fined \$50 for presenting SECOND INNINGS to race without notified gear (blinkers). Race 2 ITM G J WECK & SONS LTD 2200 SECRET DEW (M Coleman) and INA JAM (L Magorrian) both began awkwardly losing ground. FIREPOWER (M Cameron) shifted out leaving the barriers crowding HE'S INFRARED (P Turner). **SILVER FERN MARQUEES 1600** Race 3 ELSTOW (C Studd) was slow to begin. LORD SHIVA (D Miller) shifted in leaving the barriers inconveniencing EXOTIC (A Kuru). TUCKER BARKLEY (P Ormsby) began awkwardly losing ground. BAD TASTE (M McNelis) over-raced in the early stages. Approaching the 900 metres LORD SHIVA had to be steadied when crowded to the inside of EXOTIC (A Kuru) which was taken in slightly by SECRET KEEPER (T Harris). LORD SHIVA then shifted out making contact with CURLI (R Hutchings). LORD SHIVA then raced greenly for a distance. Passing the 600 metres CURLI had to be steadied when crowded by EL CORBY (G Walsh) which shifted in. Contributing was outward movement from EXOTIC. SKYLLA (M Mitchell) and CURLI lay in under pressure in the final straight. S Phelan (CHESNEE) was fined \$250 for riding in an unapproved body protector. Race 4 **PLACEMAKERS COUNTIES 1200** ROCKNROLLA (M Wenn) began awkwardly losing ground. QUEVADO (K Myers) began awkwardly and then was steadied. Passing the 1000 metres MILLYTHEMOOCHER (M Sweeney) shifted away from SHEZ BUBBLY (S Collett) crowding GO **TEENA** (O Bosson) which was steadied. **SHEZ BUBBLY** then raced ungenerously for a distance. Passing the 500 metres ROCKNROLLA was denied clear racing room between PERIA PRINCESS (B R Jones) and SHEZ BUBBLY. **RHYTHMS OF NATURE** (D Johnson) was held up early in the final straight. FUSSY HUSSY (R Hutchings) was held up until near the 350 metres having to shift out across heels to obtain clear running. ROCKNROLLA was held up for clear running until shifting in passing the 150 metres and in doing so inconvenienced FUSSY HUSSY. SHEZ BUBBLY had a tendency to shift in over the final 100 metres inconveniencing PERIA PRINCESS. **MITRE 10 MEGA PUKEKOHE 1200** Race 5 MY SHANTILLY (A Jones) was slow to begin. LES SILK (Z Moki) began awkwardly losing ground. DELLA LAMOUR (L Satherley) shifted in leaving the barriers crowding TRENDY WENDY (C Grylls). **RONGPHILLY** (S Collett) was slow to begin (5L). PACE SETTER (D Johnson) began awkwardly shifting out inconveniencing LUSHOTO (R Smyth) which was steadided. **KATORIE** (M Cameron) shifted out slightly approaching the 1100 metres hampering **PACE SETTER**. **KATORIE** had difficulty obtaining clear running early in the final straight, and then had to steady approaching the 300 metres becoming awkwardly placed on heels when PACE SETTER shifted in slightly with KATORIE then further having to steady. PACE SETTER shifted out slightly under pressure passing the 200 metres into the line of LUSHOTO which had to shift in across that runner's heels to obtain clear running. Race 6 **VERNON & VAZEY TRUCK PARTS LTD 1200 EEZEMOOVA** (M Sweeney) and **SNOW EXCUSE** (K Myers) came together leaving the barriers. PASSING PARADE (T Wenn) shifted out abruptly shortly after leaving the barriers forcing EEZEMOOVA on to SNOW **EXCUSE** which were both hampered losing ground. Approaching the 500 metres **CAPISTRANO MAGIC** (R Hutchings) had to steady briefly when placed in restricted room. SWAP FOR KASH (B R Jones) shifted out making contact with RAMARRO (M Cameron) passing the 500 metres. **IRISH HEARTBEAT** (O Bosson) had to change ground approaching the 400 metres to obtain clear running.

Race 7 HYNDS PIPE SYSTEMS LTD 1200

DEVOUR (R Hutchings) was slow to begin, and then inconvenienced by **SO DANSO** (K Myers) which shifted out. **GERRY MERITO** (O Bosson) shifted out leaving the barrier forcing **DONTDYEWONDERIN** (A Jones) wider on the track.

ANAHEIM (L Magorrian) raced ungenerously when being steadied passing the 1100 metres.

GRANT'S GIRL (D Johnson) raced fiercely when leading through the early and middle stages.

SO DANSO was held up for a distance until approaching the 250 metres then shifted out to obtain clear running. **GRANT'S GIRL** raced greenly under pressure in the final straight with **ANAHEIM** becoming awkwardly placed outside that runner's heels approaching the 200 metres.

When questioned into the performance of the favourite **GRANT'S GIRL** rider D Johnson advised the filly found the

distance of today's race in the existing track conditions may have contributed to the filly's performance. When questioned into the performance of **DEVOUR** rider R Hutchings could offer no excuse. Trainer Mr B Hawtin advised that **DEVOUR** would no longer be persevered with as a racing proposition.

Race 8 COUNTIES CLEANING SUPPLIES 1400

METALLIC (M Wenn) was slow to begin (3L).

UPLAND GIRL (K Myers) shifted out leaving the barriers crowding MALINA (B R Jones).

MANGAROA FLO JO (B Grylls) went off stride shortly after leaving the barriers.

SHESGOTIT (K Leung) dipped passing the 900 metres and then raced ungenerously for a short distance.

COPA VERDE (C Grylls) had to steady briefly passing the 500 metres when **GETALONGHOME CINDY** (L Magorrian) shifted out into that runner's line.

MANGAROA FLO JO raced greenly under pressure in the final straight ducking out passing the 250 metres into the line of **SHESGOTIT** which was checked losing ground.

CAGA DANCE (M Cameron) was inclined to shift around under pressure in the final straight having to be straightened by its rider on several occasions.

Race 9 THE LOCKSMITHS 1400

ABSOLUTE GEM (A Jones) began awkwardly losing ground.

EL DECANO (S Collett) began awkwardly then became awkwardly placed on the heels of **GUSTAVO** (M Cameron) which shifted in slightly.

Approaching the 400 metres **MIDNIGHT REIGN** (P Turner) shifted in to obtain clear running forcing **EL DECANO** in on to the heels of **IZZANORANGE** (A Taylor) with **EL DECANO** having to steady. Rider P Turner was issued with a warning. **INNER NINJA** (K Myers) had to steady for a distance passing the 400 metres when becoming awkwardly placed on the heels of **CHAPRISE** (R Hutchings) which shifted out. **INNER NINJA** was then unable to obtain clear running.

Passing the 100 metres **APRIL JOY** (J Jago) shifted out into the line of **CHAPRISE** with **CHAPRISE** having to change ground to the inside of **APRIL JOY**. The connections of the fourth placed horse **CHAPRISE** wished to view footage with regard to the incident electing not to proceed with an objection.

Race 10 BRIAN ROBERTS PANELBEATING & TOWING LTD 1600

SIR SUNNY (M Sweeney) shifted in and away from THE HAWK (M Cameron) which had begun awkwardly.

GALVANISED (R Hutchings) began awkwardly shifting in causing crowding to **VIKING POINT** (M Hills), **GESEMI** (C Grylls) and **REBEL ROSE** (R Smyth) on jumping away. Contributing was outward movement from **LUCKY DESIRE** (B Grylls) with the worst affected being **VIKING POINT** and **GESEMI** with both those runners losing ground.

An inquiry was opened into the reasons as to the interference to **REBEL ROSE**, **LOOK WHOS ASKING** (O Bosson), **AMBITIOUS HERO** (D Johnson) and **MY LOCKET** (K Myers) with **MY LOCKET** falling approaching the 500 metres rider K Myers was transferred to hospital for further evaluation. **AMBITIOUS HERO** was not then persevered with down the final straight.

Passing the 300 metres **SIR SUNNY** shifted out under pressure inconveniencing **VIKING POINT**.
