RACE COMMENTS:

Race 1	JOIN NZ JUMPS INC. RST OPEN HURDLE 2700m
<p>ONE FOR THE MONEY was awkwardly away and slow through the early stages. NANCHO LASS made a poor leap at the fence passing the 900 metres. ONE FOR THE MONEY also made at an awkward jump at this fence. NANCHO LASS again put in a poor leap at the fence passing the 600 metres. HARRY HILL was inclined to lay in throughout the run home. DANISH RULER made a poor leap at the last fence losing some momentum. Stewards requested a post-race veterinary examination of DANISH RULER after rider M Cropp reported the gelding had felt indifferent in its action over the concluding stages. The subsequent examination failed to detect any abnormalities.</p>	
Race 2	JUMPIN JAVA COFFEE MAIDEN DASH 1200m
<p>The start of this event was delayed 4 minutes and 32 seconds while starter's assistants located a lead rope which had been inadvertently left on the track at the start position of the previous event. KILMARNOC began awkwardly losing ground. SOFIA LOREN raced wide throughout. SKEET which was racing keenly made the bend by the 800 metres awkwardly.</p>	

SKEET made the final bend awkwardly and hung outwards throughout the run home. Passing the 200 metres **KILMARNOCH** which was racing greenly shifted in abruptly crowding and hampering the tiring **KOTOTAMA**.
When questioned regarding the performance of **MARY MAGDALENE** apprentice rider T Direen reported the filly was flat throughout the running and in her opinion was not comfortable in the prevailing Heavy 10 track conditions.

Race 3 | **WILD RANGE PHOTOGRAPHY RST OPEN STEEPLECHASE 3200m**

MONTE CAIRO jumped the first fence high and lost ground.
After jumping the second fence **POWER PACK** became awkwardly placed on the heels of **JAYJAY** and had to shift ground outwards inconveniencing **MONTE CAIRO**.
MONTE CAIRO landed awkwardly after jumping the fifth fence losing momentum.
MONTE CAIRO put in a poor leap at the sixth fence and was subsequently retired from the event with rider M Cropp advising the gelding had jumped poorly and believed it was in the best interests of both horse and rider to retire from the event.
JAYJAY put in a poor leap at the fence near the 1000 metres unbalancing its rider momentarily.
ATOMIC ROAD which had been handy early gave ground from the 800 metres when under pressure and was retired after jumping the water jump the last time. Rider S Fannin advised the gelding had failed to handle the testing nature of today's Heavy 10 track.
THE SYDNEY EXPRESS put in a poor leap at the last fence landing awkwardly and losing some momentum.
Trainer D Hutton advised the Stewards **MONTE CAIRO** would now be retired as a racing proposition from his stable.

Race 4 | **CENTRAL CITY CAR PAINTERS RATING 65 1600m**

HUGHES THAT GIRL which was racing keenly skied its head when being restrained to take a position shortly after the start.
MY REASON raced wide through the early stages.
PROXIMITY shifted out under pressure passing the 200 metres placing **HUGHES THAT GIRL** in restricted room momentarily.
Rider **D Frye** (CONTADOR) was warned pursuant to Rule 638(3)(b) regarding his use of the whip between the 400 metres and the 200 metres.

Race 5 | **AAKLAND STAYERS MAIDEN 2200m**

RISKY FLIGHT shifted out abruptly at the start making contact with **SHORTY MCNORTY**.
JACHIL was slow to begin.
Passing the 1900 metres **SHORTY MCNORTY** briefly raced in restricted room when **RISKY FLIGHT** shifted ground momentarily.
NEED A WILSON'S raced keenly and had to be restrained passing the 1200 metres as the pace eased.
Passing the 400 metres **LONE WOLF** was held up and had to steady when shifting ground inwards to find clear racing room and becoming awkwardly placed on the heels of **NEED A WILSON'S**.
The tiring **RISKY FLIGHT** was placed in restricted room passing the 200 metres when **AMANDAHUGNKISS** lay in and had to be straightened.
When questioned regarding the performance of **RISKY FLIGHT** rider K Williams advised that after jumping well the mare which is better suited to taking a trailing position had commenced to over race while leading and this had lead to a disappointing performance. Trainer E Winsloe advised **RISKY FLIGHT** would now be sent for a spell.

Race 6 | **DAVE LEASK – MCKAYS TRANSPORT STAYERS RATING 85 2200m**

LAMAZE raced keenly through the early stages before being taken forward to lead with 1800 metres to run.
When questioned regarding the performance of favoured runner **SHE'S INSATIABLE** rider J Morris advised the Stewards the mare had failed to handle the holding nature of today's track.

Race 7 | **OTAGO TYRES SPRINT RATING 65 1200m**

AGNUS BROWN shifted out at the start inconveniencing **POLLY'S SISTER** which lost ground.
HALO DOLLY raced wide without cover throughout.
Passing the 350 metres **MISS THREE STARS** (S Wynne) angled out crowding and checking **SPARKS FLY** (C Barnes).
Apprentice rider S Wynne in the presence of trainer Mr N Ridley admitted a breach of Rule 638(1)(d) Careless Riding. After viewing replays and hearing evidence from Miss Wynne and the Stewards the JCA imposed a suspension of Miss Wynne's riding licence from the 29th June up to and including the 5th of July 2014.
