RACE COMMENTS:

Race 1KICK OFF 2014/15 SEASON AT HASTINGS SPRINTGOLD WEDDING shifted outwards jumping away crowding GIPSY STAR on to SUPERCEDE and HIGH SOCIETY, with
SUPERCEDE blundering.SUPERCEDE blundering.SUPERCEDE had to steady momentarily when HIGH SOCIETY shifted ground near the 400 metres
WHOOPI GEE over-raced when being restrained passing the 1000 metres.Race 2BAY FORD NZ PUNTER OF THE YEAR OCTOBER 4TH MAIDENKAYLEEN stood flat-footed in the gates and was very slow (6L). Trainer K Burne was advised that a warning is placed
against the mare with regard to its barrier manners. K Burne advised the mare would be spelled.LAUTARO was crowded leaving the barriers.LAUTARO over-raced badly in the early stages then continued to race three
wide without cover in the middle stages.RULE THE COURT shifted away from the running rail to improve. When questioned, D Walker said his mount raced greenly
and was inclined to shift away from the improving RULE THE COURT.

RULE THE COURT had to be steadied off the heels of KINGS KITE near the 900 metres.

FLASH FORWARD was inclined to lay out and had to be straightened throughout the final straight. An endoscope examination of **HAWKEYE CHIEF** which finished well back, revealed the gelding to have swallowed a clod.

Race 3 WWW.SOCIALRACING.CO.NZ MAIDEN MILE

SEAWEED was hampered when crowded leaving the barriers, losing ground.

ILADANN was slow away and despite the urgings of its rider, lost contact with the body of the field, being eased down in the final straight when a distant last. Trainer D Fuge was advised that **ILADANN** must trial to the satisfaction of a stipendiary steward prior to racing next.

SEAWEED commenced to over-race near the 1400 metres, getting its head up and racing ungenerously and having to be restrained off heels. **SARABI** and **BASE CAMP** also commenced to over-race near the 1400 metres. All three runners continued to over-race through the middle stages.

SMARTAZ raced three wide without cover.

SMARTAZ was inclined to lug inwards in the home straight.

Race 4 DHL HAWKE'S BAY GUINEAS PRELUDE

M Cameron was unable to make the weight for PLATINUM WITNESS and was replaced by D Bradley.

S Doyle was unable to make the weight for TAKEN THE LIBERTY and was replaced by C Johnson.

CRYPTIC jumped outwards at the start.

BARTOLI and **OPERATIC RESCUE** began awkwardly with **BARTOLI** then shifting outwards away from **CRYPTIC**, further hampering **OPERATIC RESCUE**, which lost ground when crowded on to the hind quarters of **PRICE TAG**.

NYMPH MONTE and KING'S SECRET began awkwardly.

CRYPTIC over-raced in the run along the back straight.

Race 5 JB ORGANICS SPRING CARNIVAL TICKETS ON SALE MILE

JACK'S BOY shifted outwards leaving the barriers, hampering ROYAL SCEPTRE, PIRINITETE and JUST ISHI. PIRINITETE had to be firmly restrained when becoming awkwardly placed on the heels of ROYAL SCEPTRE passing the 700 metres.

Race 6 NIAGARA AT LIME COUNTRY SPRINT

ALDEBARAN STAR began awkwardly and shifted inwards hampering KENNYS CHANCE, HEMINGWAY and WEISSMULLER. SUNBEAM and WEISSMULLER over-raced in the early stages when being restrained.

When questioned into the disappointing run of **WEISSMULLER**, rider B Lammas was unable to offer any excuse other than may not being suited to today's track conditions. A post-race veterinary inspection failed to reveal any abnormalities. T Kahlon, the rider of **HEMINGWAY**, was reminded of her obligations regarding the use of her whip prior to the 200 metres.

Race 7 VALE GERRY ARBER MILE

M Cameron was unable to make the weight for JIMMY MAC and was replaced by D Bradley.

SINGLE GIRL was slow to begin.

SORTEMOUT was briefly held up near the 300 metres.

G Andrew, trainer of **JIMMY MAC**, attributed the improved run today to the gelding being unsuited to the heavy track at Otaki at its previous start on 26 July.

Rider B Lammas reported that his mount, **MRS CLOONEY**, had got its tongue over the bit during the running, which had adversely affected the mare's breathing.

Race 8 "SEE YOU AT THE MAKFI AUGUST 30TH" MILE

LAVISH PRINCE began awkwardly.

SPIKE MILIGAN began awkwardly crowding **DUCATI** on to **ONE KAY** resulting **DAL VUITTON** being hampered. **ONE KAY** shifted outwards making contact with **DAL VUITTON** near the 600 metres.

When questioned regarding the performance of **O'CEIRINS SECRET**, rider J Riddell was of the opinion that the gelding would derive benefit from today's fresh up run.

YORKIE and SHOW THE BEEL were slow away.

RISING TIDE over-raced in the middle stages.

I'LL'AVA'ALF shifted out under pressure near the 150 metres making contact with SAN PEDRO.

Apprentice A Donald was spoken to regarding the use of his whip on a horse out of contention.
