RACE COMMENTS:

Race 1HARRIS CONTRACTING SANSON/MAKOWHAI FARMS HURDLE (2900 metres)Stewards gave permission at approximately 8.00am for M McNelis to be replaced by R Cole at the request of his employer,
M Eales, to ride SORTEMOUT.JUSTA TOMBOY lost ground at the jump near the 2500 metres when back.GET FLASH was inclined to over-race in the early and middle stages.HAZY DAZE lost ground after jumping the fence near the 1200 metres.CRACKA CROWN put in a bad jump at the fence near the 1000 metres, landing awkwardly and losing ground.KRASE was tightened and checked shortly after jumping the fence near the 1000 metres when inside HAZY DAZE (S Fannin)which shifted in when not clear.S Fannin admitted a resultant breach of Rule 638(1)(d) and after consideration the judicial
committee suspended S Fannin's licence to ride in races from the close of racing on Sunday, 26 July until the close of racing

on Friday, 31 July, plus a fine of \$350.

GOONDIWINDI was placed in restricted room near the 850 metres when awkwardly inside the heels of **HAZY DAZE CRACKA CROWN** was eased down passing the 800 metres. Stewards ordered a post-race veterinary inspection on **CRACKA CROWN**, which did not reveal any abnormality.

GOONDIWINDI was retired from the event near the 700 metres when well back.

HARD SHOT and JUSTA TOMBOY were retired from the event passing the 500 metres when out of contention.

BANTENEIGHTY jumped the final fence awkwardly and lost momentum.

Race 2 GAVIN TEAL CONTRACTING AMATEUR (2100 metres)

GOLDYSOX was a late scratching at 12.12pm after rider A McIntyre sustained an injury to her shoulder when attempting to mount the gelding.

MAILLY over-raced in the middle stages.

Race 3

SEIGAL was held up for a short distance passing the 800 metres.

MAILLY was crowded passing the 600 metres when awkwardly placed near heels.

C Roughan (SEIGAL) dropped her whip near the 400 metres.

H Fleming (IMA PERFECT GUY) was issued with a warning with respect to the use of her whip prior to the 200 metres. **H Fleming (IMA PERFECT GUY)** was severely reprimanded after relaxing her ride passing the 70 metres when in fourth position, narrowly holding that placing at the finish.

HARRIS CONTRACTING DANNEVIRKE MAIDEN STEEPLECHASE (4200 metres)

I'VE GOT THIS jumped indifferently on the first circuit losing ground at various jumps.

AND THATZ SCOTTY jumped the fence near the 2200 metres awkwardly and lost momentum.

WAITOKI AHI (M Mitchell) got in close and misjudged the fence near the 1600 metres and fell. NELLS BELLE (L Kennedy), which was racing in behind, was unable to avoid the fallen WAITOKI AHI, and fell in consequence. Respective riders M Mitchell and L Kennedy were cleared to ride by paramedics. Also affected in this incident was I'VE GOT THIS, which was checked and lost ground.

MY AVATAR was eased out of the contest after jumping the fence near the 800 metres when out of contention.

THE PAINTER (R Cole) made a poor jump and lost ground at the second last fence and then fell at the last fence and took some time to recover when tired. A subsequent veterinary examination revealed **THE PAINTER** to have a cardiac arrhythmia. Trainer G Brick was advised that a veterinary clearance including the results of an ECG must be produced prior

to **THE PAINTER** next racing. Rider R Cole was uninjured.

Race 4 THURSTON CONTRACTING STEEPLECHASE (4200 metres)

KICK BACK jumped its fences high in the early stages, losing ground.

GOOSEBUMPS landed awkwardly at the fence near the 800 metres on the first round.

BRUSHMAN landed awkwardly at the last fence in the back straight on the last round, dislodging rider T Harris. T Harris was examined and cleared by medical staff.

KICK BACK jumped the fence at the 600 metres poorly on the last round.

MAN O' MANN weakened from the 1200 metres.

GOOSEBUMPS was forced wide by the riderless horse at the fence near the 600 metres.

Race 5 HOPKINS FARMING GROUP MAIDEN (2100 metres)

PLATINUM SONG was a late scratching at the barrier on veterinary advice after the gelding pulled a plate in the preliminary which resulted in a laceration to a heel.

ZEDACE jumped out at the start and bumped HAMILTONIAN.

MA BELLE KATE raced four wide without cover around the first bend so was taken forward to a leading position.

BEFORUNOIT raced very wide in the back straight in search of better going.

Race 6 VANDENBERG SHELTER TRIMMERS MAIDEN (1200 metres)

D Bradley replaced J Oliver (unwell) as the rider of ROCFIVE.

FIFTEENSIXTY began awkwardly, making contact with the barrier and losing ground.

IL CAMPIONE and **ROCFIVE** were slow to begin.

When questioned regarding the disappointing performance of **ALOT**, which gave ground from the 500 metres, apprentice N Teeluck reported that the mare had made irregular breathing noises on pulling up. Stewards ordered a veterinary inspection of **ALOT** which revealed a noise in the upper respiratory tract. Connections were advised that **ALOT** should under a follow-up examination.

EAMES AG/CORBETT BROS MAIDEN (1600 metres)

KEEN TEMPO began very awkwardly and lost ground.

HEAVENS KEEP shifted out abruptly on jumping hampering MWAADAN.

PHILOSOPHER was slow to begin.

Race 7

ALTIPLANO raced wide without cover throughout.

J Gracioso (UNREEL) was spoken to advisedly and firmly reminded of his obligations in relation to his use of the whip prior to the 200 metres.

Race 8 CB NORWOOD DISTRIBUTORS HANDICAP (1400 metres)

D Mo replaced J Oliver as the rider of **ALLSTARS**.

RALPH'S GIFT and ZA BRUTE were slow on jumping.

SPECIAL BID began awkwardly and settled back.

ALL GINGA had to be steadied to avoid the heels of ANOTHER BACHELOR approaching the home turn.

When questioned regarding the run of **SPECIAL BID**, rider R Goldsbury reported that the mare was not suited to the Heavy (11) track conditions today.

An investigation was opened and adjourned with respect to apprentice **T Johnson (ALL GINGA)** who presented himself at the scales to weigh out without a safety vest.
