#### **RACE COMMENTS:**

Race 1 Central Site Works Hurdle

FERN AVENUE (H Voss) began awkwardly losing ground.

**FERN AVENUE** ran the fences down throughout the running losing contact with the body of the field near the 1400 metres finishing a distant last. Rider H Voss was advised that in future she would be expected to retire the gelding when so far out of contention.

FAST PROFIT (C Thornton) put in a poor jump at the fence near the 1400 metres.

**FAST PROFIT** hit the fence near the 700 metres hard and stumbled on landing. The gelding was then retired from the race. **ZANKURO** (S Fannin) was not persevered with from the 500 metres and did not jump the final two fences being retired from the race.

NOAH JON (M Mitchell) ran down the second to last fence.

MAGNA CARTA (A Kuru) hit the final fence hard losing momentum.

CASH KINGDOM (E Farr) put in a poor jump at the last fence and fell. A post race veterinary examination revealed the

gelding to have an elevated heart rate.

When questioned into the performance of the favourite **FAST PROFIT** which was pulled up, Rider C Thornton advised the Stewards that the gelding had pulled up well and felt that the very testing track conditions may have contributed to the poor performance.

Carters Tyres 2200 Race 2 **THATZ LOUIE** (M Simons) and **STAGEHAND** (S Wenn) both began awkwardly. STORMIN NORMAN (L Wheeler) was crowded on jumping away losing ground due to movement from JOKING (M Northcott) and HENRY TUDOR (J Reid). CHLOE KEEPER (M Gibbs-Manssen) over-raced in the early stages. HENRY TUDOR when shifting out to obtain clear running made contact with BACH (M Roustoby) which was laying in under pressure passing the 600 metres. Passing the 350 metres TOP CHOICE (N Jamieson) shifted out under pressure inconveniencing HENRY TUDOR. Over the final 150 metres TALLYHO TWINKLETOE (S MacNab) shifted out under pressure dictating TOP CHOICE wider on the track. The connections of the second placed horse TOP CHOICE viewed videos as to lodging a protest against the winner TALLYHO **TWINKLETOE** but elected not to proceed. M Gibbs-Manssen, the rider of CHLOE KEEPER, was charged under Rule 638(3)(b) for excessive use of the whip and was fined the sum of \$150. J Reid, the rider of HENRY TUDOR, was charged under Rule 638(3)(b) for excessive use of the whip and was fined the sum of \$250. S Wenn, the rider of STAGEHAND, was issued with a warning over his use of the whip prior to the 200 metres.

Race 3 Building Elements Steeplechase

JUST GORGEOUS (R Eynon) put in a poor jump at the first fence in the centre on the first occasion.

**ATHENRY** (M Mitchell) put in a poor jump at the first of the double on the first occasion and also jumped the two fences on the hill on the second occasion poorly, becoming tailed off and was pulled up prior to jumping the fence at the foot of the hill. **ATHENRY** underwent a post race veterinary examination which revealed no abnormalities.

**POTTER** (C Singer) jumped the fence near the 1600 metres poorly, losing ground.

**GOGINGA** (S Phelan) misjudged the second to last fence and fell. Both horse and rider were uninjured. Hampered by the fallen runner were **CRASH BANDICOOT** (M Gillies), **JUST GORGEOUS** and **POTTER**.

Race 4 The Tractor Centre Hurdle

SUPERCHARGED (I Lupton) over-raced in the early stages.

JUST GOT HOME (C Singer) got its head up when being restrained near the 1200 metres on the first occasion.

THENAMESBOND (S Fannin) misjudged the fence near the 1100 metres on the first occasion.

THATZ DAVID (A Browne) jumped the last fence in the straight poorly on the first occasion.

BIG BROWNIE (M Gillies) jumped the fence near the 1200 metres poorly.

**REAL TREASURE** (S Phelan) landed awkwardly after jumping the third to last fence losing momentum.

**JUST GOT HOME** was held up for a distance passing the 700 metres.

**AROSE** (E Farr) put in a poor jump at the second to last fence.

When questioned into the performance of the favourite **ZENOCOIN** Rider M Mitchell advised that he found today's very testing track conditions not suitable. A post race veterinary examination revealed no abnormalities.

Race 5 Harney Fine Teas 2200

MASTER MICHAEL (S McKay) was very slow to begin (5L).

Race 6 Tony Richards Toyota Pakuranga Hunt Cup

**IMA HEROINE** (M Gillies) and **BALLY HEIGHTS** (A Kuru) came together on jumping away with **IMA HEROINE** becoming briefly unbalanced.

UPPER CUT (I Lupton) was slow away.

**NO QUOTA** (C Singer) shifted out abruptly on jumping away crowding **SINISTA** (E Farr) which lost ground.

**THE FOX** (D Miller) put in a poor jump at the first fence on the second occasion.

TOM'S MYTH (S Phelan) jumped indifferently over the final circuit.

**TOBY CEE** stumbled badly on landing after jumping the fence near the 1400 metres on the second occasion almost dislodging Rider A Browne who lost the use of his right hand stirrup iron and travelled a short distance before regaining the use of his iron.

**SINISTA** (E Farr) put in a poor jump at the fence near the 1200 metres on the second occasion.

**NO QUOTA** put in a poor jump at the fourth last fence.

**BALLY HEIGHTS** blundered on landing after jumping the final fence when well back.

**MARVON DOWNS** (S Fannin) and **SINISTA** were pulled up prior to jumping the final fence when out of contention. **TOBY CEE** returned to the weigh in area with blood present in a nostril. After undergoing a post race veterinary examination **TOBY CEE** was found to have a minor laceration to the nostril and the horse was also observed to be very lame in the off fore leg and will require a veterinary clearance prior to racing again.

**Riders A Kuru** (BALLY HEIGHTS), **M Gillies** (IMA HEROINE) and **D Miller** (THE FOX) were spoken to over their use of the whip on horses that were out of contention.

Race 7 TDM Construction 1200

**TAAXMAN** (J Wong) was crowded when leaving the barriers.

**RAMARRO** (T Thornton) raced keenly through the middle stages.

Approaching the 300 metres **QUEENS ROSE** (N Harris) shifted out to obtain clear running inconveniencing **TAAXMAN**. **TAAXMAN** then raced ungenerously for a short distance becoming awkwardly placed on the heels of **CODY CAT** (L Magorrian) near the 150 metres.

Race 8 Boulgaris Realty Mile

**CORNELIUS** pulled a plate when in the parade ring and had to be returned to the tie-up enclosure to have the shoe replaced. As a result the race ran late.

MAXIMUM HEIGHT (U Holmquist) raced keenly in the early stages.

Race 9 Harrison Lane Mile

**RIOT ACT** (N Harris) began awkwardly losing ground.

ROCKET QUEEN (M Wenn) was crowded when leaving the barriers.

NOTTOOBAD (L Innes) began awkwardly making contact with DRAGONKEEPER (U Holmquist).

Passing the 1500 metres **ROCKNROLLA** (L Magorrian) shifted out making contact with **NOTHING** (J Wong) which in turn shifted out making contact with the hind quarters of **BASSALEG** (S McKay) which lay inwards crowding **NOTHING** for several strides. **NOTHING** then raced ungenerously for a distance.

**COOL ONE** (C Dell) lay in when placed under pressure in the final straight.

When questioned into the performance of the favourite **ROCKET QUEEN** Rider M Wenn advised the Stewards the mare pulled up well but may be feeling the effects of recent racing. A post race veterinary examination revealed no abnormalities.

**Trainer K Opie** was charged under Rule 616(3) for presenting the horse NOTHING without notified gear (side winkers) and was fined \$50.
