RACE COMMENTS:

Race 1	Cowley's Hire Centre 2100
KIDNAPPED (B Hutton) was slow to begin. Passing the 1600 metres CANTERINO (S McKay) over-raced when being restrained with CANTERINO then being allowed to work forward to lead passing the 1200 metres. ENDORSEMENT (G Cooksley) raced ungenerously when being steadied passing the 1500 metres. SMEDLEY (L Magorrian) was forced to race wide around the final bend. Passing the 400 metres ENDORSEMENT shifted out to obtain clear running making contact with BACHELOR'S DREAM (C Lammas).	
Race 2	Tavistock Syndicate Owners 2YO 1000
MONGOLIAN WARRIOR (M Cameron) was slow to begin. RULE THE WORLD (D Johnson) shifted inwards leaving the barriers crowding VICAR'S DAUGHTER (S Collett) and DEVIANT MISS (R Smyth) onto IRDY'S GIRL (C Lammas) which was hampered losing ground. SUGGESTIONS (V Colgan) made contact with the hind quarters of NIGHT FEVER (L Magorrian) shortly after the start with both those runners being unbalanced. Inconvenienced as a result was MONGOLIAN WARRIOR . AMARULA (S McKay) and SACRED DESIRE (L Innes) both raced wide without cover. SHERADREAM (B Hutton) was held up entering the final straight having to shift outwards across heels to obtain clear running near the 250 metres. SHERADREAM then again shifted ground inwards across the heels of RULE THE WORLD near the 150 metres.	
Race 3	Whangarei Love It Here 1200

BANNERMAN (A Jones) was slow to begin.
MALALA (T Thornton) began awkwardly making solid contact with **TOMMY BROCK** (V Colgan) which was crowded onto **ESCALATE** (B Hutton).
SILENCER (M Cameron) shifted inwards shortly after the start when not sufficiently clear of **MALALA** which was checked.
M Cameron admitted a resultant breach of careless riding with his license to ride in races being suspended by the Judicial Committee from the conclusion of racing on Saturday 4 July 2015 up to and including racing on Friday 10 July 2015, 3 riding days.
Near the 1100 metres **TOMMY BROCK** and **SILENCER** came together with **SILENCER** becoming awkwardly placed on the heels of **WHERE THERES SMOKE** (R Smyth) which was shifting inwards. R Smyth was advised to exercise more care.
TOMMY BROCK and **SILENCER** again came together passing the 1000 metres when **TOMMY BROCK** which was racing in restricted room to the inside of **SILENCER** shifted outwards slightly to avoid the heels of **LANCASTER** (D Johnson) which shifted ground when being restrained. **TOMMY BROCK** and **SILENCER** then made the bend near the 900 metres awkwardly forcing **HE'S CAVALIER** (J Whiteside) over extra ground.
JEHANNE (S McKay) and **KATANGO** (C Lammas) raced wide without cover on the pace.
LANCASTER ducked outwards near the 250 metres forcing **WHERE THERES SMOKE** outwards on to **JEHANNE** and **KATANGO**. **ALL ROADS** (S Collett) which was improving into a run between **KATANGO** and **HE'S CAVALIER** was crowded as a result.
ESCALATE raced greenly and lay out over the final 100 metres becoming uneven in its action.
ESCALATE struck itself during the running suffering a superficial wound to the left hind.

Race 4	A'Fare Caterers 1400

P Holmes was fined \$225 by the Judicial Committee after failing to make the weight for **THE RICH LISTER**, being replaced by C Lammas.
ELYSIUM (M Cameron) and **THE RICH LISTER** (C Lammas) were both slow to begin.
FARAWAY EYES (A Schwerin) shifted outwards leaving the barriers crowding **AIRFIELD ROAD** (S McKay) onto **ZERO TUA HUNDRED** (S Collett).
Following the race **ELYSIUM** was found to have bled from both nostrils and is now subject to the mandatory three month stand down from racing. Co-trainer Mr S Ramsay indicated that the mare was now likely to be retired.

Race 5	Northland Business Systems 1600

BIG DREAMER (V Colgan) began awkwardly.
FORT STREET DANCER (L Magorrian) raced in restricted room to the inside of **HAPI GIRL** (R Smyth) approaching the 800 metres with **FORT STREET DANCER** then becoming awkwardly placed on the heels of **PROSPERITY** (D Johnson) which when making the bend awkwardly dropped back onto **FORT STREET DANCER** further hampering that runner.
BELLE VOLANT (A Schwerin) raced three wide without cover.
HAPI GIRL shifted outwards to avoid the heels of **SUPER READY** (M Cameron) near the 600 metres hampering **LORD AND MASTER** (S Collett). **LORD AND MASTER** then lay out rounding the final turn.
C Lammas advised that **STABIKRAFT** had been making abnormal breathing noises and may have held its breath. A post race endoscopic examination of the gelding did not reveal any abnormality.

Race 6	Whangarei Bus Services 1600

SERENGETTI SUN (D Johnson) shifted inwards leaving the barriers crowding **THUNDERBIRD THREE** (M Hills) on to the hind quarters of **ICE COOL** (A Jones) with **THUNDERBIRD THREE** losing ground.
ROCK ROSE (S Collett) was hampered leaving the barriers.
PRO FUMO (L Magorrian) was a little slow to begin then inconvenienced by **FLAVOURING** (A Schwerin) which shifted inwards slightly.
SERENGETTI SUN over-raced when being restrained to avoid the heels of **OPULENT** (M Cameron) when that runner was being steadied passing the 1400 metres.
R Smyth (KING TUTE) dropped her whip near the 300 metres.

Race 7	Whangarei ITM Open 1600

THE JUNGLE BOY (V Colgan) underwent a veterinary inspection after making contact with the front of the barriers being passed fit to race.
THE JUNGLE BOY began awkwardly inconveniencing **LOVES THE SHOW** (M Cameron).
GREY POWER (C Lammas) began awkwardly losing ground.
PAN DULCE (R Smyth) was inclined to lay out under pressure early in the final straight.

Race 8	Waipu N Tartan 2015 1200

PINZANO (S Collett) underwent a veterinary examination after being kicked behind the barriers being passed fit to race.
FLAVIGNY (G Cooksley) was slow to begin.
PINZANO shifted inwards abruptly leaving the barriers crowding **HUCKLEBERRY FLYER** (C Lammas) and **MIDNIGHT MISTRESS** (L Magorrian) both of which were hampered.
TWIN FIGHTER (R Norvall) lay out when leaving the barriers inconveniencing **COOKIE MONSTER** (D Johnson) which had been slow to begin.
SILVER CITY (A Schwerin) over-raced in the middle stages shifting outwards to avoid the heels of **OVERNIGHTSENSATION** (R Smyth) near the 800 metres, then racing three wide without cover around the bend.

FLAVIGNY had some difficulty obtaining clear running in the final straight having to shift inwards across the heels of **ROCKWELL** (L Innes) near the 200 metres. **FLAVIGNY** was then held up over the final 50 metres having to be steadied off the heels of **TWIN FIGHTER**.

TWIN FIGHTER lost the right hind plate during the running.

Race 9	BNI B'Nspired Whangarei 1200

PIAZZETTA (B Hutton) was slow to begin.

ZUCCATO (D Johnson) shifted inwards jumping away inconveniencing **VIBRANT MOSS** (P Holmes).

Passing the 1000 metres **ZUCCATO** became awkwardly placed on the heels of **IN FLIGHT** (M Cameron) which was steadied with **ZUCCATO** commencing to over-race. As a result **ZUCCATO** shifted outwards to avoid the heels of **IN FLIGHT** forcing **QUEEN OF NAVARRE** (S McKay) wider on the track near the 900 metres. Hampered as a result was **AIRMAN** (V Colgan) which was also over-racing. **QUEEN OF NAVARRE** then raced three wide without cover for the remainder of the race.

CHARLIE FARLEY (A Schwerin) was held up passing the 300 metres having to be steadied to shift outwards across the heels of **ZUCCATO** to obtain clear running near the 200 metres.

CHARLIE FARLEY when improving into a run to the inside of **QUEEN OF NAVARRE** was accidentally struck on the head by the whip of Apprentice S McKay approaching the 200 metres.

When questioned regarding the performance of **ZUCCATO** Rider D Johnson advised that the filly had over-raced at its first run back from a long spell and in her opinion would benefit from the outing.

Race 10	Rob Harte Lawyer Supporting Ruakaka Charity Race Day 11 July 1600

Trainer **S Marsh** was fined \$50 after presenting **AURORA LIGHTS** to race without notified gear.

RICH TED (S McKay) began awkwardly losing ground.

Near the 1300 metres **SONIC JET** (V Colgan) had to be briefly steadied to avoid the heels of **OUR DAISY** (S Collett) which shifted inwards when not fully clear. When being steadied **SONIC JET** shifted inwards slightly crowding **BUDWISER** (T Thornton) on to **RIVER RAIDER** (C Lammas) which raced ungenerously when having to be steadied after being placed in restricted room losing ground. S Collett was advised to exercise greater care and to ensure that she is fully clear when shifting ground in future.

BUDWISER was held up behind the weakening **OUR DAISY** rounding the final turn going back on to **RIVER RAIDER** which had to shift outwards across that runner's heels.

SONIC JET and **AURORA LIGHTS** (D Johnson) came together near the 300 metres. **AURORA LIGHTS** was then inclined to lay in under pressure.

HASSELHOOF (M Cameron) shifted inwards under pressure early in the final straight.

Rider S Collett reported that her mount **OUR DAISY** had felt indifferent in its action. A post race veterinary examination did not detect any signs of lameness but found the filly to be displaying a slow rate of recovery.

L Magorrian reported that his mount **OSCAR LEGEND** had got its tongue over the bit.

Race 11	Cowley's Hire Centre 1600

Trainer Ms D Waddell was fined \$50 after presenting **CAST A SPELL** without notified gear.

PLAYBOY PRINCE (P Holmes), **EIGHT TO RULE** (B Hutton) and **MISTER TOM** (L Innes) all came together at the start with **MISTER TOM** then knuckling and shifting outwards making contact with **CHARLIE PRIDE** (L Magorrian).

THE MIG (T Thornton) was slow to begin.

MISTER TOM raced keenly for a distance passing the 1400 metres before being allowed to work forward passing the 800 metres to sit outside the leader.

SAVABELLA ROSE (C Lammas) raced ungenerously when making the bend approaching the 800 metres.

Passing the 750 metres **FINNS HALO** (R Norvall) became awkwardly placed on the heels of **BUSINESSMAN** (S Collett) which steadied.

SAVABELLA ROSE steadied for a distance approaching the 300 metres when awkwardly placed on the heels of the weakening **OUR QUEEN BEE** (A Schwerin).

When weighing in following the race R Norvall the rider of the fourth placed horse **FINNS HALO** was unable to draw the correct weight being in excess of the 0.5kg allowance allowed under the provisions of Rule 648(3) leading to **FINNS HALO** being disqualified from its fourth placing by the Judicial Committee. Trainer Mrs D Logan admitted a breach of Rule 614(2) in that a towel had been omitted when saddling **FINNS HALO** with the Judicial Committee imposing a fine of \$400.
