RACE COMMENTS:

Race 1	CAL ISUZU 1200
Trainers T Busuttin and N Young were fined \$100 after failing to gain permission to race ANIMATOR in blinkers by the required time.	
MONEY TRAIL (S Collett) was slow to begin.	
KATIE'S SO KOOL (T Thornton) shifted inwards leaving the barrier making contact with LANDED GENTRY (D Johnson) which then shifted in slightly making contact with the hind quarters of DEL RIOS (M Cameron) which became unbalanced, and shifted out. Simultaneously LAMAROSA shifted inwards when jumping away awkwardly crowding ANIMATOR (M McNab)	

on to **KATIE'S SO KOOL** which further crowded **LANDED GENTRY** which lost ground. **ANIMATOR** continued to race in restricted room for a distance before having to be steadied losing ground.

THE HASSLER (V Colgan) began awkwardly losing ground.

ANIMATOR made contact with the running rail when reluctant to improve to the inside of **LANDED GENTRY** going into the bend near the 900 metres. **ANIMATOR** continued to race greenly, making contact with the running rail on numerous occasions rounding the bend. When questioned rider M McNab advised that the gelding had raced on the speed when winning a recent trial, but after suffering interference at the start had got further back than intended today, racing greenly throughout but finding the line well, and would benefit from the experience of today's raceday debut.

Passing the 800 metres **KATIE'S SO KOOL** raced ungenerously when being steadied.

Rider D Johnson was unable to offer any excuses for the poor performance of **LANDED GENTRY**.

Race 2	NORRIS WARD MCKINNON 1400

KINDALEICA (S Collet) began awkwardly making contact with **ALLEYOOP** (B Hutton) which became unbalanced with both runners losing ground.

SIR ELMO (A Jones) was a little slow to begin.

Near the 1100 metres **OHOPE PRINCE** (B R Jones) shifted in when being steadied off the heels of **KELLY O'REILLY** (D Johnson) crowding **SAVANAH RUSH** (S Spratt) which was steadied. **OHOPE PRINCE** then raced ungenerously when being steadied for a distance getting its head up and shifting outwards to avoid the heels of **KELLY O'REILLY** near the 900 metres.

Race 3	NRM 2100

ARIZONA JAZZ (B Hutton) began awkwardly.

PEACEFULEASYFEELIN (A Jones) raced in restricted room soon after leaving the barriers and was steadied.

REKA (C Grylls) and **PROUD LIFE** (V Gatu) raced in restricted room approaching the 1900 metres to the inside of **SAVED BY THE BELL** (R Scott) which shifted in slightly.

Apprentices B Hutton (**ARIZONA JAZZ**) and L Magorrian (**ETHICAL**) were issued with warnings regarding their whip use prior to the 200 metres.

Apprentice L Magorrian admitted a breach of Rule 636(1)(d) in that he failed to ride his mount **ETHICAL** out to the end of the race when there was a reasonable chance of it finishing in a higher placing. After hearing submissions the Judicial Committee suspended L Magorrian's license to ride in races from the conclusion of racing on Saturday 13 June until the conclusion of racing on Wednesday 24 June, 5 riding days.

ZELDARA (M Cameron) pulled up in a distressed condition following the race requiring veterinary treatment.

Apprentice L Magorrian (**SILVER MINX**) was issued with a Minor Infringement Notice being fined \$200 after failing to claim down to his published riding weight.

SILVER MINX began awkwardly before being steadied when racing in restricted room.

YES (C Grylls) shifted outwards leaving the barrier crowding **VICKI ANNE** (B R Jones).

KATY O'BEEL (A Collett) began awkwardly making contact with the hind quarters of **MAGIC MEMORIES** (V Gatu).

TWILIGHT OFFER (D Johnson) raced ungenerously when being steadied in the early stages.

MAGIC MEMORIES raced three wide without cover.

ST SATURNIN (V Colgan) was steadied by its rider when crossing **SINGLE SHOT** (M Hills) near the 1850 metres when not fully clear. As a result **SINGLE SHOT** had to be restrained to avoid the heels of **ST SATURNIN** and shifted inwards slightly crowding **BACHELOR BRAVE** (M Coleman). **SILVER MINX** which was following also had to be steadied to avoid the heels of **SINGLE SHOT** going back on to **CARADONNA** (C Lammas). V Colgan was issued with a warning. **SINGLE SHOT** then over-raced becoming awkwardly placed inside the heels of **ST SATURNIN** again crowding **BACHELOR BRAVE** near the 1800 metres with **BACHELOR BRAVE** then making the first turn awkwardly.

SINGLE SHOT had to be steadied when briefly held up near the 500 metres.

COOLIBAH (T Thornton) ran wide rounding the final turn forcing **TWILIGHT OFFER** over extra ground.

CARADONNA was eased down over the concluding stages when well beaten with rider C Lammas advising that the mare had pulled up lame. A post-race veterinary examination found **CARADONNA** to have suffered a tendon injury to the right foreleg. Trainer Mr S Ralph indicated that the mare would now be retired.

Race 5	NEW WORLD TE RAPA 1600

GOSHAWK (C Grylls) shifted outwards leaving the barriers crowding **DOURO** (L Innes) which was steadied.

KIDDO (U Holmquist) and **ROAD TRIP** (P Holmes) both began awkwardly and came together with **ROAD TRIP** then shifting inwards making contact with the hind quarters of **GALVANISED** (A Jones).

PACORUS (V Gatu) began awkwardly losing ground.

HOWLAND (V Colgan) was held up near the 500 metres. **HOWLAND** was again held up entering the final straight near the 400 metres.

When questioned regarding the performance of **PARANA** rider D Johnson advised that the gelding had failed to handle today's track conditions.

Race 6	UNITED CLEANING 1400

Trainer Mr P Shailer was fined \$50 after **SECRET POWER** was presented to race with incorrect gear. **MAGNIFIER** (P Holmes) shifted outwards leaving the barriers crowding **DEEBEE DON** (M McNab) and **SECRET POWER** (M Coleman), both of which were hampered losing ground. **PRIZE LAD** (B Hutton) and **CELTIC BOY** (C Lammas) both began awkwardly. Approaching the 1200 metres **MAGNIFIER** commenced to race fiercely when becoming awkwardly placed on heels and shifted inwards inconveniencing **EMERALD LADY** (M Hills). **MAGNIFIER** continued to over-race through the middle stages. **MARCIANO** (D Johnson) raced greenly when looking to obtain clear running passing the 200 metres. **CELTIC BOY** (C Lammas) had some difficulty obtaining clear running until near the 150 metres. **SECRET POWER** lost the left front plate during the running.

Race 7	ALLIED SECURITY 1400

GARDONE (C Lammas) was very slow to begin. **MAN DOWN** (S Spratt) was slow to begin. **BOB VALDEZ** (V Gatu) began awkwardly before being crowded losing ground. **DAVEY CROCKETT** (M McNab) commenced to race ungenerously when being restrained in the early stages. **MAN DOWN** raced keenly in the early stages. **KLITSCHKO** (J Oliver) had to be steadied approaching the 600 metres when becoming awkwardly placed. **TROJAN** (L Hemi) lay out under pressure in the final straight. Following the race the gelding was found to have suffered a significant tendon injury to the left foreleg being unlikely to race again. **SAKOLOGY** (D Johnson) lost the right hind plate during the running.

Race 8	LINWOOD PARK STUD 1200

Trainers T and M Carter were fined \$50 after presenting **MRKNOWITALL** (R Smyth) to race with incorrect gear. **GRANT'S GIRL** (A Jones), **KEEPING TOM** (D Johnson) and **MRKNOWITALL** were all crowded between **ZERO TUA HUNDRED** (J Oliver) which shifted inwards and **GIARDINI** (M Coleman) which shifted outwards leaving the barriers with **MRKNOWITALL** having to be steadied losing ground. **SING FOR THE SUN** (L Hemi) was slow to begin. **GRANT'S GIRL** commenced to over-race near the 900 metres and shifted outwards forcing **ZERO TUA HUNDRED** across the heels of **ALICE WEBB ELLIS** (B Hutton). **GRANT'S GIRL** continued to over-race through the middle stages having to be steadied away from heels on a number of occasions. **JACQUI ICKX** (U Holmquist) was crowded near the 250 metres when **AIRMAN** (V Colgan) shifted away from **ALICE WEBB ELLIS** simultaneously as **GIARDINI** shifted outwards marginally. **AIRMAN** lost the left hind plate during the running.

Race 9	MUNNS THE MAN'S STORE 1600

CRACKLING ROSIE (L Hemi) and **ATLANTIS** (A Jones) came together leaving the barriers losing ground. **FORBIDDEN** (B Hutton) began awkwardly and was slow away. **KALINDA** (L Magorrian) was inconvenienced by **FLAVOUR FLAV** (M Hills) which shifted outwards leaving the barriers. **GALAKTIKA** (M Cameron) lay out under pressure in the final straight. **CLARA JANE** (L Innes) appeared to be accidentally struck on the head by the whip of M Cameron (**GALAKTIKA**) near the 250 metres. When continuing to lay out under pressure **GALAKTIKA** inconvenienced **CLARA JANE** passing the 100 metres. Prior to the authorisation of dividends the connections of **CLARA JANE** viewed footage of the home straight before electing not to proceed with a protest. **KALINDA** was eased down over the final 200 metres when well beaten with rider L Magorrian advising that the mare had felt indifferent in its action. A post-race veterinary examination of the **KALINDA** did not reveal any apparent abnormality.

Race 10	NORRIS WARD MCKINNON 1600

C Grylls (**EL BANDIDO**) lost his whip at the start when it became entangled in the barriers. **ELROI** (M Coleman) was very slow to begin (5L). **COPA VERDE** (S Spratt), **OOMPA** (A Jones) and **EL BANDIDO** all came together leaving the barriers with **OOMPA** and **COPA VERDE** jostling for several strides with **COPA VERDE** then being steadied losing ground. **OOMPA** then shifted outwards across heels hampering **EL BANDIDO** near the 1400 metres. Apprentice A Jones was advised to exercise greater care when shifting ground. **STORM BRO** (B Hutton) and **ADRIATIC PEARL** (B R Jones) were both slow to begin. **KENTUCKY SON** (U Holmquist) knuckled leaving the barriers. **AMBITIOUS PINS** (M Cameron) lay out shortly after leaving the barriers crowding **WELL RELATED** (S Collett) which steadied. **HOLLYWOOD LAD** (D Johnson) over-raced in the early stages. **AMBITIOUS PINS** hung outwards throughout the race and was unable to be ridden out as a result. A post-race veterinary examination of the gelding did not reveal any abnormality.
