Rider O Bosson did not attend the meeting with Stipendiary Stewards being advised by Mr Bosson's riding agent on the evening of Tuesday 26 May that he was unable to make the weight for his three declared rides, one of which was subsequently scratched. Mr Bosson was charged under Rule 330(3)(c) with the hearing to be held on a date to be set due to Mr Bosson's non-attendance today.

Rider R Cole did not attend today's meeting after suffering from the effects of a fall at yesterday's Cambridge Jumping Trials. R Cole is to provide a clearance prior to riding next.

**TOP CHOICE** was a late scratching from Race 3 at 8.20am as there was no suitable rider avaliable.

#### **RACE COMMENTS:**

#### Race 1 LUNJEVICH & MARTIN CONTRACTING

SPACE ODDITY (D Jensen) was slow to begin.

JET FIGHTER (G Walsh) jumped away awkwardly, losing ground.

**RUM'N'COKE** (A Tata) raced keenly in the early stages, and passing the 900 metres went off stride when entering the bend. **RUM'N'COKE** then raced greenly for a distance.

**ZORY STAR** (H Voss) raced wide without cover throughout.

Passing the 600 metres **WORTHISWAITNGOLD** (E Farr) shifted to the inside of **SIR AL SYD** (C Perrett) to obtain clear running, crowding **ENURE** (D Nolan) which had to steady. E Farr was reprimanded by Stewards and advised that a warning would be placed on her record.

**RUM'N'COKE** commenced to give ground passing the 500 metres with **ENURE** improving on to that runner's heels near the 450 metres and having to steady for a distance.

### Race 2 FRANK & ANNIE MATIJASEVICH MEMORIAL 1200

**GIARDINI** (B Hutton) and **BAGSAGOLD** (B R Jones) were both slow to begin.

#### Race 3 SILVER FERN FARMS 2200

WAITOKI AHI (A Tata) was slow to begin.

**PIONEER** (C Perrett) raced wide for the majority of the race.

**NOTABADROOSTER** (E Farr) was inclined to lay out in the final straight when placed under pressure.

Rider H Voss was questioned after Stewards had concerns regarding her ride on **THE NOTT**. Trainer Mr A Wright was also questioned and **THE NOTT** underwent a post-race veterinary examination which did not reveal any abnormality. Following consideration of the matter, H Voss was charged with incompetent riding under Rule 638(1)(e) in that she had ridden in an incompetent manner failing to maintain her position in the early stages after beginning well and continuing to allow her mount to lose ground through the middle stages. With Ms Voss leaving the racecourse during the course of the Stewards' inquiries the matter will be heard at a later date, with a further charge being lodged under Rule 606 in that Ms Voss had left the racecourse without obtaining the permission of the Stipendiary Stewards to do so.

### Race 4 WAIHOU TAVERN 2200

IT'S COMPLICATED (M Cameron) lay in leaving the barriers, forcing SPECIAL UNIT (U Holmquist) inwards, crowding THE KAKAHU EXPRESS (B Hutton) on to CANDARA (M Coleman) which was forced across the heels of MUZICMUZICMUZIC (S Spratt).

IT'S COMPLICATED raced ungenerously when being restrained in the early stages.

Passing the 1200 metres **SKILLS** (V Colgan) had to be steadied when placed in restricted room between **ZAH OFF** (C Grylls) and **BIXBY** (D Johnson).

## Race 5 NEW WORLD MORRINSVILLE 1600

**LICAVOLI** (G Cooksley) was slow to begin.

**NOWHERE MAN** (L Innes) began awkwardly, and then was further hampered by **SHE'S ALL CLANG** (M McNab) which also began awkwardly and shifted inwards.

**SHIMMY** (S Spratt) got its head up when racing ungenerously in the early to middle stages.

**MATANGI BOY** (U Holmquist) raced ungenerously when being restrained in the early stages, and dipped when crossing on to the course proper approaching the 1400 metres, then shifting out, hampering **PRIMROSE HILL** (A Collett) which had to be steadied.

LICAVOLI raced keenly through the middle stages.

When questioned regarding the performance of **PRIMROSE HILL** rider A Collett advised that the filly failed to handle today's track conditions. A post-race veterinary examination of **PRIMROSE HILL** did not reveal any abnormality.

### Race 6 NOTTINGHAM CASTLE HOTEL 1200

**REACHIN' OUT** (S McKay) was very slow to begin (5L).

KEEP IN FASHION (B R Jones) was slow to begin, and then crowded.

PHILLY LANE (V Colgan) was crowded shortly after leaving the barrier.

**DINAH LEE** (M Coleman) lay in leaving the barriers crowding **LUNA DOLCE** (A Collett).

ROC'S ARE DIAMONDS (D Johnson) raced ungenerously when being steadied passing the 1000 metres.

**DINAH LEE** shied approaching the 100 metres and shift in, inconveniencing I'LL STAND BY YOU (U Holmquist).

Rider L Innes reported to Stewards that in his opinion **OUR IFFRAAJ** had breathing abnormalities. A subsequent veterinary examination did not reveal any obvious abnormality, but that abnormal breathing noises reported may be consistent with displacement of the soft palate.

When questioned regarding the performance of **THE KEEPT LADY** apprentice A Jones advised that the filly, which had won both its recent trials by jumping well and racing on the pace, had jumped away only fairly today, and got further back than intended where it had not felt overly comfortable in today's track conditions, and in particular the amount of kick-back and had been unable to recover.

### Race 7 DAVE, FRED & MICHAEL LAURICH 1400

COX ROAD (T Thornton) was slow to begin.

THE HAWK (C Grylls) and LUCKY SUGGESTION (R Goldsbury) began awkwardly.

THE SWEET ESCAPE (C Collett) raced ungenerously in the early to middle stages.

# Race 8 VICTOR & FRANK MATIJASEVICH 1400

KEEPHERINMIND (M Coleman) was slow to begin.

TONY TWO CHIPS (M McNab) began awkwardly, and then was crowded.

G Cooksley admitted a breach of careless riding in that he permitted his mount **WADAPLEASURE** to shift outwards when not sufficiently clear of **RUN FORREST RUN** (S Spratt) which was checked near the 450 metres. After hearing all relevant evidence the Judicial Committee suspended G Cooksley's licence to ride in races 2 – 10 June inclusive, three riding days.

**SORORIA** (D Johnson) then lay out making contact with **CHILI PEPPER** (M Chui) forcing **WADAPLEASURE** out further compounding the crowding received by **RUN FORREST RUN** which made contact with **FORTUNE KEPT** (S Collett) which was badly hampered when buffeted. **SORORIA** then continued to lay out under pressure in the final straight making contact with **CHILI PEPPER** passing the 250 metres.

Early in the final straight **STRONG IMPACT** (B Hutton) shifted away from **KIDDO** (U Holmquist) making contact with **SAKI'S ACE** (A Collett) which briefly steadied.

### Race 9 KARL DAVIS BAYLEYS REAL ESTATE 1200

DRAW THE LINE (T Thornton), OUR EEJAY (J Oliver) and DARK GEM (A Schwerin) were slow to begin.

SUGGEST GOLD (R Goldsbury) jumped away awkwardly, losing ground.

PRINCESS NICOLE (U Holmquist) was held up for the majority of the final straight.

**DRAW THE LINE** lay in under pressure in the final straight and despite the efforts of its rider shifted in passing the 200 metres hampering the weakening **OUR EEJAY**.

BACHATA (M McNab) had difficulty obtaining clear running until near the 100 metres.

#### Race 10 NZB INSURANCE PEARL SERIES RACE

The start of this race was delayed one minute at the request of TAB Control.

MADDEE FAE (C Lammas) and PUZZLENTE (B Hutton) both jumped away awkwardly coming together making contact with both runners becoming unbalanced. MADDEE FAE then made contact with TREVITA (V Colgan) which was forced on to ODIN'S CHOICE (A Jones) with TREVITA, MADDEE FAE and PUZZLENTE then all coming together again. Passing the 350 metres MADDEE FAE shifted out and away from ODIN'S CHOICE which had shifted out slightly with MADDEE FAE hampering TREVITA and TRANKY DOO (D Johnson) which were both hampered and forced wide. B Hutton the rider of PUZZLENTE admitted a breach of Rule 638(3)(b)(i) for using his whip to an extent which was unnecessary and was fined \$300.00.
