### **RACE COMMENTS:**

Race 1 Bidvest 2400

Rider **M McNab** was fined \$100 when failing to make the contracted weight for LE'VANTOS. M McNab was replaced by D Johnson.

# Race 2 Armitage Mile

Z Moki was replaced by B Hutton after experiencing transport delays. Z Moki was questioned after arriving on course with her explanation being accepted.

# Race 3 Equilume 1400

THE SHACKLER (C Lammas) raced in restricted room for a short distance when leaving the barriers.

THE SHACKLER and LUCKY FEATHER (M Coleman) both raced keenly in the early to middle stages.

Approaching the 600 metres **RAMARRO** (D Johnson) shifted out off the heels of the weakening **THE SHACKLER** crowding **SIERRA BEEL** (V Colgan) which was checked, losing ground. Rider D Johnson plead guilty to a subsequent breach of careless riding with her license to ride in races being suspended by the Judicial Committee, 28 May to 1 June 2015 inclusive, 5 riding days.

# Race 4 Scot Thrust 1200

**TWILIGHT DRAGON** (R Smyth) was inclined to lay out in the final 100 metres when placed under pressure.

Rider **R Smyth** (TWILIGHT DRAGON) was reprimanded for her use of the whip prior to the 200 metres and advised that a warning would be placed on her record.

Trainer P Williams was spoken to regarding the barrier manners of **FLOWER BOMB**. Trainer P Williams advised Stewards that a blind fold would be tried on **FLOWER BOMB** at its next race day appearance to try and rectify the mare's poor barrier manners.

# Race 5 Shamrock Group 1200

MAN DOWN (S Spratt) was slow to begin and then was hampered when THE KEY'S WITHIN (A Collett) shifted out. AMBER RAYNE (B Hutton) over-raced in the early stages.

**HAYPIN** (T Thornton) was held up until approaching the 200 metres.

Rider T Thornton (HAYPIN) was reminded of her obligations when riding her mounts out to the finish of the race when circumstances permit her to do so.

### Race 6 Broderick Print Mile

LEICA DREIM (A Collett), INA JAM (C Lammas) and PACORUS (V Gatu) were slow to begin.

Near the 1500 metres **READY TO RUMBLE** (T Thornton) shifted in, crowding **VITA BELLA** (D Johnson) which clipped a heel and blundered. Rider T Thornton defended a resultant breach of careless riding with the Judicial Committee finding the charge proven. The Judicial Committee suspended T Thornton's license to ride in races from 28 May to 3 June 2015 inclusive, 3 riding days.

Near the 1200 metres **ZUCCHERO** (O Bosson) shifted in, dictating **ROCK DA** (R Smyth) in on to **BOOTYFUL** (V Colgan) and **VITA BELLA** (D Johnson) which both had to briefly steady. Contributing was outward movement from **BRAVO SUPREMO** (M Cameron). As a result **POSTD'OR** (B Hutton) which was following had to steady.

## Race 7 Graeme Thomson Jewellers Great Northern Foal Stakes

**DUKEDOM** was late scratched on veterinary advice at 1.20pm after becoming cast in its box on course.

Shortly after the start **FASCINATE ME** (M Hills) lay out crowding **CASTAMERE** (R Hutchings) and **SECRET SPIRIT** (D Johnson) which was hampered.

When being steadied **RONCHI** (G Cooksley) went off stride passing the 1200 metres. **RONCHI** then raced ungenerously for a distance.

**FASCINATE ME** had a tendency to lay in under pressure in the final straight.

## Race 8 Shamrock Recruitment 1400

Trainer G Merkulov was granted permission to remove the blinkers from **SAVED BY THE BELL** due to track conditions. **ANA** (M Cameron) was slow to begin.

**HE'S A BIGDEEL** (C Grylls) was slow to begin and then was crowded for a distance.

**FIAMETTE** (V Colgan) raced keenly in the early to middle stages.

### Race 9 Ellerslie Event Centre 1400

CASINO PARK (Z Moki) was slow to begin.

**LAMASON** (M Cameron) raced keenly in the early stages.

**DOUCETTE** (A Collett) steadied passing the 1100 metres and then was hampered when becoming awkwardly placed on heels.

Riders **V Colgan** (SONIC JET) and **M McNab** (DAHLS DELIGHT) advised that their respective mounts which were not persevered with in the final straight, had failed to cope with the existing track conditions.

Race 10 Papatoetoe Glass Mile

Trainer D Logan was granted permission to remove the blinkers from **RADAR** due to track conditions.

**RADAR** (T Thornton) knuckled when leaving the barriers, losing ground.

**BULLDOZER** (R Hutchings) and **HENRY TUDOR** (S Spratt) made brief contact near the 100 metres.
