Race 11 – Baker Racing 1200

Rider M McNab was suspended by the Judicial Committee from the conclusion of racing on Saturday 9 May until the conclusion of racing on Wednesday 20 May, 3 riding days, after admitting a breach of careless riding in that he permitted his mount **SAOIRSE** to shift outwards when not sufficiently clear causing interference to **ALICUDI** (D Johnson), **JACQUI ICKX** (U Holmquist) and **TWIN FIGHTER** (R Norvall) near the 175 metres.

RACE COMMENTS:

Race 1 NORTHERN RACE DAY SERVICES 2000

THINKING OUT LOUD (L Magorrian) jumped away awkwardly when the gates opened.

DANCING DONNA (B R Jones) shifted out leaving the barrier hampering CRUISEO (J Oliver).

SHEEZ THE BOSS (A Collett) and CENTRE STAGE (D Johnson) began awkwardly losing ground.

BIXBY (S Collett) and THE KAKAHU EXPRESS (C Lammas) were both slow to begin.

THINKING OUT LOUD commenced to race ungenerously when being steadied in the early stages. THINKING OUT LOUD continued to race ungenerously through the middle stages shifting back on to LADY QUASAR (B Hutton) near the 1300 metres.

Near the 1300 metres **A PERTE DE VUE** (Z Moki) made the crossing awkwardly shifting out, and then raced ungenerously for a distance.

BIG MEADSY (V Gatu) raced keenly in the early stages being allowed to stride forward to sit outside the leader passing the 1000 metres.

VILLA ELBA (R Hutchings) raced in restricted room for a distance passing the 900 metres to the inside of A PERTE DE VUE which then shifted in slightly passing the 800 metres with VILLA ELBA being hampered losing ground.

LADY QUASAR shifted out off the heels of the weakening THINKING OUT LOUD to obtain clear running near the 400 metres. BIG MEADSY shifted out under pressure making contact with CRUISEO on at least three occasions in the final straight.

A Collett the rider of **SHEEZ THE BOSS** dropped her whip approaching the 200 metres.

Race 2 BROADWAY MOTEL 1200

Prior to the start **BLAZE SMARTIE** dropped its head in the barriers dislodging rider M Coleman who was uninjured. **ROAD TRIP** (P Holmes) and **MISS EL DORADO** (R Norvall) were both slow to begin.

HUBBLE BUBBLE (M Sweeney) and JOUET CUVEE (M Cameron) came together on jumping away when both runners began awkwardly.

FIRST HONOUR (L Magorrian) began awkwardly shifting out abruptly taking **BLAZE SMARTIE** (M Coleman) wider on the track. **BEAUTY ACE** (C Grylls) over-raced in the early stages.

JOUET CUVEE got its head up and over-raced for a distance when being restrained passing the 800 metres.

SIAN (J Oliver) made the bend awkwardly near the 800 metres.

Passing the 150 metres **JOUET CUVEE** shifted out across the heels of **FIRST HONOUR** to obtain clear running taking **BEAUTY ACE** out into the line of **ALL RAZZLE DAZZLE** (V Colgan) which had to be steadied off the heels of **BEAUTY ACE**. Rider M Cameron was issued with a warning.

Race 3 MODERN TRANSPORT ENGINEERS LTD 1200

ONETANGI (M Cameron) began awkwardly making contact with **CHERRY BAY** (D Johnson) which shifted out taking **CHILI PEPPER** (V Ravikumar) out on to **THE SWEET ESCAPE** (A Collett) with both those runners being crowded losing ground. Contributing was inward movement from **GALAXY MISS** (C Grylls).

IN MEMORY OF (P Holmes) began very awkwardly shifting in hampering **KEEPHERINMIND** (B R Jones) which had to steady. **IN MEMORY OF** then raced ungenerously through the early stages.

ARCADE (S Collett) began awkwardly.

Approaching the 800 metres **POWER STAR** (R Schistl) moved in when not sufficiently clear of **OUR IFFRAAJ** (J Oliver) which had to be checked sharply losing ground. R Schistl defended a charge of careless riding under Rule 638(1)(d) after viewing all relevant videos the charge was found proven with his licence being suspended from the conclusion of racing on 20th May up to including the 1st June 2015(4 Days).

Approaching the 700 metres **ONETANGI** had to be checked losing ground when crowded to the inside of **CHERRY BAY** which was racing to the inside of **BOUNTIFUL** (G Cooksley) which was dictated in by **POWER STAR**. R Schistl was charged under Rule 638(1)(d) to which he elected to plead guilty and was suspended from the conclusion of racing on the 2nd June up to and including 13th June 2015(4 Days).

As a result **CHILI PEPPER** then shifted away from the running rail to avoid the heels of **ONETANGI** forcing **IN MEMORY OF** out on to the hind quarters of **SYRIANA** (M Hills) which became unbalanced and lay in, then crowding **IN MEMORY OF** on to **CHILI PEPPER** which was checked and shifted out abruptly badly hampering **KEEPHERINMIND** which made contact with the hind quarters of **ARCADE**.

When questioned into the performance of the favourite **BOUNTIFUL** rider G Cooksley advised the filly may prefer better footing than on this occasion.

When questioned into the performance of **ONETANGI** rider M Cameron advised that after being checked in the middle stages the filly then was reluctant to improve and was not persevered with over the final 100 metres. M Cameron also advised that the filly would be stepped up to 1400 metres at its next start.

Race 4AA AUTO SERVICE & REPAIR MATAMATA 1400

PINZ CHARMING (B R Jones) escaped under the front of the barrier stalls and galloped a distance being declared a late scratching at 1.44 pm. A subsequent veterinary examination revealed superficial lacerations to the neck area which required veterinary attention.

KIDDO (U Holmquist) was crowded leaving the barriers losing ground.

HOWZAT (D Johnson) was bumped becoming unbalanced shortly after leaving the barriers.

HANNIBAL LECTER (P Holmes) began awkwardly.

LEICA DREIM (A Collett) raced ungenerously when making the bend passing the 800 metres. **LEICA DREIM** then became awkwardly placed on heels passing the 600 metres.

After this race the track was upgraded to Dead (6).

Race 5 MATAMATA GLASS & JOINERY 1400

BIG DREAMER (V Colgan) jumped away awkwardly losing ground.

DREAMLIFE (M Cameron) was crowded shortly after leaving the barrier.

MAX A MISS (A Jones) lay out when crossing on to the course proper near the 1300 metres with **FLANDERS** (J Oliver) having to be firmly restrained off that runner's heels.

FLANDERS over-raced for a distance when being steadied off the heels of **MAX A MISS** through the middle stages.

DREAMLIFE raced keenly in the early and middle stages, and hung out when making the final bend running wide.

Race 6 THE BOLTHOLDER LIMITED 1600

LORD SHIVA (R Hutchings) was slow to begin.

YARDARM (M Cameron) raced ungenerously in the early stages.

100 metres after the start **HOWLAND** (V Colgan) when crossing over to obtain a position closer to the inside crowded **MUZICMUZIC** (R Schistl), **SILVERADO** (A Jones) and **GOSHAWK** (C Grylls) which all had to be steadied as a result. **HOWLAND** then continued to shift in inconveniencing **THE ARABIAN DUKE** (S Collett). V Colgan was issued with a warning.

YARDARM over-raced when crossing over to the course proper near the 1200 metres for a distance.

HEATH (R Smyth) raced wide without cover for the majority of the race.

FINNS HALO (R Norvall) made the 800 metre bend awkwardly.

Passing the 500 metres **MUZICMUZICMUZIC** improved into a marginal run to the inside of **ARTERIAL** (B R Jones) which lay in slightly with **MUZICMUZICMUZIC** then clipping a heel blundering losing ground. Hampered as a result was **CANDARA** (M Coleman).

Passing the 250 metres **RESET THE TURBO** (C Lammas) lay out under pressure inconveniencing **HOWLAND**. When being corrected **RESET THE TURBO** shifted back in taking **HEATH** (R Smyth) inwards which made contact with **THE ARABIAN DUKE** (S Collett) with those two runners buffeting for a short distance.

Passing the 75 metres **HOWLAND** shifted in under pressure making contact with **RESET THE TURBO**.

GOSHAWK lost the near hind plate during the running.

Race 7 CHALLENGE MATAMATA 2000

CANDYBELLE (C Grylls) jumped away awkwardly crowding ON PAROLE (S Collett).

RUNNING SCARED (B Hutton) began awkwardly.

TE KINGI (U Holmquist) raced keenly in the lead in the early stages.

RUNNING SCARED shifted outwards near the 250 metres forcing **PROUD LIFE** (A Collett) outwards making contact with **ON PAROLE**.

CANDYBELLE underwent a post-race veterinary examination which revealed the filly to be suffering from cardiac arrhythmia. The connections were advised that **CANDYBELLE** will require a veterinary clearance, including a clear ECG test, prior to racing next.

Race 8 NZB INSURANCE PEARL SERIES RACE

PURCENTAGE (C Grylls) shifted out leaving the barrier crowding **ENJOY THE RIDE** (A Collett) and **FELICITY HALL** (P Holmes) clipping a heel and blundering.

SAKOLOGY (D Johnson) shifted out leaving the barrier crowding **HIGH TAIL IT** (M Coleman).

HARMONIZE (V Colgan) shifted out abruptly leaving the barrier crowding ADRIATIC PEARL (B R Jones).

SAKOLOGY hung out away from the running rail in the run down the back straight, and hung out around the final bend. Passing the 1050 metres **FELICITY HALL** shifted out off the heels of **HARMONIZE** when racing keenly.

SHEEZ TORKIN (B Hutton) raced wide without cover for the majority of the race.

Race 9 MATAMATA GLASS & JOINERY 1400

KINDALEICA (B Hutton) jumped away awkwardly.

DEEBEE DON (C Grylls) was slow to begin.

SYDNEY CARTON (M Cameron) raced ungenerously when being steadied in the early stages.

FLICKA OF GOLD (A Collett) raced three wide throughout.

I'M BRONSON (R Schistl) went off stride passing the 200 metres when racing in restricted room.

PITTSBURGH LAD (S Collett) collapsed following the race and was humanely euthanised.
