## RACE COMMENTS:

Race 1	PIAKO MITSUBISHI 1600
<b>PRIZE LORD</b> (C Grylls) was slow to begin. <b>IT'S COMPLICATED</b> (M McNab) jumped away awkwardly. <b>LA NOVICE</b> (U Holmquist) over-raced through the middle stages, and steadied passing the 900 metres when awkwardly placed. Approaching the 500 metres <b>IT'S COMPLICATED</b> when attempting a tight run to the inside of <b>ARTERIAL</b> (B R Jones) shifted away from that runner hampering <b>PRIZE LORD</b> (C Grylls) which was hampered losing ground. After questioning riders concerned and viewing all relevant videos which were inconclusive rider M McNab was advised to exercise care. Approaching the 350 metres <b>IT'S COMPLICATED</b> attempted a tight run to the inside of <b>ARTERIAL</b> making contact with that runner forcing it wider on the track. Contributing was outward movement from <b>OHIO GIRL</b> (L Magorrian) on to <b>IT'S</b>	

<b>COMPLICATED.</b> After this race the track was downgraded to Heavy (10).	
<b>Race 2</b>	<b>JAN REVELL MEMORIAL 1400</b>
<p>Trainer Mr C Wood was fined \$100 for failing to declare a rider by the required time for <b>PACORUS</b>. <b>PACORUS</b> (V Gatu) was slow away.</p> <p><b>SHE'S ALL CLANG</b> (M McNab) was crowded shortly after jumping away between <b>BOSTON HAVOC</b> (B Hutton) which shifted out and <b>SIR AL SYD</b> (J Oliver) which shifted in, then shortly after <b>SHE'S ALL CLANG</b> had to steady when further crowded between <b>BOSTON HAVOC</b> and <b>SIR AL SYD</b> which were taken out by <b>BONNY EMILIA</b> (L Innes). Contributing was inward movement from <b>STOCKTAKE</b> (S Spratt) resulting in <b>SHE'S ALL CLANG</b> being badly hampered.</p> <p>Approaching the 900 metres <b>MONEYMAKEHERSMILE</b> (B R Jones) shifted out when becoming awkwardly placed on the heels of <b>LADY DE LAGO</b> (R Smyth) which was laying out taking <b>BONNY EMILIA</b> out on to <b>WHAT'S UP ALF</b> (D Johnson) taking that runner out on to <b>RAADICAL JAZZ</b> (M Coleman) which had to steady.</p> <p>M McNab admitted a breach of Rule 638(1)(d) in that he failed to ride <b>SHE'S ALL CLANG</b> out to the end of the race when there was a reasonable chance of finishing in a better position. After viewing the videos and hearing submissions M McNab's license to ride in races was suspended from the conclusion of racing on Saturday 2 May up to and including racing on Saturday 9 May, 4 riding days.</p>	
<b>Race 3</b>	<b>RACING TE AROHA SUPPORTERS CLUB 1400</b>
<p><b>MY ALEGRIA</b> (U Holmquist) began awkwardly.</p> <p><b>NESSUN DORMA</b> (M McNab) lay out shortly after jumping away taking <b>FOUR DAY HIGH</b> (B R Jones) out on to <b>CHASING AMY</b> (M Sweeney) which had to steady when becoming awkwardly placed on the heels of <b>FOUR DAY HIGH</b>. Contributing was inward movement from <b>STRONG IMPACT</b> (S Collett). <b>CHASING AMY</b> and <b>STRONG IMPACT</b> then continued to buffet for a short distance.</p> <p><b>MY ALEGRIA</b> shifted out under pressure in the final straight.</p> <p><b>RIDDLE</b> (S McKay) had to be straightened on at least two occasions in the final straight when hanging out under pressure.</p>	
<b>Race 4</b>	<b>MANAWARU SANDFILL &amp; LIVESTOCK LTD 1200</b>
<p><b>HE'S GAME</b> (K Myers) and <b>BLAZE SMARTIE</b> (B R Jones) were both slow to begin.</p> <p>Approaching the 1000 metres <b>ARIZONA BLIZZARD</b> (U Holmquist) shifted in abruptly away from <b>CAGLIARI</b> (V Colgan) crowding <b>CAPISTRANO PEARL</b> (J Oliver) which clipped a heel and blundered losing ground.</p> <p><b>CAPISTRANO PEARL</b> got its head up when being restrained off the heels of <b>VIVA LA JOUR</b> (M Hills) which was shifting out to improve forward approaching the 500 metres.</p> <p><b>CAGLIARI</b> raced greenly in the final straight when under pressure.</p> <p>When questioned into the disappointing performance of <b>ARIZONA BLIZZARD</b> the rider advised Stewards that the gelding had become fractious prior to the start, and over-raced in the early and middle stages, but was unable to offer any other reason for the gelding's performance.</p>	
<b>Race 5</b>	<b>TRU-TEST GROUP 1400</b>
<p><b>ARTIFACT</b> (M Chui) began awkwardly.</p> <p><b>HEISTHEONE</b> (B Hutton) over-raced through the middle stages.</p> <p>Approaching the 1150 metres <b>TOFINO</b> (J Oliver) got its head up when being restrained off the heels of <b>VARRO</b> (C Lammas).</p> <p><b>AMUN RA</b> (M Cameron) shifted in abruptly near the 200 metres after shying at a steeplechase fence when wide on the track.</p>	
<b>Race 6</b>	<b>TE AROHA STALLION PLACEMENT SCHEME 1400</b>
<p>B R Jones failed to make the handicapped weight for <b>MANAIA ROSE</b> and was fined \$100 and replaced by K Myers.</p> <p><b>SPRNGLOADED</b> (A Collett), <b>LUCKY DESIRE</b> (S Spratt) and <b>JORDANIAN PRINCE</b> (S Collett) were all slow to begin.</p> <p><b>POGUE</b> (A Taylor) raced keenly in the early and middle stages.</p> <p><b>LUCKY DESIRE</b> had to steady over the concluding stages when racing in restricted room.</p>	
<b>Race 7</b>	<b>SUPER LIQUOR TE AROHA 2200</b>
<p><b>SINO HEIGHTS</b> (S McKay) jumped away awkwardly losing ground.</p> <p><b>FULL MONTY</b> (K Myers) and <b>SILVE MINX</b> (S Collett) came together on several occasions in the final straight when both runners shifted ground.</p>	
<b>Race 8</b>	<b>NZB INSURANCE PEARL SERIES RACE</b>
<p><b>PHEROZITA</b> (S Collett) was slow to begin.</p> <p><b>NABBED</b> (U Holmquist) jumped away awkwardly shifting out making contact with <b>LUCKY AFFAIR</b> (B Hutton) losing ground.</p> <p><b>MIDNIGHT HOUR</b> (L Magorrian) was inclined to lay out under pressure in the final straight.</p>	
<b>Race 9</b>	<b>SIR SLICK WINNERS CIRCLE 1400</b>
<b>NOTTOOBAD</b> (A Collett) was slow to begin.	

**ROCKNROLLA** (S Collett) began awkwardly making contact with **GIARDINI** (C Grylls).  
**PUNTINATO** (D Johnson) had to steady passing the 1300 metres and shift out across the heels of **PANNA COTTA** (L Innes), and then commenced to over-race for a distance.  
**PEREGRINE** (K Myers) had to steady passing the 400 metres and change ground to obtain clear running.

<b>Race 10</b>	<b>ECOLAB 1600</b>

**SONIC ROCKET** (A Collett), **ST D'ORE** (Z Moki) and **KATORIE** (S Spratt) were all slow to begin.  
**STELLA** (L Magorrian) raced ungenerously in the early stages.  
Approaching the 1400 metres **AMITY DANE** (J Oliver) shifted out taking **STELLA** and **GOTTA KEEPER** (M Cameron) wider on the track.  
**STELLA** had to be firmly restrained passing the 1400 metres when crowded between **GOTTA KEEPER** and **AMITY DANE** when both those runners shifted ground.  
Passing the 800 metres **AMITY DANE** had to be steadied when crowded to the outside of **MAGIC MEMORIES** (V Gatu) which shifted out when not clear, and contributing was inward movement from **GOTTA KEEPER**. After questioning riders concerned apprentice jockey V Gatu was issued with a warning.  
**KENTUCKY SON** (U Holmquist) shifted out abruptly passing the 200 metres.  
**KATORIE** (S Spratt) lay out under pressure in the final straight.  
B R Jones the rider of **WAJIMA** was charged under Rule 638(3)(b) for excessive use of the whip prior to the 200 metres and was fined the sum of \$200.
