RACE COMMENTS:

 Race 1
 PIAKO MITSUBISHI 1600

 PRIZE LORD (C Grylls) was slow to begin.
 IT'S COMPLICATED (M McNab) jumped away awkwardly.

 LA NOVICE (U Holmquist) over-raced through the middle stages, and steadied passing the 900 metres when awkwardly placed.

 Approaching the 500 metres IT'S COMPLICATED when attempting a tight run to the inside of ARTERIAL (B R Jones) shifted

away from that runner hampering **PRIZE LORD** (C Grylls) which was hampered losing ground. After questioning riders concerned and viewing all relevant videos which were inconclusive rider M McNab was advised to exercise care.

Approaching the 350 metres **IT'S COMPLICATED** attempted a tight run to the inside of **ARTERIAL** making contact with that runner forcing it wider on the track. Contributing was outward movement from **OHIO GIRL** (L Magorrian) on to **IT'S**

COMPLICATED.

After this race the track was downgraded to Heavy (10).

Race 2 JAN REVELL MEMORIAL 1400

Trainer Mr C Wood was fined \$100 for failing to declare a rider by the required time for **PACORUS**.

PACORUS (V Gatu) was slow away.

SHE'S ALL CLANG (M McNab) was crowded shortly after jumping away between **BOSTON HAVOC** (B Hutton) which shifted out and **SIR AL SYD** (J Oliver) which shifted in, then shortly after **SHE'S ALL CLANG** had to steady when further crowded between **BOSTON HAVOC** and **SIR AL SYD** which were taken out by **BONNY EMILIA** (L Innes). Contributing was inward movement from **STOCKTAKE** (S Spratt) resulting in **SHE'S ALL CLANG** being badly hampered.

Approaching the 900 metres **MONEYMAKEHERSMILE** (B R Jones) shifted out when becoming awkwardly placed on the heels of **LADY DE LAGO** (R Smyth) which was laying out taking **BONNY EMILIA** out on to **WHAT'S UP ALF** (D Johnson) taking that runner out on to **RAADICAL JAZZ** (M Coleman) which had to steady.

M McNab admitted a breach of Rule 638(1)(d) in that he failed to ride **SHE'S ALL CLANG** out to the end of the race when there was a reasonable chance of finishing in a better position. After viewing the videos and hearing submissions M McNab's license to ride in races was suspended from the conclusion of racing on Saturday 2 May up to and including racing on Saturday 9 May, 4 riding days.

Race 3 RACING TE AROHA SUPPORTERS CLUB 1400

MY ALEGRIA (U Holmquist) began awkwardly.

NESSUN DORMA (M McNab) lay out shortly after jumping away taking **FOUR DAY HIGH** (B R Jones) out on to **CHASING AMY** (M Sweeney) which had to steady when becoming awkwardly placed on the heels of **FOUR DAY HIGH**. Contributing was inward movement from **STRONG IMPACT** (S Collett). **CHASING AMY** and **STRONG IMPACT** then continued to buffet for a short distance.

MY ALEGRIA shifted out under pressure in the final straight.

RIDDLE (S McKay) had to be straightened on at least two occasions in the final straight when hanging out under pressure.

Race 4 MANAWARU SANDFILL & LIVESTOCK LTD 1200

HE'S GAME (K Myers) and BLAZE SMARTIE (B R Jones) were both slow to begin.

Approaching the 1000 metres **ARIZONA BLIZZARD** (U Holmquist) shifted in abruptly away from **CAGLIARI** (V Colgan) crowding **CAPISTRANO PEARL** (J Oliver) which clipped a heel and blundered losing ground.

CAPISTRANO PEARL got its head up when being restrained off the heels of **VIVA LA JOUR** (M Hills) which was shifting out to improve forward approaching the 500 metres.

CAGLIARI raced greenly in the final straight when under pressure.

When questioned into the disappointing performance of **ARIZONA BLIZZARD** the rider advised Stewards that the gelding had become fractious prior to the start, and over-raced in the early and middle stages, but was unable to offer any other reason for the gelding's performance.

Race 5TRU-TEST GROUP 1400

ARTIFACT (M Chui) began awkwardly.

HEISTHEONE (B Hutton) over-raced through the middle stages.

Approaching the 1150 metres **TOFINO** (J Oliver) got its head up when being restrained off the heels of **VARRO** (C Lammas).

AMUN RA (M Cameron) shifted in abruptly near the 200 metres after shying at a steeplechase fence when wide on the track.

Race 6 TE AROHA STALLION PLACEMENT SCHEME 1400

B R Jones failed to make the handicapped weight for **MANAIA ROSE** and was fined \$100 and replaced by K Myers. **SPRNGLOADED** (A Collett), **LUCKY DESIRE** (S Spratt) and **JORDANIAN PRINCE** (S Collett) were all slow to begin.

POGUE (A Taylor) raced keenly in the early and middle stages.

LUCKY DESIRE had to steady over the concluding stages when racing in restricted room.

Race 7 SUPER LIQUOR TE AROHA 2200

SINO HEIGHTS (S McKay) jumped away awkwardly losing ground.

FULL MONTY (K Myers) and **SILVE MINX** (S Collett) came together on several occasions in the final straight when both runners shifted ground.

Race 8	NZB INSURANCE PEARL SERIES RACE

PHEROZITA (S Collett) was slow to begin.

NABBED (U Holmquist) jumped away awkwardly shifting out making contact with **LUCKY AFFAIR** (B Hutton) losing ground.

MIDNIGHT HOUR (L Magorrian) was inclined to lay out under pressure in the final straight.

Race 9 SIR SLICK WINNERS CIRCLE 1400

NOTTOOBAD (A Collett) was slow to begin.

ROCKNROLLA (S Collett) began awkwardly making contact with **GIARDINI** (C Grylls).

PUNTINATO (D Johnson) had to steady passing the 1300 metres and shift out across the heels of **PANNA COTTA** (L Innes), and then commenced to over-race for a distance.

PEREGRINE (K Myers) had to steady passing the 400 metres and change ground to obtain clear running.

Race 10 ECOLAB 1600

SONIC ROCKET (A Collett), **ST D'ORE** (Z Moki) and **KATORIE** (S Spratt) were all slow to begin.

STELLA (L Magorrian) raced ungenerously in the early stages.

Approaching the 1400 metres **AMITY DANE** (J Oliver) shifted out taking **STELLA** and **GOTTA KEEPER** (M Cameron) wider on the track.

STELLA had to be firmly restrained passing the 1400 metres when crowded between **GOTTA KEEPER** and **AMITY DANE** when both those runners shifted ground.

Passing the 800 metres **AMITY DANE** had to be steadied when crowded to the outside of **MAGIC MEMORIES** (V Gatu) which shifted out when not clear, and contributing was inward movement from **GOTTA KEEPER**. After questioning riders concerned apprentice jockey V Gatu was issued with a warning.

KENTUCKY SON (U Holmquist) shifted out abruptly passing the 200 metres.

KATORIE (S Spratt) lay out under pressure in the final straight.

B R Jones the rider of **WAJIMA** was charged under Rule 638(3)(b) for excessive use of the whip prior to the 200 metres and was fined the sum of \$200.
