Passing the 1400 metres **LA DORADA** (J Oliver) became awkwardly placed on the heels of **HILARIOUS HONOUR** which was steadying. As a result **LA DORADA** then raced ungenerously shifting back on to **DAHLS DELIGHT** which raced ungenerously for a distance.

## Race 3 ROGER GILL MOTORS LTD 1600

**THE PAPERBOY** (K Leung) raced wide without cover throughout.

Rider C Dell reported that **NEEDS TO PLAY** failed to handle today's existing track conditions.

When questioned regarding the performance of **OOMPA** rider B R Jones advised that the gelding had found today's conditions too testing.

Race 4 FELICE BROOM @ HARCOURTS 1200

SO KEEP ME (M Wenn) and AIRWORTHY (C Dell) both began awkwardly.

Approaching the 1100 metres **AIRWORTHY** had to be steadied off the heels of **SUMMER DALE** (V Gatu) when in restricted room.

Passing the 900 metres **DANCE** (B R Jones) commenced to over-race when being steadied off the heels of **DENTELLE** (M Dee) which shifted in. Apprentice rider M Dee was advised to exercise care in similar circumstances.

SUMMER DALE made brief contact with AIRWORTHY passing the 400 metres.

Passing the 150 metres THEBESTOFYOU (R Smyth) shifted out abruptly under pressure.

Over the concluding stages **SUMMER DALE** raced in restricted room between **THEBESTOFYOU** which continued to shift out and **SO KEEP ME** which shifted in.

When questioned regarding the performance of **DANCE** rider B R Jones advised that after racing keenly in the early stages when becoming awkwardly placed, and he believed **DANCE** had not finished the race off as a result, in testing track conditions.

When questioned regarding the performance of **DENTELLE** apprentice rider M Dee was of the opinion that the filly had failed to handle the existing track conditions.

### Race 5 MONDIALE FREIGHT SERVICES 1200

MR KNOWITALL (V Gatu) began awkwardly.

**CRACKER** (A Jones) began awkwardly and raced ungenerously in the early stages.

**MAGIC BELLE** (Z Moki) was inclined to lay out when placed under pressure in the final straight making contact with **MR KNOWITALL** near the 400 metres, and then shifting out over the final 100 metres again making contact with **MR KNOWITALL**.

ARNOLD (J Wong) shifted out abruptly under pressure passing the 250 metres making contact with CRACKER.

## Race 6 AUCKLAND THOROUGHBRED OWNERS ASSOCIATION 1400

After becoming fractious in the barriers NOTTOOBAD (M Wenn) was slow to begin, losing several lengths.

**LUCKY FEATHER** (B R Jones) raced keenly in the early stages.

**OUI** (R Smyth) returned to the enclosure with blood present in the left nostril. A subsequent veterinary examination revealed a laceration to the near side nostril.

**NOTTOOBAD** (M Wenn) underwent a post-race veterinary examination which could find no obvious abnormality.

# Race 7 NZB INSURANCE PEARL SERIES & NZTR F&M BONUS STAKES RACE

**RIBBONY ROSE** jumped away awkwardly, throwing its head in the air and then raced ungenerously for a distance placing apprentice rider A Jones in difficulty, losing considerable ground as a result. Trainer I George was advised that **RIBBONY ROSE** would be required to barrier trial to the satisfaction of Stewards prior to racing again. Trainer I George advised that **RIBBONY ROSE** was not likely to be persevered with as a racing proposition.

**STELLA** (R Smyth) jumped away awkwardly, shifting in abruptly, crowding **DOUCETTE** (Z Moki) for a distance.

HAYLEY GRACE (D Hain) had to change ground passing the 300 metres to obtain clear running.

## Race 8 WESTBURY STUD KARAKA CLASSIC

WANABEFAMOUS (S Collett) was slow to begin, and was further hampered by PUMP UP THE VOLUME (D Nolan) which shifted in.

RAFA (R Smyth) was slow to begin.

JOHN GRAY (M Sweeney) was inclined to lay in when placed under pressure in the final straight.

When questioned regarding the performance of **SWIPER THE FOX** apprentice rider J Wong advised that **SWIPER THE FOX** had travelled keener than at its previous start through the middle stages, and may prefer looser footing.

C Dell (**BIOLOGIST**) was reprimanded by Stewards for allowing his mount to shift out considerably, hampering **WANABEFAMOUS** when pulling up.

## Race 9 VERSATILE BUILDINGS 2300

LUCKY TONIGHT (M Dee) was slow to begin.

LE BON FIN (M Sweeney) dipped passing the 1000 metres.

**STRAIGHT FURROW** (B R Jones) was held up passing the 600 metres.

**REKA** dipped passing the 450 metres.

Passing the 450 metres **TOP CHOICE** (R Smyth) shifted in, hampering **TEQUILA AT MIDNITE** (A Jones). Contributing was some outward movement from the weakening **HUNTERS CREEK** (A Schwerin). Footage proved inconclusive, with apprentice rider **R Smyth** being reprimanded by Stewards, and further advised a warning would be placed on her record. **LE BON FIN** which was eased down in the straight underwent a post-race veterinary examination which failed to find any obvious abnormalities.

Apprentice rider **M Dee** (LUCKY TONIGHT) was reminded of his obligations with regard to whip use, prior to the 200 metres.
