## RACE COMMENTS:

<b>Race 1</b>	<b>WINDSOR PARK STALLIONS SPRINT</b>
<p><b>ARIBASAN</b> (R Goldsbury) was tightened and lost several lengths at the start when <b>TIGGER TAHNEE</b> (D Bradley) jumped sideways abruptly.</p> <p><b>JUSTLIKEYASISTER</b> (C Grylls) shifted out on jumping hampering <b>BLATHWAYT</b> (J Riddell).</p> <p><b>ETONIAN</b> (U Holmquist) shifted out at the start bumping with <b>FAZED</b> (D Johnson), which lost ground.</p> <p><b>JUSTLIKEYASISTER</b> raced keenly when wide in the early and middle stages.</p> <p><b>ETONIAN</b> raced wide without cover throughout.</p> <p>Following the event the Stewards lodged a Request for a Ruling with the Judicial Committee relating to <b>TIGGER TAHNEE</b> and <b>ARIBASAN</b> being denied a fair start after their starting gates were slow to open. After consideration the Judicial Committee declared <b>TIGGER TAHNEE</b> and <b>ARIBASAN</b> non-starters. Remedial Work was affected to the starting gates prior to race two.</p> <p>When questioned regarding the run of <b>WAJIMA</b> rider M Du Plessis reported that the gelding may prefer a more rain affected track.</p>	

When questioned into the run of **JUSTLIKEYASISTER** rider C Grylls was of the opinion the mare may be better suited to a more rain affected track.

A post-race veterinary inspection of **JUSTLIKEYASISTER** failed to reveal any abnormality.

**Race 2** | **BAY FORD PUNTER OF THE YEAR OCTOBER 4<sup>TH</sup> STAYERS**

**VICEROY** (H Tinsley) shifted out on jumping away dictating **EMPATHY** (R Hutchings) outwards into the line of **BEAU ZED** (D Turner) and **WAIRAKA** (M Coleman) which got back.

**PARTY ICE** (D Bradley) shifted out hampering **O'CEIRINS SECRET** (J Parkes) which got back at the start.

**WAIRAKA** raced keenly in the early and middle stages.

**BEAU ZED** raced four wide from the 1000 metres.

J Parkes was fined \$400 by the Judicial Committee after admitting a breach of Rule 638 (3) (b) in that he used his whip excessively on his mount **O'CEIRINS SECRET** prior to the 200 metres.

**Race 3** | **HAWKE'S BAY RANFURLY SHIELD COUNTRY STAYERS**

C Grylls replaced B Lammas on **MR COOL BOY** due to B Lammas being overweight. B Lammas admitted a resultant breach of Rule 330 (3) (c) and was fined \$200.00

**SAN PEDRO** (S Doyle) shifted out tightening **KIPKEINO** (A Taylor) at the start.

**DARBY SHAW** (S Spratt) when steading near the winning post on the first occasion was placed in restricted room briefly when racing to the inside of **PEREGRINE** (K Myers) which shifted in and away from **ROCKY** (J Riddell).

**ROCKY** raced wide in the early stages.

**RUNNING LATE** (V Colgan) over-raced in the middle stages.

**SAN PEDRO** raced wide in the back straight so was taken forward to lead near the 800 metres.

**JUGGERNAUT ROCK** (M Cameron) was held up early in the home straight prior to being angled out near the 200 metres to improve.

**Race 4** | **HAWKE'S BAY BREEDERS GOLD TRAIL STAKES**

**DIVISSIMA** dislodged rider R Hutchings on the way to the barriers and after being recaptured **DIVISSIMA** underwent a veterinary inspection behind the barriers being passed fit to run.

**LADY ROYALE** (J Parkes) shifted sideways at the start bumping **O'MARILYN** (S Spratt) which lost ground.

**ANUKA** (K Myers) made the first turn awkwardly.

**DIVISSIMA** raced with throughout.

**CHERRY VAIN** (L Innes) shifted inwards early in the home straight.

**O'MARILYN** and **XCUSES XCUSES** (S Doyle) were held up early in the home straight and continued to race in restricted room to the inside of **ANUKA** which shifted inwards slightly. Near the 250 metres **LADY ROYALE** which was weakening lay in towards the running rail and when being corrected by its rider shifted outwards making contact with **XCUSES XCUSES** which was forced on to the hind quarters of **O'MARILYN**. As a result **O'MARILYN** became badly unbalanced and **XCUSES XCUSES** was sharply checked.

**LADY ROYALE** underwent a post-race veterinary examination which failed to reveal any abnormality.

**Race 5** | **AON INSURANCE BROKERS SPRINT**

**LA PUNTA** (S Spratt) was tightened at the start when there was movement from runners either side.

**SIR LANCELOT** (M Du Plessis) shifted out and bumped **WHOOPI GEE** (A Taylor) which was dictated onto the hind quarters of **SING FOR THE SUN** (U Holmquist) at the start.

**RED DAKOTA** (B Lammas) began awkwardly and was slow away.

**MAESTRO TOM** (M Coleman) raced three wide without cover to near the 800 metres.

**GISELA** (D Johnson), **MAYGROVE** (O Bosson) and **SIR LANCELOT** came together and bumped near the 700 metres.

**THEE ACHIEVER** (C Grylls) was forced a little wide approaching the home turn when **ACHOO** (M Cameron) improved to its inside.

**BLAME DE ANGELS** (N Teeluck) had difficulty obtaining clear running for some distance in the final straight.

**THEE ACHIEVER** shifted out near the 200 metres hampering **SIR LANCELOT** and **VEGA** (D Turner) which were improving to its outside.

**LONGBEACH** (L Innes) was held up early in the home straight until the 200 metres.

**Race 6** | **LIVAMOL CLASSIC PRELUDE**

S Spratt replaced R Stam on **ME AROHA**. An investigation was adjourned into this matter.

**ME AROHA** (S Spratt) raced wide throughout.

**ARIZONA JAZZ** (M Du Plessis) lay out under pressure early in the home straight hampering **KARLA BRUNI** (M Dravitzki) for a short distance. M Du Plessis was advised that when in similar circumstances he must straighten his mount sooner than he did on this occasion.

**Race 7** | **STELLA ARTOIS SPRINT**

**FIGURE AGAIN** was a late scratching at 10.08 after sustaining an injury prior to leaving for the race meeting.

**CASINO** was declared a late scratching at the barriers after refusing to load. Trainer G Kenny was advised that **CASINO** must trial prior to next racing.

**TYNE COT** (H Tinsley) was very slow to begin.  
**KAPSBOY** (U Holmquist) got back at the start.  
**ALDEBARAN STAR** (J Riddell) jumped inward at the start bumping with **GUESS WHAT**.  
**TAAXMAN** (K Myers) and **DORIAN GREY** (R Hutching) came together on jumping.  
**CHAMBORD** (M Cameron) was held up early in the home straight prior to be angled out for clear running by the 200 metres.  
**DAME MARGOT** (D Johnson) raced in restricted room near the 200 metres.  
**KUZANOV** (J Parkes) shifted out under pressure over the final stages.  
Following the event stewards lodged a Request for a Ruling with the Judicial Committee relating to **KAPSBOY** and **TYNE COT** being denied a fair start after their starting gates were slow to open. After consideration the Judicial Committee declared **KAPSBOY** and **TYNE COT** non-starters.  
Following this event further remedial work was undertaken on the barriers with them undergoing numerous tests prior to race eight. The Stewards will be following up the matter of today's barrier issues with the relevant authorities.

<b>Race 8</b>	<b>WINDSOR PARK PLATE</b>

**VEYRON** (R Norvall) was slow away and then knuckled losing ground.  
**COSTUME** (M Coleman) was slow away.  
**I DO** (O Bosson) and **SHUKA** (M Du Plessis) began awkwardly.  
**PUSSY O'REILLY** (K Myers) raced with around the first turn.  
**VEYRON** raced keenly throughout.  
**O'FILLE** (N Harris) had to be steadied approaching the first turn when racing in restricted room between **VEYRON** and **I DO**.  
**VEYRON** hung out making the first turn and became awkwardly placed inside the heels of **I DO** having to be firmly restrained and in doing so lost ground.  
**SACRED STAR** (V Colgan) lay in away from **PURE CHAMPION** (C Grylls) passing the 100 metres and bumped with **ZONZA** (L Innes)  
**XANADU** (D Johnson) underwent a veterinary examination after disappointing which did not reveal any abnormality. Trainer K Kelso reported that **XANADU** has been retired.

<b>Race 9</b>	<b>THE WINNING EDGE CUP</b>

**AUTHENTIC PADDY** (R Hannam) bounded at the start and was slow away.  
**GINNER HART** (N Harris) shifted out on jumping away and tightened **ATOZED** (S Spratt) and **WHOSYOURMASTER** (H Tinsley) which lost ground.  
**DAIELLO** (J Parkes) raced keenly in the middle stages.  
**THE FILLY** (N TEELUCK) shifted inwards when being restrained near the 900 metres crowding **KISSES** (M Du Plessis) which when being steadied went back onto **GINNER HART** which became unbalanced making contact with **JUSTANEXCUSE** (D Bradley) which was hampered. **RECITE** (V Colgan) also had to be steadied as a result. Apprentice N Teeluck was issued with a warning. When being corrected by its rider **THE FILLY** shifted outwards abruptly running wide going into the first turn and racing three wide without cover for the remainder of the race.  
**FAIRWAY WISH** (D Johnson) raced three wide.  
**WHOSYOURMASTER** was held up in the early part of the home straight before obtaining clear running until near the 200 metres.  
**JUSTANEXCUSE** was held up for clear racing room throughout the final straight.  
**RECITE** was held up in the early part of the home straight.
