RACE COMMENTS:

Race 1	TE AROHA VETERINARY SERVICES 2200
<p>Shortly after the start SIR AL SYD (R Norvall) shifted out, crowding FEAR OF GOD (S Spratt) on to MANOEUVRE (M Wenn) with FEAR OF GOD losing ground.</p> <p>SIR AL SYD raced three wide without cover before being allowed to improve forward to sit outside the leader near the 1500 metres.</p> <p>ABSOLUTE GEM (S Collett) made the crossing awkwardly approaching the 1450 metres, inconveniencing SIR AL SYD. Rider S Collett defended a breach of Rule 636(1)(d) in that she relaxed her ride near the 75 metres for several strides, when there was a reasonable chance of ABSOLUTE GEM finishing in a better position. After considering submissions the Judicial Committee dismissed the charge.</p>	
Race 2	SHACKELL ELECTRICAL 1600
<p>GEE WHIZ (J Wong) began awkwardly.</p> <p>LITTLE DREAMER (L Magorrian) began awkwardly losing ground (2L).</p> <p>DENIAL (U Holmquist) was held up approaching the 200 metres, shifting out to obtain clear running.</p> <p>LITTLE DREAMER had some difficulty obtaining clear running until passing the 200 metres.</p>	
Race 3	MURRAY & SALLY BARKER 1400
<p>BONGA LADY (C Dell) and JOVAN (P Holmes) came together leaving the barrier.</p>	

Shortly after the start **RESULT MERCHANT** (L Magorrian) shifted in placing **DREIMS OF GOLD** (S Spratt) in restricted room for a short distance.

SPY IN THE HUDDLE (M Wenn) commenced to over-race approaching the 1000 metres having to be restrained off the heels of **RESULT MERCHANT**. **SPY IN THE HUDDLE** then shifted out, making contact with **CHARDON** (J Oliver), which was forced over extra ground. Inconvenienced as a result was **BONGA LADY**. **CHARDON** was then obliged to race three wide without cover.

HEEZA DREIMER (R Smyth) hung out when making the final turn.

R Smyth (**HEEZA DREIMER**) dropped her whip near the 200 metres.

Race 4 | **BIG MICKS UNDERGROUND TAKEAWAYS 1200**

P Mirabelli the trainer of **LAEKEEPER** (R Hutchings) was given permission by Stewards to remove declared gear (ear covers).

FORT STREET DANCER (M Coleman) was slow to begin, and then further hampered.

VERMEER (C Grylls) jumped away awkwardly.

VERMEER commenced to race ungenerously when being restrained in the early stages, and continued to do so through the middle stages.

DAYTIME ROBBERY (L Magorrian) over-raced in the early stages.

EKSUJUE (M Wenn) and **LAEKEEPER** both raced wide without cover.

Approaching the 800 metres **RAISETHESTAKES** (L Satherley) lay out becoming awkwardly placed on the heels of **LAEKEEPER** having to be restrained, losing ground.

DAYTIME ROBBERY shifted out passing the 450 metres to obtain clear running forcing **EKSUJUE** wider on the track.

GRAYSON (M Sweeney) shifted in under pressure making contact with **FORT STREET DANCER** approaching the 200 metres.

Over the concluding stages **OUR DAISY** (M Du Plessis) shifted out slightly with **DAYTIME ROBBERY** shifting away from that runner making contact with the hind quarters of **EKSUJUE**.

Race 5 | **MIKE FRASER-JONES 1200**

MISCONCEIVED (P Holmes) went in the air as the start was effected losing considerable ground. Trainer E Holmes was advised that a warning would be placed against the mare's barrier manners, and further advised that if **MISCONCEIVED** was to perform in a similar manner again she would be required to barrier trial.

J Oliver (**MISS FINNERTY**) dropped his whip approaching the 1000 metres.

BISQUEE (K Leung) raced in restricted room in the early stages to the inside of **ANNAMEIKA** (L Satherley) which commenced to race ungenerously.

DEELIGNA (S Spratt) raced keenly through the middle stages.

Race 6 | **BAYLEYS REAL ESTATE 1400**

TAVAKE (K Leung) was slow away.

DRAW THE LINE (R Hutchings) and **APACHEE TAAT** (U Holmquist) came together leaving the barriers.

Passing the 1000 metres **ANAHEIM** (S Spratt) commenced to race ungenerously when being steadied off the heels of **DRAW THE LINE**. As a result **ZAHCONI** (L Magorrian) which was racing to the inside of **ANAHEIM** then raced in restricted room for a distance and had to steady.

GARDEZ LA FOI (J Oliver) raced keenly in the early stages becoming awkwardly placed on the heels of **APACHEE TAAT** passing the 900 metres.

CURSIVE (D Johnson) shifted out over the concluding stages making contact with **ZAHCONI**.

DRAW THE LINE which was not persevered with in the home straight underwent a subsequent veterinary examination which failed to find any obvious abnormality. Apprentice rider R Hutchings advised that he believed that **DRAW THE LINE** had held its breath during the race which had contributed to the gelding failing to finish the race off.

Race 7 | **DIPROSE MILLER LTD CHARTERED ACCOUNTANTS 1600**

ALL ABOUT FUN (S Collett) was slow away.

IZ (R Hutchings) was inclined to lay in when placed under pressure in the final straight.
