## RACE COMMENTS:

Race 1 ECOLAB 1400

SHE'S A SCREAMER (K Myers) jumped in the air at the start.

JUST ENUFF (L Magorrian) began awkwardly.

**RED ROBYN** (D Johnson) raced keenly through the early stages.

Passing the 800 metres **JUST ENUFF** shifted out when awkwardly placed on the heels of **ROC THAT** (R Hutchings) and inconvenienced **NOT IFFRAID** (C Grylls).

S Spratt the rider of **EYES WIDE SHUT** sustained an injury to the right foot when coming out of the barrier stalls, and was unable to fulfil her remaining riding engagements.

### Race 2 PIC INSURANCE BROKERS 1400

K Joyce the declared rider for **CAILEAG** was unwell and was replaced by R Smyth.

ISTIS LASS (L Satherley) was slow away.

**NULLA CREEK** (B R Jones) began awkwardly.

**TARTAN TWO** (J Oliver) began awkwardly shifting out making contact with **MYSTIC MAN** (D Johnson) and became briefly unbalanced.

**DEELIGNA** (M Sweeney) raced keenly in the early stages.

**DEELIGNA** made the 1100 metre bend awkwardly shifting out making contact with **JOANNA** (L Magorrian).

**CAILEAG** raced wide without cover for the majority of the race.

## Race 3 TE AWAMUTU RSA CLUB 2000

**COX ROAD** (L Satherley) jumped away awkwardly and was further hampered when **CHLOE KEEPER** (S McKay) shifted out with **COX ROAD** losing ground.

**CRUISEO** (M Sweeney) and **LA DORADA** (R Hutchings) were crowded leaving the barriers between **JAYLA MONET** (L Magorrian) and **IZZANORANGE** (J Oliver).

**CHACHI ARCOLA** (D Johnson) raced keenly in the early stages.

Passing the 600 metres CHLOE KEEPER had to be steadied off the heels of ABSOLUTE GEM (U Holmquist).

L Magorrian the declared rider for **JAYLA MONET** was unable to claim any of his allowable allowance and was fined the sum of \$100. As there was no suitable claiming apprentice available L Magorrian was granted permission to ride the filly.

When questioned into the performance of **DESCHABEEL** rider C Grylls was unable to offer any tangible excuse.

## Race 4 NZI INSURANCE 1150

CEDAR ROSE (M Sweeney) and ELY VALLEY (D Johnson) were both slow to begin.

**JEHANNE** (S Collett) raced greenly in the final straight when placed under pressure.

**DAN THE MAN** (Z Moki) made contact with the running rail near the 200 metres when attempting a marginal run to the inside of **SILVER SECRET** (M Wenn).

**SILVER SECRET** shifted out under pressure over the final 100 metres.

**SILVER SECRET** sustained a minor laceration to the off hind leg during the running.

## Race 5 COMMERCIAL HOTEL TE AWAMUTU 1150

TELL THE WORLD (D Johnson), NAUGHTY KNUCKLES (M Wenn) and MISS ELEGANTE (C Grylls) were all slow away.

**HEART OF GRACE** (A Jones) shifted out off heels when racing keenly near the 900 metres forcing **MISS ELEGANTE** wider on the track.

**HEART OF GRACE** ran wide around the bend near the 700 metres.

**LUCOBLU** (M Chui) made contact with the running rail on two occasions in the final straight when being ridden with the whip.

An information was filed requesting a ruling in relation to Rule 648(3) that the rider of **JUSTABOUT READY** (L Magorrian) weighed in 0.6 kg underweight with the gelding being disqualified. Rider L Magorrian was charged under Rule 649(3) for weighing-in light to which he pleaded guilty and was fined the sum of \$300.

## Race 6 EL HERMANO @ CHEVAL STUD 2000

MASTER MICHAEL (J Oliver) was slow away.

**ST RHYTHM** (M Sweeney) jumped away awkwardly and then was further hampered when **COPA VERDE** (J Wong) shifted out leaving the barrier.

**NOTHING** (K Leung) over-raced in the early stages having to be firmly restrained off heels approaching the 1400 metres.

**REKA** (L Satherley) had to steady when becoming awkwardly placed on the heels of **COPA VERDE** near the 800 metres

Approaching the 600 metres **NOTHING** had to be firmly restrained off the heels of **D'LLARO** which was weakening. Passing the 400 metres **D'LLARO** (R Hutchings) was crowded to the inside of **NOTHING** when weakening under pressure.

The connections of **REKA** wished to view the videos as to lodging a protest alleging interference by the horse **TOKOMUTU JUDGE** (C Grylls) near the 800 metres, but after viewing all relevant videos elected not to proceed.

#### Race 7 FREIGHT LINES TE AWAMUTU CUP 2000

**DANZA LAD** (D Hain) over-raced in the early and middle stages.

JOHN GRAY (J Oliver) raced wide until improving forward approaching the 1000 metres to sit outside the leader.

The favourite **WANABEFAMOUS** (R Hutchings) raced mid field, but when placed under pressure approaching the 400 metres was unable to improve and was not persevered with in the final straight. When questioned R Hutchings could offer no reason for the gelding's performance apart from hanging throughout. **WANABEFAMOUS** underwent a post-

race veterinary examination which did not reveal any abnormality.

**JOHN GRAY** lay in under pressure over the final 100 metres.

An information was filed requesting a ruling in relation to Rule 632 as the front gate on the barrier stall of **GURU GIRL** (K Myers) was slow to open with the mare losing ground. After hearing submissions from the connections the Judicial Committee felt that the chances of **GURU GIRL** were affected and declared the mare a non-starter.

### Race 8 VERNON & VAZEY 1580

**SUNBEAM** (A Jones) and **DRAGONKEEPER** (R Smyth) were both crowded on jumping away between **GENDARME** (K Myers) and **CONRWIN** (J Oliver) with **SUNBEAM** the worst affected losing ground.

BELLINO (Z Moki) began awkwardly shifting out making contact with DECORAH (D Johnson).

When crossing over on to the course proper **DRAGONKEEPER** shifted out taking **CONRWIN** out on to **COACHLINE** (V Colgan) with that runner shifting out causing crowding to **BELLINO** which had to steady losing ground.

**DRAGONKEEPER** made the bend near the 1150 metres awkwardly and continued to hang for the remainder of the race.

JOEY MASSINO (S McKay) had to steady off the heels of MAXIMUM HEIGHT (C Grylls) passing the 1000 metres.

Near the 600 metres **GENDARME** shifted out forcing **COACHLINE** out on to **CONRWIN** which had to steady when awkwardly placed on heels.

**DRAGONKEEPER** raced in restricted room over the concluding stages to the inside of **WATTLE BAY** (M Sweeney) which was laying in under pressure. Rider M Sweeney was advised that he must make a greater effort to keep his mounts on a straight line of running.

## Race 9 CAL ISUZU 1400

**CHOCOLAT** (M Sweeney) began awkwardly shifting out abruptly forcing **SUMMER DALE** (J Oliver) out into the line of **ATTICA** (R Hutchings) with that runner losing ground. Also contributing to this was slight inward movement from **TEGWIN** (B R Jones).

**NIGHEAN** (R Smyth) was slow away.

**HAMACHO** (C Grylls) jumped away awkwardly.

MATAKANA (J Wong) raced wide without cover throughout.

**NIGHEAN** was held up rounding the bend into the final straight.

The well supported **TEGWIN** raced disappointingly and underwent a post-race veterinary examination which did not reveal any abnormality. Rider B R Jones said the mare was possibly unsuited by the turning nature of the track.
