<b>Race 1</b>	<b>ECOLAB 1400</b>
<p><b>SHE'S A SCREAMER</b> (K Myers) jumped in the air at the start.</p> <p><b>JUST ENUFF</b> (L Magorrian) began awkwardly.</p> <p><b>RED ROBYN</b> (D Johnson) raced keenly through the early stages.</p> <p>Passing the 800 metres <b>JUST ENUFF</b> shifted out when awkwardly placed on the heels of <b>ROC THAT</b> (R Hutchings) and inconvenienced <b>NOT IFFRAID</b> (C Grylls).</p>	

S Spratt the rider of <b>EYES WIDE SHUT</b> sustained an injury to the right foot when coming out of the barrier stalls, and was unable to fulfil her remaining riding engagements.	
<b>Race 2</b>	<b>PIC INSURANCE BROKERS 1400</b>
<p>K Joyce the declared rider for <b>CAILEAG</b> was unwell and was replaced by R Smyth.</p> <p><b>ISTIS LASS</b> (L Satherley) was slow away.</p> <p><b>NULLA CREEK</b> (B R Jones) began awkwardly.</p> <p><b>TARTAN TWO</b> (J Oliver) began awkwardly shifting out making contact with <b>MYSTIC MAN</b> (D Johnson) and became briefly unbalanced.</p> <p><b>DEELIGNA</b> (M Sweeney) raced keenly in the early stages.</p> <p><b>DEELIGNA</b> made the 1100 metre bend awkwardly shifting out making contact with <b>JOANNA</b> (L Magorrian).</p> <p><b>CAILEAG</b> raced wide without cover for the majority of the race.</p>	
<b>Race 3</b>	<b>TE AWAMUTU RSA CLUB 2000</b>
<p><b>COX ROAD</b> (L Satherley) jumped away awkwardly and was further hampered when <b>CHLOE KEEPER</b> (S McKay) shifted out with <b>COX ROAD</b> losing ground.</p> <p><b>CRUISEO</b> (M Sweeney) and <b>LA DORADA</b> (R Hutchings) were crowded leaving the barriers between <b>JAYLA MONET</b> (L Magorrian) and <b>IZZANORANGE</b> (J Oliver).</p> <p><b>CHACHI ARCOLA</b> (D Johnson) raced keenly in the early stages.</p> <p>Passing the 600 metres <b>CHLOE KEEPER</b> had to be steadied off the heels of <b>ABSOLUTE GEM</b> (U Holmquist).</p> <p>L Magorrian the declared rider for <b>JAYLA MONET</b> was unable to claim any of his allowable allowance and was fined the sum of \$100. As there was no suitable claiming apprentice available L Magorrian was granted permission to ride the filly.</p> <p>When questioned into the performance of <b>DESCHABEEL</b> rider C Grylls was unable to offer any tangible excuse.</p>	
<b>Race 4</b>	<b>NZI INSURANCE 1150</b>
<p><b>CEDAR ROSE</b> (M Sweeney) and <b>ELY VALLEY</b> (D Johnson) were both slow to begin.</p> <p><b>JEHANNE</b> (S Collett) raced greenly in the final straight when placed under pressure.</p> <p><b>DAN THE MAN</b> (Z Moki) made contact with the running rail near the 200 metres when attempting a marginal run to the inside of <b>SILVER SECRET</b> (M Wenn).</p> <p><b>SILVER SECRET</b> shifted out under pressure over the final 100 metres.</p> <p><b>SILVER SECRET</b> sustained a minor laceration to the off hind leg during the running.</p>	
<b>Race 5</b>	<b>COMMERCIAL HOTEL TE AWAMUTU 1150</b>
<p><b>TELL THE WORLD</b> (D Johnson), <b>NAUGHTY KNUCKLES</b> (M Wenn) and <b>MISS ELEGANTE</b> (C Grylls) were all slow away.</p> <p><b>HEART OF GRACE</b> (A Jones) shifted out off heels when racing keenly near the 900 metres forcing <b>MISS ELEGANTE</b> wider on the track.</p> <p><b>HEART OF GRACE</b> ran wide around the bend near the 700 metres.</p> <p><b>LUCOBLU</b> (M Chui) made contact with the running rail on two occasions in the final straight when being ridden with the whip.</p> <p>An information was filed requesting a ruling in relation to Rule 648(3) that the rider of <b>JUSTABOUT READY</b> (L Magorrian) weighed in 0.6 kg underweight with the gelding being disqualified. Rider L Magorrian was charged under Rule 649(3) for weighing-in light to which he pleaded guilty and was fined the sum of \$300.</p>	
<b>Race 6</b>	<b>EL HERMANO @ CHEVAL STUD 2000</b>
<p><b>MASTER MICHAEL</b> (J Oliver) was slow away.</p> <p><b>ST RHYTHM</b> (M Sweeney) jumped away awkwardly and then was further hampered when <b>COPA VERDE</b> (J Wong) shifted out leaving the barrier.</p> <p><b>NOTHING</b> (K Leung) over-raced in the early stages having to be firmly restrained off heels approaching the 1400 metres.</p> <p><b>REKA</b> (L Satherley) had to steady when becoming awkwardly placed on the heels of <b>COPA VERDE</b> near the 800 metres.</p> <p>Approaching the 600 metres <b>NOTHING</b> had to be firmly restrained off the heels of <b>D'LLARO</b> which was weakening.</p> <p>Passing the 400 metres <b>D'LLARO</b> (R Hutchings) was crowded to the inside of <b>NOTHING</b> when weakening under pressure.</p> <p>The connections of <b>REKA</b> wished to view the videos as to lodging a protest alleging interference by the horse <b>TOKOMUTU JUDGE</b> (C Grylls) near the 800 metres, but after viewing all relevant videos elected not to proceed.</p>	
<b>Race 7</b>	<b>FREIGHT LINES TE AWAMUTU CUP 2000</b>
<p><b>DANZA LAD</b> (D Hain) over-raced in the early and middle stages.</p> <p><b>JOHN GRAY</b> (J Oliver) raced wide until improving forward approaching the 1000 metres to sit outside the leader.</p> <p>The favourite <b>WANABEFAMOUS</b> (R Hutchings) raced mid field, but when placed under pressure approaching the 400 metres was unable to improve and was not persevered with in the final straight. When questioned R Hutchings could offer no reason for the gelding's performance apart from hanging throughout. <b>WANABEFAMOUS</b> underwent a post-</p>	

race veterinary examination which did not reveal any abnormality.

**JOHN GRAY** lay in under pressure over the final 100 metres.

An information was filed requesting a ruling in relation to Rule 632 as the front gate on the barrier stall of **GURU GIRL** (K Myers) was slow to open with the mare losing ground. After hearing submissions from the connections the Judicial Committee felt that the chances of **GURU GIRL** were affected and declared the mare a non-starter.

**Race 8**

**VERNON & VAZEY 1580**

**SUNBEAM** (A Jones) and **DRAGONKEEPER** (R Smyth) were both crowded on jumping away between **GENDARME** (K Myers) and **CONRWIN** (J Oliver) with **SUNBEAM** the worst affected losing ground.

**BELLINO** (Z Moki) began awkwardly shifting out making contact with **DECORAH** (D Johnson).

When crossing over on to the course proper **DRAGONKEEPER** shifted out taking **CONRWIN** out on to **COACHLINE** (V Colgan) with that runner shifting out causing crowding to **BELLINO** which had to steady losing ground.

**DRAGONKEEPER** made the bend near the 1150 metres awkwardly and continued to hang for the remainder of the race.

**JOEY MASSINO** (S McKay) had to steady off the heels of **MAXIMUM HEIGHT** (C Grylls) passing the 1000 metres.

Near the 600 metres **GENDARME** shifted out forcing **COACHLINE** out on to **CONRWIN** which had to steady when awkwardly placed on heels.

**DRAGONKEEPER** raced in restricted room over the concluding stages to the inside of **WATTLE BAY** (M Sweeney) which was laying in under pressure. Rider M Sweeney was advised that he must make a greater effort to keep his mounts on a straight line of running.

**Race 9**

**CAL ISUZU 1400**

**CHOCOLAT** (M Sweeney) began awkwardly shifting out abruptly forcing **SUMMER DALE** (J Oliver) out into the line of **ATTICA** (R Hutchings) with that runner losing ground. Also contributing to this was slight inward movement from **TEGWIN** (B R Jones).

**NIGHEAN** (R Smyth) was slow away.

**HAMACHO** (C Grylls) jumped away awkwardly.

**MATAKANA** (J Wong) raced wide without cover throughout.

**NIGHEAN** was held up rounding the bend into the final straight.

The well supported **TEGWIN** raced disappointingly and underwent a post-race veterinary examination which did not reveal any abnormality. Rider B R Jones said the mare was possibly unsuited by the turning nature of the track.
