RACE COMMENTS:

Race 1 JOHNNY NEIL BUILDING LTD MDN (1600m)

BELLE ZED and **PRINCESS PADOZA** were both slow to begin and settled back.

ALAGHERA raced four wide throughout without cover.

PRINCESS PADOZA over raced in the early part and had to be continually steadied for some distance in the back straight. **NYMPH MONTE** and **HEZANAKILAD** raced keenly early.

COUNTDOWN (K Myers) was angled out near the 300 metres when only marginally clear of **HEZANAKILAD** which was steadied. K Myers was advised to exercise care.

Apprentice Jockey **D Turner** (PRINCESS PADOZA) admitted a breach of Rule 638(1)(d) in that he allowed his mount to shift out near the 300 metres when not clear of (BELLE ZED) which was checked. After deliberations the JCA suspended the licence of D Turner to ride in races from the conclusion of racing on 11/10/14 up to and including 18/10/14 (4 days).

Race 2 ANDERSONS PIES (1600m	١)

OUGHT TO BE BAD, AUSTIN ROAD and MISS BENCI were slow to begin.

CALIFORNIA was restrained early when over racing.

AUSTIN ROAD was held up early in the home straight.

BRAD THORN was unable to obtain clear running in the home straight for some distance prior to the final 150 metres. When questioned into the run of **STELLA BELLA** which finished back, rider R Hannam was of the opinion the mare may benefit from the race and may be better suited to a more rain affected going.

Race 3 WEIR BUSES (1600m)

CHINA STAR was slow away.

BLAME DE ANGELS over raced in the early stages and had to be continuously steadied off heels for some distance prior to rider NG Harris easing his mount out into clear running near the 1400 metres, leaving **BLAME DE ANGELS** three wide for the remainder. **DIAMANTINE** had to steady off the heels of **BLAME DE ANGELS** when that runner shifted out.

LUCK AT LAST raced keenly in the back straight and when being steadied off the heels of **HOSTAGE**, shifted out hampering **TORRADO**.

SOUTHERN SECRET raced wide without cover throughout.

RAISEDINASANDPIT hung throughout placing rider M Cameron at a disadvantage. **RAISEDINASANDPIT** underwent a veterinary examination which failed to reveal any abnormality.

M Cameron (RAISEDINASANDPIT) was reminded of his obligations regarding his use of the whip on a horse out of contention.

Trainer G Thomas advised that he would alter the gear on **RAISEDINASANDPIT** prior to its next start. J Morris was advised that a warning is placed against **RAISEDINASANDPIT** with regard to its racing manners.

Race 4 MOLLER JOHNSON LTD (1400m)

The start of this race was delayed as **CASINO** was initially incorrectly loaded. Stewards addressed the Starter regarding this matter.

WEREGOINGTOGETCHA shifted out abruptly at the start dictating **WAIPIPI LAD** outwards into the line of **NORTH AND SOUTH** which lost several lengths. Also affected was **DAME MARGOT** which then commenced to race fiercely and approaching the 1200 metres had to be severely restrained, then clipped a heel of the immediate runner ahead and lost several lengths.

ESQUINA was held up early in the home straight prior to being angled wide to improve.

When questioned into the run of **KUZANOV** rider H Tinsley was of the opinion the gelding is better suited to 1200 metre races at this stage of its preparation.

Following the running of race 4, D Turner advised Stewards that he was feeling the effects of dehydration and after a medical examination by Paramedics was stood down from his remaining rides.

Race 5 AITKEN TRANSPORT 1994 LTD (1200m)

R Myers (PRINCESS LINCOLN) had to steady off the heels of MR INK when that runner lugged inwards towards the end of the back straight prior to be corrected.

ETERNITY raced four wide without cover throughout.

M Sweeney reported that his mount **SHE'S SLINKY** was coughing on pulling up. A subsequent veterinary examination revealed respiratory distress consistent with having swallowed a clod.

Race 6 EGMONT TYRES (2100m)

PARTY ICE was fractious in the barrier and then slow to begin.

D Bradley reported that **PARTY ICE** got its tongue over the bit during the running.

KING OF ROCK was slow away.

LASSWADE raced three wide without cover throughout.

KING OF ROCK raced four wide without cover throughout.

S Doyle was issued with a warning under Rule 638(1)(d) after he allowed his mount to shift in near the post on the first round when not the required distance clear of **LES SYLPHIDES**.

FAST PROFIT was held up briefly prior to entering the home straight.

Near the 200 metres **LES SYLPHIDES** when being steadied off the heels of the tiring **LASSWADE** shifted in simultaneously as **ITSALLBELT** was being angled out. This resulted in **LES SYLPHIDES** clipping the heel of **ITSALLBELT**, the incident was considered accidental.

When questioned into the run of **BEAU ZED**, which finished well back, rider M Dee could offer no tangible excuse. A post race veterinary examination failed to reveal any abnormality.

Race 7 KAPONGA HOTEL EGMONT CUP (2200m)

PERMESSO was caught wide in the early stages.

ETHICAL was under pressure passing the 700 metres and failed to finish the race off as expected. Rider V Colgan was of the opinion the mare is better suited to more rain affected going.

DELICIANO pulled the off front plate during the running.

Race 8 RICH HILL STUD TARANAKI BREEDERS STAKES – Group III (1400m)

PUSSY O'REILLY jumped inwards at the start and checked MAROTIRI MISS which settled back.

QUEENS ROSE began awkwardly and then had to be steadied when crowded a short distance further.

POSTMAN'S DAUGHTER raced three wide without cover throughout.

BETTER KEEPER was held up for some distance early in the home straight prior to being angled out passing the 200 metres to improve.

AMBERIO was held up briefly on entering the home straight.

When questioned into the improved performance of the winner **THE FILLY** which failed over 1200 metres at its previous start at Hastings, Trainer M Neal advised **THE FILLY** raced in restricted room at Hastings and is also better suited to 1400 metres.

Rider V Colgan reported that **PUSSY O'REILLY** failed to run on to any extent and was of the opinion the mare may be feeling the effects of recent racing.

QUEENS ROSE disappointed finishing last. Rider N Harris was of the opinion that the mare is better suited to more rain affected going

A subsequent veterinary inspection of **QUEENS ROSE** did not reveal any abnormality.

Race 9 SOUTH TARANAKI CLUB (1400m)

SINGLE MISSION jumped out at the start checking **THORN PASS** which settled back.

INTUITIVE hung throughout placing rider M Sweeney at a disadvantage. M Sweeney reported that the gelding did have a tendancy to hang in its races and it may be better suited to right handed racing.

SHADOW PLAYER raced keenly when wide without cover in the back straight.

COOLANGATTA over raced in the back straight and rounding the final turn.
