RACE COMMENTS:

Race 1	HAWKE'S BAY NEW YEARS DAY RACES MAIDEN
ZARTAN (B Lammas) began awkwardly and was slow away. NGAWAKA (J Riddell) raced keenly in the early stages and had little left in the straight, finishing well back. Rider J Riddell had no excuse for the gelding's poor performance. TALLEMOSA (K Myers) and HAWKEYE CHIEF (R Goldsbury) bumped near the 1600 metres. SPEED KING (S Doyle) was allowed to improve forward from its rear position in the back straight in an attempt to make the lead but was unable to do, so was then parked three wide from the 800 metres. When questioned rider S Doyle said his riding instructions were to settle the gelding back in its first start over ground, but on entering the back straight SPEED KING commenced to over-race so he elected to improve forward. COOL HAND DUKE (L Magorrian) raced in restricted room in the home straight prior to gaining a run near the 200 metres.	
Race 2	THE ROBYN MACTAGGART CUP
STRAIGHT AHEAD (B Lammas) was slow away. VICEROY (N Teeluck) had to be steadied off the heels of CASINO JACK (L Magorrian) near the post on the first round and in doing so bumped with MISSTEEFLYING (K Myers).	

SPIKE MILLIGAN (R Hannam) raced keenly in the early and middle stages and had to be continuously steadied rounding the first turn.

VICEROY after being three wide early was taken forward to lead near the 1000 metres.

ZCASTLE raced in restricted room in the home straight. Rider K Smith stated the gelding was feeling the Good 3 track. Rider K Myers stated that **MISSTEEFLYING** which finished back may not have backed up from racing the previous Tuesday. D Bradley (**SATAY**) admitted a breach of [Rule 638(1)(d)] in that he allowed his mount to shift inwards shortly after the start when not clear of **SAVAROSE** (R Goldsbury) which clipped the heels of **SATAY** and blundered. After deliberations D Bradley has his licence to ride in races suspended by the JCA from the close of racing on Saturday 15th November up to and including Sunday 23rd November (4 days)

Race 3 | **STELLA ARTOIS MAIDEN SPRINT**

LADY ZAFIRA (S Doyle) was inclined to lug out rounding the home turn.

SKYWARDS (S Collett) was momentarily held up early in the home straight.

RON'S LAST (B Lammas) was unable to take advantage of a narrow run near the 250 metres and had to be momentarily steadied.

PLATINUM EMPIRE (J Parkes) shifted in under pressure near the 250 metres hampering **QUEENOFHARPZ** (M Dravitzki). Rider J Parkes was advised that he is expected to straighten his mount sooner than he did on this occasion.

Race 4 | **THE NOW NAKED BROADBAND SPRINT**

ALL'S FAIR (J Parkes) bumped with **ABSOLUTELY SACRED** (R Myers) when attempting a run near the 500 metres.

GOLAN EXPRESS (M Dravitzki) was held up early in the home straight and had to change ground outwards passing the 200 metres to obtain clear running.

J Parkes was of the opinion ALLS FAIR may be better suited to a longer distance.

Race 5 | **TWILIGHT XMAS AT THE RACES DEC 11TH MAIDEN**

PRIORITISE (M Hills) blundered on jumping away and got back. **PRIORITISE** returned to the enclosure with an injury requiring veterinary attention to its near hind consistent with hitting the gate on leaving the barrier.

INDISCRETION (B Lammas) was slow away.

R Goldsbury (**COASTAL HIEGHTS**) was shown footage of her ride, in particular over the early stages after having angled her mount out sharply near the 1500 metres hampering **MONGOLIAN HERO** (V Colgan) and **LUCQUIDE** (J Parkes).

VOXER (J Riddell) was held up for some distance rounding the turn and early home straight prior to gaining a run near the 200 metres.

MONGOLIAN HERO was held up shortly after entering the home straight but when asked for an effort failed to produce to any extent. Rider V Colgan could offer no excuse. A subsequent veterinary inspection did not reveal any abnormality.

Race 6 | **TRINITY HILL HANDICAP SPRINT**

PEARLS (M Dravitzki) began awkwardly.

BIDDABLE (S Collett) was slow away.

Race 7 | **THE LIVAMOL MAIDEN**

ZIPIT (D Bradley) and **A RED PRINCE** (J Parkes) were slow away.

FREELINKS (R Hannam) raced three wide without cover from the 800 metres.

A RED PRINCE was unable to improve when placed under pressure approaching the home turn. Rider J Parkes was of the opinion that the colt may improve with the addition of blinkers to its gear.

Race 8 | **"GREAT THINGS GROW HERE" SPRINT**

DARTING (S Collett) shifted out abruptly at the start resulting in **SOVIET SONG** (V Colgan) being forced wider.

TANSAVA (M Dravitzki) and **WAIT A SEC** (J Parkes) were slow to begin and settled back.

LINCOLN STREET (J Riddell) raced three wide without cover.

ARIBASAN (S Doyle) raced fiercely throughout and had little left at the finish.

ARIBASAN underwent a subsequent veterinary inspection which did not reveal any abnormality.

LINCOLN STREET appeared short in its action on pulling up. Rider J Riddell was of the opinion that something may be amiss with the gelding. A subsequent veterinary inspection revealed lameness in the near fore. Connections were advised that a clearance would be required prior to racing next. Connections advised that **LINCOLN STREET** would be spelled.
