RACE COMMENTS:

Race 1	MILLS REEF WINERY & RESTAURANT 1600
<p>EZRA (L Satherley) began awkwardly before being further hampered by OUR MYSTERE (S Collett) which shifted in.</p> <p>MORENA (B R Jones) began awkwardly before being further hampered when crowded between ALTAI ROSE (M Sweeney) and PANAMBA (R Smyth) when both those runners shifted ground.</p> <p>EZRA was steadied when racing in restricted room near the 1250 metres.</p> <p>PANAMBA had to be restrained to avoid the heels of CHEVAL ETOILE (J Riddell) which shifted inwards near the 1100 metres when not fully clear. J Riddell was issued with a warning. BEAUTY GIANT (M Coleman) had to be steadied to avoid the heels of PANAMBA as a result.</p> <p>SPY IN THE HUDDLE (C Dell) over-raced having to be firmly restrained off heels approaching the 1000 metres.</p> <p>MORENA was unable to obtain clear running in the final straight until near the 100 metres.</p> <p>EZRA required veterinary attention following the race to a laceration above the left eye.</p> <p>A charge of careless riding against L Satherley was found proven, in that she permitted her mount EZRA to shift outwards near the 150 metres when not sufficiently clear resulting in interference to OUR MYSTERE, MORENA, FOOTSIE (L Cropp) and REBISHA (M Dee) which was checked. After hearing submissions L Satherley was suspended by the Judicial Committee from the conclusion of racing on Saturday 22 November until the conclusion of racing on Friday 28 November, 4 riding</p>	

days.	
Race 2	ORICA 1600
<p>QUICKASUCAN (M Dee) was slow away. NOTHING TRIVIAL (J Riddell) was held up for a distance passing the 400 metres.</p>	
Race 3	O'CONNOR WARREN INSURANCE BROKERS 3YO
<p>BUFFALO BOY (U Holmquist) was slow away. Passing the 800 metres BUFFALO BOY reacted poorly when being steadied after being placed in restricted room to the inside of THEE AULD FLOOZIE (M Coleman) which lay inwards away from PASSING SHOT (J Riddell). SAOIRSE (B R Jones) and SMASHING (C Lammas) over-raced through the middle stages. SMASHING lay out rounding the final turn crowding SAOIRSE, which was also inclined to lay out away from SMASHING, resulting in SAOIRSE being steadied passing the 400 metres. WAY IN was eased down over the concluding stages with rider L Cropp advising that the filly had felt indifferent in its action. A post-race veterinary examination did not reveal any obvious abnormality. Following this race the track was downgraded to Dead(6).</p>	
Race 4	KONING WEBSTER LAWYERS TAURANGA 1200
<p>IRISH MOON (M Coleman) was slow away before being further hampered by EVEREADY (J Oliver) which had begun awkwardly shifting inwards. IRISH ENCORE (C Lammas) began awkwardly shifting outwards making contact with HADDON HALL (M Dee) which lost ground. ALVESTA (S McKay) and MATIMBA (B R Jones) which were both slow away, had to steady shortly after jumping away when crowded to the inside of SALAMANCA (J Riddell). FIFTYSHADESOFGREY commenced to over-race passing the 1000 metres, and when being restrained shifted outwards simultaneously as SO IT GOES (L Satherley) shifted inwards before being corrected by its rider. As a result ALVESTA raced in restricted room. SO IT GOES raced wide without cover. SPEECH CRAFT (D Turner) had some difficulty obtaining clear running until near the 200 metres.</p>	
Race 5	SEA CONTAINERS NZ LTD 1400
<p>OHOPE PRINCE (S Collett) began awkwardly. AGENT ZIVA (L Cropp) over-raced in the early and middle stages when wide without cover. NEEDLly (C Lammas) was held up near the 250 metres when OHOPE PRINCE lay in. TRAVEL WISE (M Dee) was also held up at that point of the race. When improving to the outside of ONE COOL MESSAGE (M Coleman), NEEDLly was taken out by that runner briefly inconveniencing OHOPE PRINCE approaching the 100 metres. When questioned regarding the performance of AGENT ZIVA rider L Cropp stated that although travelling wide during the running she had been disappointed in the manner in which the mare had finished the race off. A post-race veterinary examination did not reveal any abnormality.</p>	
Race 6	STELLA ARTOIS TAURANGA STAKES
<p>SHANDREAM (C Lammas) began awkwardly shifting inwards making firm contact with FAY FAY (M Sweeney). VEYRON (R Norvall) began awkwardly losing ground. SURVIVED (M Coleman) over-raced in the early stages. JULINSKY PRINCE (S Collett) ducked outwards crossing the junction on to the course proper passing the 1500 metres. I DO (J Riddell) raced three wide without cover. FAY FAY lay in under pressure in the final straight hampering ZENNISTA (M Dee) near the 150 metres. M Sweeney was issued with a warning. VEYRON returned to scale with a laceration to the near hind leg. M Coleman reported that his mount SURVIVED failed to handle the existing track conditions. SURVIVED underwent a post-race veterinary examination which found the gelding to be mildly lame in the right hind leg with trainer Ms K Burne being advised that a veterinary certificate of fitness will be required prior to SURVIVED racing next.</p>	
Race 7	PACIFIC COAST TECHNICAL INSTITUTE 1300
<p>BARNIE O'MARNIE (D Turner) was slow away. Near the 1000 metres EDITH PIAF (C Lammas) and BARNIE O'MARNIE raced in restricted room to the inside of UNDISCOVERED (B Hutton) which lay in. TINDER (J Riddell) raced three wide without cover throughout. AIRWORTHY (C Dell) shifted ground under pressure early in the final straight shifting inwards abruptly towards the running rail near the 250 metres. PRINCESS NICOLE (U Holmquist) shifted outwards under pressure in the final straight taking UNDISCOVERED wider on the track. Apprentice Holmquist was advised that she must stop riding and straighten her mount in future. A post-race veterinary examination of TINDER did not reveal any abnormalities.</p>	

Race 8	CORSON DENTAL 1600
<p>THE AUSTRIAN OAK (J Riddell) began awkwardly shifting inwards making firm contact with DAHLS DELIGHT (R Norvall) which became briefly unbalanced.</p> <p>CAST KING (B R Jones) stumbled on jumping away shifting in further hampering THE AUSTRIAN OAK, and when being corrected shifted out making contact with KATORIE (L Satherley) with that runner being crowded losing ground.</p> <p>SIR SUNNY (D Turner) began awkwardly.</p> <p>Shortly after jumping away PANNO ROSSA (L Cropp) had to steady when awkwardly placed on the heels of IMAGUNAKEPA (S McKay) which shifted in.</p> <p>CAST KING over-raced in the early and middle stages.</p> <p>DAHLS DELIGHT over-raced when being restrained near the 1200 metres.</p> <p>GRAYSON (M Sweeney) raced three wide without cover.</p> <p>MONS CALPE (R Smyth) was held up rounding the final turn.</p> <p>DAHLS DELIGHT shifted outwards to obtain clear running near the 400 metres inconveniencing THE AUSTRIAN OAK.</p> <p>DAHLS DELIGHT shifted outwards under pressure inconveniencing IMAGUNAKEPA near the 250 metres. R Norvall was advised to exercise more care.</p> <p>B R Jones advised that his mount CAST KING failed to handle today's track conditions.</p> <p>When questioned regarding the performance of THE AUSTRIAN OAK rider J Riddell advised that the gelding had every chance in the running but after being confident of its chances rounding the final turn the gelding had failed to finish the race of as anticipated and was unable to offer any excuses.</p>	
Race 9	GILMOURS TAURANGA 2100
<p>Trainer Mr B Foote was fined \$50 after presenting CORNELIUS (J Riddell) with incorrect gear.</p> <p>HIACE (B Hutton) began awkwardly shifting outwards crowding TAKE CHARGE (L Cropp).</p> <p>LE BON FIN (M Dee) began awkwardly losing ground.</p> <p>AUGUSTA NATIONAL (M Sweeney) had to be steadied when crowded to the inside of HIACE which shifted inwards shortly after jumping away.</p> <p>HIACE raced ungenerously when being restrained making the first turn near the 1700 metres becoming awkwardly placed on the heels of ALFONZE (C Lammas).</p> <p>LADY LE FAY (M Coleman) raced wide without cover throughout.</p> <p>CORNELIUS lay out under pressure bumping with LETMEBY (S Collett) on a number of occasions approaching the 200 metres.</p> <p>ALFONZE was briefly steadied when racing in restricted room passing the 200 metres.</p> <p>When questioned regarding the performance of PRICKLEY PRINCESS rider J Oliver was of the opinion that the mare may be feeling the effects of recent racing.</p>
