### SUPPLEMENTARY:

#### Winning Edge Presentations Hawke's Bay Gold Cup – 18 April 2015

A charge of excessive use of the whip against Apprentice Jockey **K Chiong (BLATHWAYT)** which had been adjourned the previous Saturday was concluded with **K Chiong** admitting a breach of Rule 638 (3) (b) and being fined the sum of \$500.

### Energy City Cabs Highweight 2000 – Taranaki on 2 April 2015

A careless riding charge against Jockey N Quinn which had been adjourned from 2 April was concluded today. It was alleged by the stewards that N Quinn (**BILLY ELLIOT**) angled his mount outwards passing the 700 metres when not clear of **SONTANA** (S Fannin) dictating that runner outwards across the heels of **CANDYBELLE** (T Harris). **SONTANA** then clipped the heels of **CANDYBELLE** and fell dislodging Rider S Fannin. After deliberations the charge was found proved and N Quinn had his licence to ride in races suspended from the conclusion of racing on 23 April through to the conclusion of racing on 17 May.

#### **RACE COMMENTS:**

Race 1	LOWE SCHOLLUM & JONES MAIDEN 1360	
BOKKA shifted out on jumping away and hampered CALL DOUBT which got back.		

A short distance after the start **CENTURION** shifted outwards resulting in **JACKSSTAR** being tightened.

**CALL DOUBT** jumped the crossing in the back straight unbalancing the rider.

**HUNDYAMONTH** commenced to over-race towards the end of the back straight and had to be restrained for some distance.

**JO SO FINE** had to be steadied off heels near the 700 metres when racing fiercely then shifted out abruptly to avoid the heels of **HEATWAVE** and in doing so dictated **BOKKA** wider on the track.

JO SO FINE shifted out under pressure passing the 100 metres and bumped with THANQUE.

SUCHAPALAVA raced in restricted room near the finish when shifting in across the heels of HUNDYAMONTH.

# Race 2 FIBER FRESH 1360

**OLIVIA MARY** was declared a late scratching after the trainer experienced transportation difficulties.

AWESOME DIVA after being fractious in the gates was slow away.

**BRUNNHILDA** (L Allpress) hung outwards throughout and near the first bend shifted out hampering **GREY GURU** which in turn bumped with **DON'STOPGIRL**. L Allpress reported that **BRUNNHILDA** hung throughout and proved a difficult ride. **BRUNNHILDA** was not persevered with in the home straight.

**IMA TUI GIRL** raced wide throughout.

**GREY GURU** raced in restricted room for a short distance near the home turn.

**SILK BELT** (R Hannam) was under pressure some distance out and finished last. When questioned, R Hannam had no tangible excuse. A subsequent veterinary inspection revealed **SILK BELT** to have a slow recovery rate with an elevated heart rate but no other clinical signs.

# Race 3 NZB INSURANCE PEARL SERIES RACE 1200

Near the end of the back straight **SHEZAKIWI** (L Hemi) had to be checked when **TRANKY DOO** was momentarily dictated inwards by **SILVER SHADOW** (K Myers) which rolled in on the point of the 800 metre bend. After questioning riders, Rider K Myers was advised to exercise care when in similar circumstances.

## Race 4 KEVIN MYERS STABLES MAIDEN HIGHWEIGHT 2060

NO ESCAPE began awkwardly and then was tightened at the start.

**COUNTDOWN** was slow away.

**COUNTDOWN** had to steady off heels going into the back straight.

**PERFECTLY RED** raced three-wide without cover throughout.

**Riders E Farr (AUTHENTIC)** and **N Quinn (COUNTDOWN)** were given a warning with regard to their respective use of the whip prior to the 200 metres.

# Race 5 LISA LATTA RACING STABLES R65 & JUMPERS HIGHWEIGHT 2060

**TIZZA SECRET** was tightened at the start when **MACKLEMORE** jumped inwards, resulting in **TIZZA SECRET** settling back. **BALLY HEIGHTS** was tightened at the start and got back.

IN FOR FUN raced in restricted room near the post on the first round.

Rider E Farr (YORKIE) was spoken to regarding her use of the whip on a runner out of contention.

**EMPIRE LASS** lost the near hind plate during the running.

THE BIG OPAL lost the near fore plate during the running.

**C Perrett (SIR GONZALES)** defended a charge under Rule 636 (1) (d) in that he failed to ride his mount out fully to the finish and was beaten into fourth placing by half a head. After deliberations the allegation was found proved and C Perrett had his licence to ride in races suspended from the conclusion of racing on 23 April up to and including the conclusion of racing on 14 May.

# Race 6 NIKKI MARSHALL RACING STABLES 2060

KINGS COURT jumped inwards abruptly hampering TEDDYTWINKLETOES which settled back.

PIRINITETE raced three-wide from near the 800 metres.

When questioned into the disappointing run of **KINGS COURT** (L Hemi) which gave ground near the 600 metres and finished in last placing, Rider L Hemi advised she felt the gelding was unsuited to today's track conditions.

### Race 7 TINA EGAN RACING 1600

Shortly after the start **SELWYN** had to be steadied when **YARDSTICK** shifted out.

# Approaching the first turn **KATIE MCKEEN** shifted in making contact with **NANCYLEE**.

# Race 8 WESTMERE BULK SPREADING MAIDEN 1600

WEE BISKIT was slow away.

**COTTA PIN** had to be steadied off the heels of **LUAS** near the crossing in the back straight.

ZARTAN shifted out and bumped PERFECT PITCH near the 400 metres.
