<u>Race 1 – Speight's Ale House Handicap</u>

Trainer T Riddell advised Stewards that IFFWEDANCE, which had a slow recovery rate after its previous start at Awapuni on 10 April 2015 requiring veterinary attention, had undergone further tests. These resulted in blood, temperature and heart rate respectively being clear with a recommendation from the veterinary surgeon that the gelding was fit for racing.

RACE COMMENTS:

Race 1 GERMINAL SEEDS / DANNEVIRKE DAIRY SERVICES 2200 (2200 metres)

JUST ISHI and TIM came together on jumping.

RACQUETOR began very awkwardly and shifted in, making heavy contact with **DUMINY**. **DUMINY** then lay out on to **RACQUETOR**, which was forced out on to the hind quarters of **MR MOR**, which became unbalanced. **MCCULLEY** shifted out at the start and lost ground.

DUMINY raced wide rounding the first turn.

ROODYVOO lay out when being taken into clear running near the 250 metres, dictating **MR MOR** wider.

Race 2 MOTORCYCLE HQ / PROPERTY BROKERS PAHIATUA 2100 (2100 metres)

MA BELLE KATE shifted out at the start bumping with **WINDERMERE LAD**. **PUTTHEHAMMERDOWN** and **FIXATES** began awkwardly.

CAN COUP and **LUCQUIDE** were slow away.

MA BELLE KATE commenced to over-race passing the 1800 metres and had to be restrained off heels for some distance.

CAN COUP over-raced in the home straight on the first occasion and made the first corner awkwardly. **FIXATES** hit the rail near the 1600 metres becoming unbalanced.

Race 3 AFFCO NEW ZEALAND / MACDOUGALLS METRIC MILE (1600 metres)

DUAL AGENT was slow to begin.

PAY THE FOX lay in shortly after leaving the barriers, which resulted in crowding to **PHOENIX TYCOON** which lost ground. **ALL GINGA** commenced to lose ground shortly after leaving the barriers and lost contact with the field in the middle stages. Trainer D Fuge was advised that a warning has been placed against **ALL GINGA** with respect to its competitiveness. **TIME FOR GOLD** hung out approaching the first turn and made the corner awkwardly.

PAY THE FOX raced three wide without cover throughout.

DOING TIME (A Kuru) lay out under pressure in the final straight and near the 100 metres shifted out bumping with JED **CLAMPETT** (N Quinn), which became unbalanced and lost momentum. Immediately following the event Stewards filed a protest with the Judicial Committee alleging interference by the second placed **DOING TIME** against third placed JED **CLAMPETT**. After consideration the Judicial Committee upheld the protest. Stewards issued rider A Kuru with a warning in that while **DOING TIME** had shied away from a vehicle parked on the inside track, he should have taken corrective action sooner than he did on this occasion.

NZB INSURANCE PEARL SERIES RACE (1600 metres)

DUMONT was declared a late scratching at 2.13pm after being found to be lame in the left hind upon arrival at the barriers. Connections were advised that a veterinary clearance is required prior to its next start.

SHE KNOWS jumped in abruptly at the start badly hampering **TARIHIRA**, which lost ground.

Both LADY OF LEID, and THE DUKE'S SECRET were slow to begin.

THE DUKE'S SECRET raced three wide without cover throughout.

SANS LE PAIR raced keenly in the middle stages.

LINCOLN'S SUNSET lay out under pressure throughout the final straight.

LADY OF LEID was denied a narrow run to the inside of **SOMEKA** near the 200 metres and had to be steadied and shift out to make its finishing run.

KEEP US HAPPY was inclined to lay out under pressure over the final 200 metres.

KEEP US HAPPY was noticeably lame on cooling down post-race, requiring veterinary attention.

Race 5 FARMLANDS / FMG / TARARUA HELIWORK DASH (1200 metres)

ME AROHA was a late scratching by Stewards at 2.50pm after refusing to parade.

STEEL ROSE jumped out abruptly at the start bumping heavily with WRITTEN COMMAND, which lost ground.

JUMP FOR JOY raced without cover throughout.

HOT IN PINK was held up for several strides entering the final straight.

Race 6 PAHIATUA TRAVEL CENTRE / BEALE TRUCKING DASH (1200 metres)

MISS GAIETY was slow in the early stages.

CENTURION began awkwardly, was slow in the early stages, settling well back.

DAN CUGAT got its head up when being steadied in the early stages.

LAQUIANTE gave ground quickly near the 600 metres becoming tailed off, however over the final stages responded to hard riding and ran on fairly.

JEWEL OF THE NAKI was not persevered with in the home straight. Rider J Parkes advised Stewards that the filly felt sore in its action. A subsequent veterinary inspection revealed the filly to be mildly lame in the left foreleg.

BAMBRY'S WATER TREADMILL WOODVILLE-PAHIATUA CUP (2100 metres)

PROLOGUE, DECORUM and **THE POSTIE** were all slow to begin. **THE POSTIE** then commenced to over-race and jumped the crossing near the 1700 metres, running wide and losing ground. **THE POSTIE** continued to hang out and lost its footing momentarily.

ITSALLBELT over-raced in the early stages.

LORD CASANOVA raced wide round the first turn.

DECORUM raced wide from the 1200 metres.

SOUTHERN SECRET was held up in the early part of final straight.

Following the race, **DECORUM** returned to the birdcage minus the off front plate.

Race 8 HOFFMAN FORD / KEINZLEY AGVET / POWER FARMING MANAWATU SPRING (1400 metres)

HEATWAVE was a late scratching at 1.10pm on veterinary advice after suffering an injury in the tie-up area. **GERARDASUN** was a late scratching at 4.35pm on veterinary advice after dislodging rider J Riddell in the preliminary and sustaining a cut to a leg requiring treatment.

OUR SPICE shifted out abruptly on jumping, bumping heavily with **TIME'S SQUARE.**

ROCKY RIDE over-raced in the early stages.

J Shackleton (OUR SPICE) admitted a breach of Rule 638(1)(d) in that she angled her mount outwards near the 700 metres when not clear of VISTA DEL MAR, which was checked. After submissions Miss Shackleton had her licence to ride in races suspended from the conclusion of racing on Thursday, 23 April 2015 up to and including racing on Thursday, 7 May 2015 (4 days).

TIME'S SQUARE was inclined to shift outwards in the home straight.

Over the concluding stages **MAC DARA** shifted inwards and away from **EXPEDITE** and tightened **TIME'S SQUARE** near the finish.
