RACE COMMENTS:

Race 1 BALLANCE / MATAHIWI ESTATE MAIDEN

 $\textbf{KINGIESSTAR (R Hannam)} \ jumped \ away \ awkwardly.$

HEADS WILL ROLL (L Allpress) raced keenly in the early and middle stages when being restrained.

CRYSTAL SECRET (R Myers) raced greenly when placed under pressure in the final straight.

Race 2 PER INCANTO@LITTLE AVONDALE MAIDEN 3YO

KINGOFPLATINUM (J Riddell) and DUMONT (K Smith) were slow to begin.

GOOD GRACE (R Myers) began awkwardly and lost ground.

PAUA EYES was held up entering the home straight and near the 250 metres rider **M Dravitzki** lost the use of her offside rein for a short distance.

DAYTIME ROBBERY (R Goldsbury) shifted out under pressure passing the 200 metres forcing **KINGOFPLATINUM** wider on the track.

Race 3 LVN WOOLBUYERS RATING 65

SHEZENTHUSIASTIC (M Dravitzki) blundered badly as the gates opened settling back as a result.

DAME WYNNIE (J Shackleton) was crowded leaving the barriers between **GOODSPEED (R Goldsbury)** and **FANCY NANCY (R Hannam)** which jumped inward.

GOODSPEED raced three-wide without cover throughout.

BALLYBAY (J Riddell) raced keenly in the middle stages and was then momentarily held up near the 250 metres prior to

being angled inwards to obtain clear running.

OUR DELIGHT (L Allpress) which led into the straight, hung outwards throughout the home straight placing the rider at a disadvantage.

GOODSPEED shifted out under pressure in the run down the home straight.

Race 4 STIHL SHOP MAIDEN

DOCKET (J Riddell) hung outwards abruptly leaving the barriers hampering **PERRAN BEACH (R Myers) and SHANKLY (J Parkes)** with **PERRAN BEACH** losing ground.

LYKABETTUS (M Dravitzki) was slow to begin.

SHANKLY raced keenly in the early stages and near the 1100 metres had to steady when awkwardly placed near the heels of **DOCKET.**

WHOOPSIE (R Goldsbury) raced four-wide without cover throughout.

Near the 500 metres **RIO RAPIDO (S Doyle)** had to steady off the heels of the rapidly retreating **WHOOPSIE** (**R Goldsbury**) and as a result lost several lengths.

Following the event the connections of the 1st placed dead heater **SHANKLY (J Parkes)** lodged a protest against the codead heater **BRILLIANTE BRIGITTE (K Myers)** alleging interference near the finish. After hearing all submissions and viewing the films of the incident the JCA determined that whilst contact had been made between **BRILLANTE BRIGITTE** and **SHANKLY** it was considered there was movement from both runners and there was insufficient evidence that this affected the chances of **SHANKLY** winning the race outright so dismissed the protest accordingly.

Race 5 FAGAN MOTORS LTD

DENLEE (J Riddell) blundered leaving the barriers and shifted inwards crowding ERIC THE VIKING (C O'Beirne).

Race 6 KURIPUNI SPORTS BAR MASTERTON CUP

EVEN BETTER (D Bradley) shifted out and away from **RE DEEL (R Myers)** which began awkwardly and bumped with **FREDRICK WILLIAM (R Hannam)**

CROCODILE CANYON (K Myers) had to be steadied shortly after the start when awkwardly placed near the heels of **VOLKSWOOD (M Hills).**

RE DEEL commenced to over-race passing the post on the first occasion and made the bend near the 1800 metres awkwardly.

KOHI ROAD (C O'Beirne) raced fiercely rounding the first bend having to be firmly restrained off the heels of **FREDRICK WILLIAM.**

CROCODILE CANYON was held up entering

the home straight then shifted outwards near the 200 metres to obtain clear running.

THE BEAMA was held up near the 250 metres prior to being angled outwards to obtain clear running.

Rider J Parkes reported that WEISSMULLER failed to see out the 2050 metres of the event.

R Myers had no **e**xcuses for the performance of **RE DEEL** which failed to finish the race off as expected. Trainer **P Lock** said the gelding would now be spelled.

Race 7 TUI BACKING A WINNER SINCE 1889 RATING 65

WAIT A SEC (J Parkes) and I'LLBEYOURPLATINUM (D Bradley) were slow away.

PHOENIX TYCOON (K Myers) and JOBY (J Riddell) were held up for some distance near the 400 metres.

When questioned into the performance of WAIT A SEC which had finished last at its previous start at Otaki on 21 February, co-trainer **G Lowry** said the gelding took natural improvement with that run and was better suited to the Good 3 track today.
