RACE COMMENTS:

Race 1 NZB INSURANCE PEARL SERIES RACE 2YO

THE CZAR was a late scratching at 12.35pm after dislodging rider **J Riddell** during the preliminary and proving very difficult to recapture. **J Riddell** was uninjured. As a result the start of the race was delayed 11 minutes.

IN ANOTHER LIFE (D Bradley) was slow to begin and settled back.

IN ANOTHER LIFE then commenced to over-race going into the first turn.

IN ANOTHER LIFE galloped up onto the heels of **GOBSTOPPER (H Tinsley)** approaching the home turn so was shifted out abruptly and in doing so bumped **PETITE MIDAS (M McNab)** which was dictated wider on the track.

Following this event the track was upgraded to a Good 3.

Race 2

HAWKE'S BAY BREEDERS AND OWNERS ASSOCIATIONS SPRINT

LADY ZAFIRA (S Doyle) began awkwardly unbalancing the rider.

DR PAUL (C **O'Beirne**) raced three wide rounding the home turn.

WILD ROCK (R Goldsbury) raced keenly in the early stages.

LADY ZAFIRA raced greenly in the home straight and was inclined to shy away from the inside hoardings on the inside track over the final stages, having to be straightened off the heels of **STUNNING PRINCESS** (**D Bradley**) when that runner shifted in marginally near the post.

Race 3

THE STELLA ARTOIS MILE

IRION (D Bradley) raced keenly in the lead throughout.

GIARDINI (K Myers) shifted in under pressure near the 200 metre mark hampering **BERG EN DAL (M McNab)** which then had to shift ground outwards to improve.

The connections of the 5th placed **BERG EN DAL** lodged a protest against the 4th placed **GIARDINI** alleging interference near the 200 metres. The JCA upheld the protest and placings now read 2-3-6-7-4-5.

K Myers was issued with a warning and reminded of her obligation to straighten her mount sooner than she did on this occasion.

Race 4

PER INCANTO AT LA STUD SPRINT

MATO GROSSO (R Hannam) was held up for a short distance passing the 500 metres and then again early in the home straight so was angled inwards near the 200 metres to continue to improve.

Race 5

HAWKE'S BAY RACING MEMBERS SPRINT MAIDEN

KEEN TEMPO (M McNelis) lost ground at the start after jumping away awkwardly.

OBLIVION raced keenly in the early and middle stages.

KEEN TEMPO raced keenly in the early stages and near the 700 metres had to be steadied off heels for some distance. Over the final stages **THIEN LY (H Tinsley)** shifted in under hard riding when not clear of **SPREADEAGLED** which was checked. Connection of the 4th placed **SPREADEAGLED** viewed footage of the incident with a view to lodging an objection against the winner **THIEN LY** but elected not to proceed. **H Tinsley** defended a charge of careless riding under Rule 638 (1) (d). After deliberations the charge was found proved and H Tinsley had his jockey's licence suspended from the conclusion of racing day until the conclusion of racing on Wednesday 11 March 2015 (5 days).

B Lammas advised stewards he had aggravated an existing shoulder injury during this event so was stood down from his remaining engagements.

Race 6

THE HITS 89.5FM SPRINT

ISHIGOLD (M McNab) jumped inwards sharply as **BALLYBAY (J Riddell)** jumped outward at the start resulting in tightening to **AL PACINO (J Parkes)** and **PETITE BRIGITTE (K Myers).**

BALLYBAY raced keenly in the early and middle stages.

BALLYBAY was held up early in the home straight and was unable to obtain clear running until near the 200 metres then bumped with **DON'T CHANGE (H Tinsley)** when racing in restricted room near the 150 metres.

H Tinsley reported that DON'T CHANGE would benefit from the run.

C Lammas (ZEDETTA) was warned with regard to his whip use on a horse out of contention.

Race 7

LITTLE AVONDALE LOWLAND STAKES - GpIII

SAFFIRE and **MARY QUANT** were late scratchings at 2.30pm on veterinary advice after both runners travelling together became injured en route to the meeting. Connections were advised that a veterinary clearance will be required for **SAFFIRE**.

TASHA AIMEE (S Doyle) began awkwardly.

HAYLEY ANN (S Wynne) made the first bend awkwardly.

PIPI BEEL (J Riddell) changed stride and shifted out when racing greenly near the 300 metres.

CHOICE (J Parkes) had to be steadied near the 300 metres when MASSOFDASH (C Lammas) shifted in.

PIPI BEEL and DREAM RUN (K Myers) bumped near the finish line.

Race 8

THE www.hawkesbayracing.co.nz "GET OUT" HANDICP

PERRY MASON was hampered by **LOVE ME MOORE** near the 600 metres when **LOVE ME MOORE** shifted in when the rider had limited control

PAIGE ME (H Tinsley) was held up for some distance in the home straight until over the final 200 metres Approaching the 200 metres PERONI (K Myers) was angled outwards sharply in search of clear running and in doing so dictated PERRY MASON (K Smith), LE'VANTOS (P Holmes) and RED SUNSET (L Allpress) outwards over extra ground which resulted in the rider of RED SUNSET having to take a hold of her mount.

K Myers defended a subsequent charge of careless riding under Rule 638 (1) (d) and after deliberations the JCA found the charge not proved.

The saddle on **LOVE ME MOORE (R Goldsbury)** slipped forward near the 1800 metres placing the rider in difficulty for the remainder of the event.

L Satherley reported that the fast early tempo proved detrimental to the chances of **SKYBIRD**. Stewards ordered a post-race veterinary examination which did not reveal any abnormality.
