GENERAL:

Due to a delay in communication between Trainer B Revell and the NZTR Bureau both TWIST AND TURN (race 4) and BORNTHISWAY (race 5) were scratched at approximately 7.50am race morning.

J Riddell advised Stewards that he was unwell and would not be attending and was replaced in race 5 (GIFTED LAD) by M Cameron. J Riddell was advised that he is to supply a clearance prior to his riding next.

It was brought to the attention of the Stewards at approximately 5pm that some media publications had BORNTOACHIEVE, the winner of race 3, as being scratched. Follow-up investigations will be made by the RIU as to how the error occurred.

Race 1	BROUGHAM HEIGHTS MAIDEN 2000M

TEQUILA SUNRISE was tightened and got back at the start when **CHONNEY** jumped inwards abruptly, simultaneously as **HEZANAKILAD** shifted out.

MAKE BIG was obliged to race three wide without cover rounding the first bend.

PHONE GIRL raced three wide without cover from approximately near the 1200 metres.

Near the 700 metres **HEZANAKILAD** when seeking to improve off the rail bumped for several strides with **MAKE BIG**.

CHONNEY was held up for a short distance near the 400 metres.

TASHA AIMEE when placed under pressure near the 800 metres failed to respond, dropped away and finished last. Rider M Cameron could offer no tangible excuse for the filly's poor performance. A post race veterinary inspection revealed the filly to have suffered from cardiac arrhythmia. Stable representative G Barlow was advised that **TASHA AIMEE** must trial with a veterinary certificate of fitness required prior to racing next.

Race 2 BOOF FLEMING MEMORIAL MAIDEN 1600M

PENTATHLON began awkwardly losing ground.
SONSY blundered leaving the barriers.
UNCLE SAM was steadied when racing in restricted room shortly after the start.
ASHWINI hung outwards making the first turn near the 1400 metres taking **PURREAL** over extra ground.
ANY STREAM WILL DO also ran wide rounding the first turn.
ASHWINI continued to hang outwards throughout.
ANY STREAM WILL DO raced three wide without cover.
SONSY was held up rounding the final turn and did not obtain clear running in the straight until inside the final 100 metres and when being angled into a run, bumped with **ETOILE D'ANGE**.

Race 3 FOWLER HOMES MAIDEN 1100M

EMPIRE LASS began awkwardly.
ISOLA BELLA had to steady off the heels of **GOT THE SNITZ** passing the 1000 metres.
ISOLA BELLA was held up on the home turn and when being angled outwards into clear running dictated **LOUVRES** outwards into the line of **KAHUI LAD** which was steadied. After questioning riders it was established that **WHEELER FORTUNE** which was improving to the inside of **ISOLA BELLA** contributed to the movement when shifting outwards as **ISOLA BELLA** was improving.
EMPIRE LASS lay out near the 1000 metres and was then obliged to race wide for the remainder.
Over the final stages **ISOLA BELLA** shifted out under pressure dictating **LOUVRES** wider on the track.

Race 4 NZB INSURANCE PEARL SERIES 1200M

The left hind plate on the **THELIONZSHADOW** became displaced in the tie up stalls having to be removed. The plate was unable to be reapplied with **THELIONZSHADOW** being permitted to run without the plate.
WILLBEOKAY began awkwardly losing ground.
THELIONZSHADOW began awkwardly before being further hampered by **BOUNTIFUL** which shifted outwards jumping away.
When questioned, rider J Parkes was unable to offer any excuses for the poor performance of **MOJO**. Trainer Mr R Patterson advised that in his opinion the mare would benefit from today's race day experience and may be better suited over more ground.

Race 5 JOHN EAGAR MEMORIAL MAIDEN 1400M

GIFTED LAD began awkwardly and got back.
ESTER lost its footing and blundered at the start.
MALINA shifted in and bumped **STREET WARS** at the crossing in the back straight.
TINGED WITH GOLD raced three wide without cover throughout.
CALL DOUBT which finished a long last underwent a veterinary inspection which did not reveal any abnormality.

Race 6 NULOOK ALUMINIUM & DOORS 1400M

Apprentice Jockey D Turner in the presence of his employer P Bourke, requested a ruling under Rule 330(2)(4) claiming that he was engaged to ride **SECONDS OUT** and seeking the appropriate riding fees from connections. After hearing submissions from all parties, the Judicial committee did not find in Mr Turner's favour and his application was declined.
POROTENE CHANCE and **RIVER HEAD** were both crowded leaving the barriers.
SECONDS OUT began awkwardly hampering **WAITINO BISCUIT**.
GO GO GONZO was crowded at the start.
MISS DAISY raced keenly through the middle stages.
MISS DAISY lay in under pressure in the home straight.

Race 7 LAMBERTS BUSINESS CENTRE 1800M

DUCHESSOFCAMBRIDGE began awkwardly then settled back.
CAPINSKY made the first turn awkwardly passing the winning post on the first occasion and shifted out hampering **NORTH OF SUNSET**, which had to be steadied.
REGALO REAAL raced wide throughout.

NORTH OF SUNSET lugged outwards in the back straight.

KING NERO was held up for some distance in the home straight prior to gaining clear running near the 200 metres.

DIAMANTINE lay in under pressure near the 200 metres

and bumped with **NORTH OF SUNSET** prior to being straightened.

When questioned into the run of **CAPINSKY** rider D Johnson had no real excuse for the disappointing run.

Race 8

LANDMARK HOMES 1800M

MENDOZA was slow away.

STORM HOME shifted inwards jumping away crowding **PADDY JO** on to **OUTOFTIME** and **ROCKY EXPRESS**.

REGAL RANGER was hampered at the start losing ground.

CHEEKY BOY was held up rounding the final turn and continued to be held up in the final straight, until shifting outwards across heels to obtain clear running near the 150 metres.

When questioned regarding the performance of **LOU SEA** rider D Bradley stated the mare had raced wide throughout and was unable to finish the race off as a result.
