RACE COMMENTS:

Race 1	VAUTRON GROUP 1200
IFFLEY ROAD lent heavily on the side of its gate as the start was made and began awkwardly. STACCATO after racing keenly in the early stages was inclined to lay out under pressure in the home straight.	
Race 2	SUPPORTERS 2YO
GREAT EXPECTATIONS shifted outward abruptly leaving the barriers, bumping with SCAGLIONI which shifted outwards simultaneously as OUR ROKKII shifted inwards. This resulted in LOLLA LEE LOU being tightened losing ground. MARGRET JOY was slow to begin. SPECIAL MEMORIES got its head up in the early stages when being restrained. MARGRET JOY raced three wide without cover throughout. OUR ROKKII had to be steadied passing the 600 metres when becoming awkwardly placed on the heels of NAKI GIRL .	
Race 3	LFF NEW ZEALAND 3YO
CAVALRY began very awkwardly losing considerable ground. When questioned, rider B Lammas could offer no explanation regarding its awkwardness. Connections were advised that a warning would be placed against CAVALRY for the gelding's barrier manners. BIDDIE WALKER over raced for a distance in the early stages and had to be restrained off the heels of PEAK PERFORMER	

near the 1000 metres.

STAIRWAY hung inwards under pressure in the home straight and had to be straightened near the 100 metres.

Rider R Myers had no excuse for the disappointing performance of **BIDDIE WALKER** which finished well back.

Race 4	CHAIN RESOURCES MDN F&M

AMAYA commenced to buck shortly after the start being pulled up rider M Cropp. Connections were advised that **AMAYA** must trial on two separate occasions to the satisfaction of Stewards prior to racing next.

PIER ELEVEN began awkwardly and was slow away.

LADY ANNALEE was slow to begin.

MIDNIGHTCHICADEORO jumped inwards and made contact with the side of its gate at the start.

THELIONZSHADOW shifted out on the turn dictating **CORTISAN** and **LADY ANNALEE** wider on the track.

TWISTANDTURN raced in restricted room for the majority of the home straight.

OUTOFTIME was slow to begin.

WAITINO BISCUIT bumped with **THE POSTIE** when seeking a run near the 600 metres.

BRECON GROSV had to steady off the heels of the tiring **LYKAROC** near the 400 metres.

M Cameron (KOHI ROAD) admitted a breach of Rule 638(3)(b) in that he used his whip excessively prior to the 200 metres.

The JCA imposed a fine of \$350.

Race 6	SUPPORTING SPECIAL OLYMPICS NORTH TARANAKI MDN

ASTRA returned to the enclosure with blood present in a nostril consistent with having hit the front of the gate which a veterinary inspection confirmed.

MASTER PATRICK was slow away.

DANASONIC shifted out abruptly on jumping away and tightened **WHEELER FORTUNE**.

HOT SHOT LASS raced three wide in the early stages.

MASTER PATRICK ran wide rounding the turn.

Race 7	SPIERS WIRELINE PATHWAY

HIGH SOCIETY jumped inwards leaving the barriers bumping **DEO VOLENTE** which in turned bumped **SIR LANCELOT** on to **SECONDS OUT**.

SEALED BY A DANCE and **SHEZASTUNNA** both stumbled leaving the barriers.

SIR LANCELOT raced keenly going into the first bend and had to steady off the heels of **DEO VOLENTE**. **SIR LANCELOT**

continued to race keenly through the middle stages so was then angled wide to avoid heels near the 900 metres. A subsequent veterinary examination revealed **SIR LANCELOT** to have pulled up in a normal post race condition.

SECONDS OUT was briefly held up passing the 400 metres.

ATTIVAREE was held up rounding the turn and early part of the home straight so had to be taken wide to improve.

When questioned into the run of **LANDLORD** rider J Riddell stated he had got further back than intended and was unable to improve his position when required.

Race 8	SAT FEB 14th HOOKER PACIFIC TARANAKI CUP 1400

CAUGHT BEHIND dislodged rider D Turner and galloped some distance to the stabling area. Stewards declared the gelding a late scratching at 7.25pm.

PACHENKO and **TEXAS YELLOW ROSE** came together and bumped leaving the barriers.

WILLBEOKAY was slow to begin.

PACHENKO and **TEXAS YELLOW ROSE** both over raced going into the first bend.

WILLBEOKAY raced three wide without cover until near the 800 metres.

R Hutchings admitted a breach of careless riding under Rule 638(1)(d) in that he angled his mount **BERG EN DAL** outwards near the 250 metres, when not clear of **OUR GIRL KATE** (L Allpress) which was checked and forced outwards on to

WILLBEOKAY, which was also checked. Stewards consented to a request by Mr Hutchings to have the hearing adjourned to a later date due to travel commitments.
