# AUCKLAND RACING CLUB – Friday 26th December 2014

### Race 9 - Zabeel Classic

In concluding their inquiries into an incident near the 450 metres where **NOBLE WARRIOR** was crowded on to **ABIDEWITHME** the Stewards accepted the evidence of N Harris that when shifting outwards to obtain clear running his mount **PONDAROSA MISS** had over-reacted and lay out badly then becoming badly unbalanced making contact with **NOBLE WARRIOR**. N Harris was advised to exercise care when shifting ground in future.

# AUCKLAND RACING CLUB – Sunday 14th December 2014

### <u> Race 3 – Mayfair Village 2YO</u>

The Stewards concluded their inquiries into a check received by **OUTLAW KATE** (J Wong) near the 900 metres. With film footage and evidence heard being inconclusive no further action is being taken regarding the incident.

#### **RACE COMMENTS:**

 Race 1
 The New Zealand Herald 2100

 TOFINO (M Coleman) became fractious in the barriers and was removed undergoing a veterinary inspection and was declared a late scratching at 1.16pm as it had suffered a number of lacerations to the legs. Co-trainer Mr G Rogerson

advised that TOFINO was now likely to be spelled.

REBEL ROSE (V Colgan) began awkwardly.

**CHENILLE** (R Hutchings) stumbled on jumping away.

**REBEL ROSE** got its head up when being restrained making the bend awkwardly passing the 1800 metres.

**ZAVIERA** (L Innes) over-raced in the early stages when three wide and then got into a position passing the 1400 metres. **CHENILLE** lay out under pressure over the final 100 metres.

Race 2 Mainstream Plumbing & Gasfitting 1400

MEESKA MOOSKA (M Cameron) was crowded on jumping away between DENNIS DENUTO (O Bosson) and SEIZE THE MOMENT (J McDonald). SEIZE THE MOMENT then lay out further crowding CASTLE RIDGE (L Satherley) and DENNIS DENUTO. Contributing was inward movement from CIVETTA (S Collett). The worst affected was CASTLE RIDGE which lost ground.

**SONIC JET** (V Colgan) was held up near the 200 metres when awkwardly near the heels of **ARROW IN THE SAND** (M Coleman).

When questioned regarding the run of **DENNIS DENUTO** Rider O Bosson reported that the gelding had over-raced throughout and felt indifferent in its action. The Stewards ordered a veterinary examination of **DENNIS DENUTO** which revealed no abnormalities.

Race 3 Barneswood Farm Eclipse Stakes

**IFF SO HAPPENS** was a late scratching at 12.25pm after being injured en route to the meeting.

**VEGAS FLING** (M Du Plessis) jumped in the air at the start losing ground and then was further hampered when **MARITIMO** (D Johnson) shifted in.

**BATTLE TIME** (S Spratt) was slow away and then was crowded shortly after by outward movement from **JACQUETTA** (C Johnson).

WINDBORNE (M Cameron) and ROCANTO (J McDonald) came together shortly after jumping away.

**CHINA SILK** (M Coleman) raced wide without cover throughout and near the 800 metres hung out and raced wider on the track for a short distance.

**SHOWBOY** (J Riddell) and **MARITIMO** both raced in restricted room to the inside of **JACQUETTA** for a distance passing the 1000 metres.

**WINDBORNE** got its head up when being restrained to trail passing the 900 metres and in doing so came back on to **SHOWBOY** which had to steady in consequence.

WINDBORNE was held up passing the 600 metres until near the 400 metres.

**SHOWBOY** was held up passing the 400 metres and had to be taken wide near the 200 metres to obtain clear running. When questioned regarding the run of **JACQUETTA** Rider C Johnson reported that the filly was inclined to over-race in the early stages and when pressured passing the 400 metres had failed to respond and was disappointing.

# Race 4 2014/15 Dunstan Feeds Championship Final

**R Hutchings** was unable to make the contracted weight for **HEISTHEONE** as a result of having to take on fluids after becoming dehydrated following his ride in Race 1. Given all the circumstances, including that Apprentice Hutchings had ridden at the identical weight in race 1 the Stewards determined no further action necessary.

UNDISCOVERED (C Grylls) knuckled badly on jumping away losing ground.

ROCK DIVA (L Innes) was slow away.

**SMEDLEY** (L Magorrian) began awkwardly losing ground.

**MANGAROA FLO JO** (M Cameron) was crowded for a distance shortly after the start when to the inside of **CURSIVE** (D Johnson) which shifted in.

AUSTIN ROAD (J Parkes) over-raced throughout.

HEISTHEONE (V Colgan) and COLONEL CARRERA (O Bosson) both raced wide rounding the first turn.

MANGAROA FLO JO raced wide without cover from the 1600 metres.

**UNDISCOVERED** had to steady passing the 1400 metres when awkwardly near the heels of **JIMMY HOFFA** (S McKay) which shifted in to obtain a position adjacent to the rail. Apprentice S McKay was issued with a warning and told that he must maintain full clearance when shifting ground.

**PROUD LIFE** (S Collett) over-raced in the middle stages.

**DUBAI SHUFFLE** (N Harris) over-raced in the middle stages and near the 1200 metres had to be steadied away from the heels of **ROCK DIVA**.

**CURSIVE** shifted out under hard riding over the final stages making contact with **AWESOME GOAL** (C Johnson) passing the 50 metres.

Race 5 New Zealand Bloodstock Royal Stakes

VAVASOUR (L Innes) and CONSENSUS (C Johnson) both began awkwardly.

THEE AULD FLOOZIE (M Coleman) was slow away.

PALACE ROCK (D Johnson) was slow away and was further crowded when VAVASOUR shifted out.

**STOLEN DANCE** (J McDonald) began awkwardly.

**STOLEN DANCE** was tightened and checked near the 1800 metres when inside **DE KENSINGTON OVAL** (J Riddell) which shifted in when not clear. J Riddell admitted a resultant charge of careless riding and after consideration the Judicial Committee suspended his license to ride in races from the conclusion of racing on 5 January 2015 up to and including racing on 15 January 2015, 6 riding days.

**BOHEMIAN LILY** (M Du Plessis) was placed in restricted room and compelled to steady passing the 1800 metres when inside **ORANGE PEEL** (R Hutchings) which lay in.

**CHARMONT** (O Bosson) raced wide without cover rounding the first turn.

**DARCI'S DREAM** (M Cameron) made the bend near the 1500 metres awkwardly when over-racing and shifted out taking **CONSENSUS** over extra ground. **CONSENSUS** then raced three wide without cover for the remainder.

VAVASOUR over-raced in the middle stages.

**STOLEN DANCE** gave ground passing the 700 metres and was eased down with Rider J McDonald reporting that he felt there was something amiss with the filly. The Stewards ordered a veterinary examination of **STOLEN DANCE** which revealed no abnormalities.

ATTENTION SEEKER (J Parkes) hung outwards badly rounding the final turn running wide forcing CHARMONT, CONSENSUS and VAVASOUR over extra ground.

**SAAVOYA** (C Grylls) shifted in under pressure approaching the 300 metres resulting in the trailing **DE KENSINGTON OVAL** contacting the heels of **SAAVOYA** and falling. **EZRA** (L Satherley) which was immediately in behind **DE KENSINGTON OVAL** was bought down in consequence. Affected in this incident was **DARCI'S DREAM** which was severely hampered, almost falling and losing its chance. **PALACE ROCK** (D Johnson) was also badly hampered and was not persevered with thereafter. Riders J Riddell and L Satherley were examined by the Course Doctor and cleared fit to continue with their riding engagements. Rider C Grylls admitted a resultant charge of careless riding in that he had permitted **SAAVOYA** to shift in

when not clear. After consideration the Judicial Committee suspended C Grylls licence to ride in races from the conclusion of racing on Saturday 3<sup>rd</sup> January up to and including racing on Saturday 31<sup>st</sup> January 2015 – 18 days. In addition a fine of \$1,000.00 was imposed.

CONSENSUS was inconvenienced near the 250 metres when inside VAVASOUR which lay in.

**CONSENSUS** lay in under pressure over the final 200 metres.

**OUTSPOKEN** (N Harris) lay out under pressure over the final 200 metres.

Race 6 The Sound Great Northern Guineas

**NO TRICKS** (D Johnson) began awkwardly shifting in crowding **KOLONEL KEV** (J Riddell) which lost ground.

MARGIN TRADER (L Innes) began awkwardly losing ground.

JET TRAC (M Du Plessis) began awkwardly shifting in making contact with THE DEPOSIT (L Magorrian).

**THE DEPOSIT** commenced to race fiercely shortly after leaving the barriers and had to be restrained off heels for some distance.

**SHERPA** (BR Jones) raced keenly in the middle stages.

NO TRICKS over-raced in the middle stages.

LISTOWEL (C Grylls) was crowded when weakening passing the 200 metres.

Race 7 Rich Hill Mile

**C Johnson** the declared rider for **ZAH GIRL** was unable to make the weight and was replaced by S Spratt. C Johnson admitted a breach of Rule 330(3)(c) and was fined the sum of \$225.

**CAPONE** (C Grylls) jumped in the air at the start.

ATACAMA (J McDonald) and COSTUME (M Coleman) were both slow away.

**KALEIDOSCOPE** (M Du Plessis) commenced to race fiercely shortly after leaving the barriers having to be restrained off heels for some distance. **KALEIDOSCOPE** was then crowded near the 1300 metres when inside **CANDLE IN THE WIND** (K Myers) which was taken in when **SPIN DOCTOR** (R Hutchings) shifted in. After questioning riders concerned it was determined that while **SPIN DOCTOR** had shifted ground the racing manners of **KALEIDOSCOPE** had contributed significantly to this incident. Nonetheless Apprentice R Hutchings was issued with a warning in relation to shifting ground. **KALEIDOSCOPE** continued to race fiercely shifting out near the 1200 metres hampering **CAPONE**. **WAIKAHA** (M Dee) raced wide from the 800 metres.

**TO BE SURE** was held up passing the 400 metres and only obtained clear running until passing the 200 metres.

Race 8 Sistema Railway Stakes

**TREPIDATION** (N Harris), **WHOSYOURMASTER** (R Hutchings) and **MOSSE** (J McDonald) were slow away. **GIG** (K Myers) began awkwardly, shifting out making contact with **RYAN MARK** (M Coleman) losing ground. O'MARILYN (S Spratt) was steadied when leading approaching the 1000 metres which resulted in SILVER ECLIPSE (C Johnson) having to be steadied away from the heels of O'MARILYN with the trailing MOSSE, WHOSYOURMASTER, TREPIDATION and PINZAARA (S Collett) all having to be restrained for some distance. Stewards opened and adjourned an investigation into Miss Spratt slowing the speed at this point of the race.

**DURHAM TOWN** (O Bosson) raced wide rounding the first turn and was taken forward to lead near the 800 metres. O'MARILYN raced in restricted room to the inside of IN STYLE (L Innes) and HANNAH MARY (L Magorrian) near the 800 metres.

HANNAH MARY raced wide without cover throughout.

**TREPIDATION** was held up passing the 500 metres until near the 300 metres.

WHOSYOURMASTER was held up passing the 500 metres until near the 300 metres.

PINZAARA was held up from the 450 metres to the 300 metres.

O'MARILYN shifted out to obtain clear running near the 250 metres and bumped SILVER ECLIPSE.

PINZAARA was crowded passing the 200 metres when inside WHOSYOURMASTER which, when racing greenly, shifted in.

 Race 9
 Scot Thrust City of Auckland Cup

SCINTILLULA (M Coleman) began awkwardly and lost ground.

DELAGO'S SECRET (D Johnson) dipped on jumping and lost ground.

MALCOLM (N Harris) began awkwardly and lost ground.

**DUQUESA** (M Cameron) was tightened near the 2200 metres when inside **DEANE MARTIN** (J Riddell) which shifted in. An investigation into this matter was adjourned. **DUQUESA** then over-raced for a distance.

**RE DEEL** (T Thornton) was crowded near the 2000 metres when inside **DEANE MARTIN** which was crowded inward.

KING KROVANH (L Innes) over-raced in the early stages.

LION RED (BR Jones) raced wide without cover from the 1600 metres.

MALCOLM raced wide rounding the first turn before obtaining the lead near the 1600 metres.

PERFECT START (S Spratt) and SECRET'S ONLY (K Myers) were held up rounding the turn.

**DECORAH** (C Grylls) was badly held up rounding the final turn behind the weakening **MALCOLM**.

was held up rounding the final turn.

**THE FIRE INSIDE** clipped a heel of **LOVES THE SHOW** (S Collett) near the 400 metres and blundered, dislodging Rider M McNab who was attended to by St John's personnel and transferred to Auckland Hospital for further assessment. **DEANE MARTIN** (J Riddell) which was directly in behind was severely hampered and lost its chance. **DECORAH, RE DEEL** and

**PERFECT START** were all badly hampered by the riderless **THE FIRE INSIDE** and the weakening **MALCOLM** early in the final straight. After questioning Riders J Parkes and S Collett into the incident the matter was adjourned until evidence could be taken from M McNab.

SURPASS (O Bosson) had difficulty obtaining clear running over the final stages.

SURPASS lay out over the final stages and brushed with DELAGO'S SECRET near the post.

Race 10 Lindauer Mile

**STELLA'S HONOUR** was a late scratching at 3.25pm after sustaining an injury en-route to the race meeting.

SO IT GOES (L Magorrian) was crowded when leaving the barriers losing ground.

ZABERTO (M Du Plessis) was slow to begin.

**BINGO** (D Johnson) was crowded approaching the 1200 metres when inside **DUFELLFORTE** (C Johnson) which when overracing shifted in and away from **GENIUS** (M Cameron).

**PROCUREMENT** (J McDonald) raced wide without cover throughout.

**BINGO** was taken wider passing the 350 metres when **GUSTAVO** (O Bosson) shifted out to obtain clear running. **REVELATOR** (R Hutchings) raced in restricted room over the final 200 metres.
