GORE RACING CLUB @ GORE - SATURDAY 17TH JANUARY 2015 Race 8 – Liquorland Gore Guineas Trainer L Didham reported to the Stewards that KING KAHUNA had undergone a subsequent veterinary examination on return to his stable which revealed the gelding to be shin sore. Mr Didham advised that KING KAHUNA would now be sent for a spell.

RACE COMMENTS:

Race 1	PETERS GENETICS & GRANT FARMING PARTNERSHIP MAIDEN (1200M)
DISCUSSING FLAGS and TWIZEL GURU were both slow to begin. ALL THINGS NICE was crowded at the start and lost momentum when runners either side shifted ground. WILD WINGS bounded at the start. TWIZEL GURU raced greenly throughout the race and lay out on the final bend running very wide on the track. The connections were advised the gelding would have to trial to the Stewards satisfaction on one occasion prior to racing next. Co-trainer B Anderton advised that TWIZEL GURU would now be sent for a spell prior to resuming racing. MISS DOLLY raced wide through the early stages. FINAL WAVE blundered and made contact with the running rail passing the 800 metres. Passing the 750 metres CARMODY had to be steadied when racing keenly and then had to shift out off the heels of SINGLE SPICE taking WILD WINGS and THOUGHT THAT wider on the track.	

COULEE lay out throughout the final straight and passing the 50 metres became awkwardly placed on the heels of **KOFFEE 'N' KREAM** and had to steady in the shadows of the post.

Following this event rider **L Callaway** (CARMODY) could not draw his correct weight. L Callaway admitted a breach of Rule 649(3) and after hearing evidence from Mr Callaway, Mr K Wood (Clerk of the Scales) and the Stewards the JCA imposed a fine of \$100. **CARMODY** was subsequently disqualified from seventh placing pursuant to Rule 648(3).

When questioned regarding the performance of favourite **COULEE** rider S Muniandy advised that after leading early then taking a trail the filly was flat thereafter and he could offer no further explanation.

When questioned regarding the performance of favoured runner **FINAL WAVE** apprentice rider G Jogoo advised that after getting further back than intended he had been held up on the final bend and had battled on fairly over the concluding stages.

Race 2 HOKONUI SUZUKI HANDICAP (1335M)

HIGH RISE raced keenly through the early and middle stages.

NEWS FLASH was held up early in the run home only gaining clear racing room inside the final 150 metres.

When questioned regarding the performance of **GALLANT DAN** apprentice rider C Barnes advised the gelding had found the track indifferent in patches which had not suited its racing style.

When questioned regarding the performance of favoured runner **DUNOON** rider K Williams advised the mare had hung at various stages throughout the running and had found the track conditions shifty in places. Miss Williams added in her opinion **DUNOON** had not handled today's track conditions.

When spoken to regarding the apparent improved performance of **HIGH RISE** stable representative Mrs D Gibson advised the Stewards that the gelding had benefitted from the drop back in class and distance of today's race after starting in the Open race over 2000 metres at Gore the previous Saturday.

Race 3 JOHN BRICK MEMORIAL MAIDEN (1335M)

GOLD NUGGET was slow to begin.

SATIN GURU was hampered and lost ground when **ADDED** shifted in abruptly shortly after the start.

THE FASCINATOR raced wide through the early and middle stages.

ADDED raced wide throughout.

DUN EDEN was held up for several strides passing the 400 metres.

NAUGHTY BARBIE locked on one rein and ran off on the home turn and could not be persevered with over the concluding stages. The connections of the mare were advised **NAUGHTY BARBIE** must trial to the Stewards satisfaction on one occasion prior to racing next. Trainer A Borthwick advised the Stewards he would now be sending **NAUGHTY BARBIE** for a spell and would trial the mare prior to resuming racing.

When questioned regarding the performance of favourite **SATIN GURU** rider S Muniandy advised the Stewards that after getting back in the early stages had battled on fairly over the concluding stages. Mr Muniandy added in his opinion the mare may now be looking for more ground.

When questioned regarding the performance of favoured runner **ADDED** apprentice rider T Direen advised the mare had been trapped wide throughout and this had taken its toll over the final stages.

When spoken to regarding the apparent improved performance of **FLAGRANTE DELICTO** trainer K Tyler advised the gelding had been working well in the lead up, had been improved by recent racing experiences and also appreciated the better track conditions today.

Race 4 WHITE ROBE LODGE / AB LIME MAIDEN (1335)

THE WEDDINGS OFF was declared a late scratching at 1.40pm on veterinary advice.

GUNNA BE GOOD was slow to begin.

MANDY BAY shifted in abruptly at the start crowding **YOUNG ISSY** with both these runners losing ground.

Passing the 900 metres **I'M SO VAIN** had to steady when momentarily crowded for room by **WEST ARM** (A Morgan) which shifted in. Apprentice A Morgan was advised to exercise care when shifting ground.

HE AIN'T HEAVY raced wide throughout

JIMMY was inclined to lay in early in the run home.

Race 5 TED WINSLOE MEMORIAL MAIDEN (2000M)

JUST IMPRESS and **VOUSSOIR** made firm contact at the start.

CRISTALLO lost ground when crowded by **ULTRASONIC** shortly after the start.

JUST IMPRESS raced wide into the first bend.

TANIWHA lay out on the first bend dictating **MANGAROA MISS** wider on the track for several strides.

AKAL raced wide through the middle stages.

HOLD THE NOTE raced wide from the 800 metres.

TANIWHA lay out from the 600 metres racing wider on the track. **TANIWHA** then continued to lay out throughout the run

home and could not be ridden to full advantage by rider J Morris. The connections of **TANIWHA** were advised the gelding was on a warning for its racing manners.

JUST IMPRESS was reported by rider A Morgan to have made abnormal breathing noises throughout the race with the Stewards ordering a post-race veterinary examination of the mare which revealed no abnormalities. Trainer A Stalker advised he would try the mare with a tongue tie before his next start.

MANGAROA MISS gave ground from the 500 metres eventually finishing well back in the field. Rider K Williams was spoken to however she could offer no tangible explanation for the poor performance. Stewards ordered a post-race veterinary examination of **MANGAROA MISS**. The subsequent examination revealed no abnormalities.

Race 6	SWITZERS VALLEY TRANSPORT HANDICAP (2000M)

ELDANTE bounded at the start and began awkwardly.

TILLY had to be steadied shortly after the start when awkwardly placed on heels.

THEGREATPICKPOCKET, **TILLY** and **PUDDLE ALLEY** all improved wide passing the 1100 metres to be in or near the lead by the 800 metres.

BRAEHILL raced wide from the 1000 metres.

EKSTRA SPECIAL was held up rounding the final bend and had to shift ground outwards at the 300 metres to find clear racing room.

Race 7	GORE NEW WORLD HANDICAP (2000M)

YAZOOM was slow to begin.

KEEP HER SECRET raced wide in the early stages before being taken forward to the lead at the 1500 metres.

READY TO RULE also raced wide in the early stages.

When spoken to regarding the improved performance of **YAZOOM** trainer B Jenkins advised the Stewards he had been confident of a forward showing from the mare at Gore the previous Saturday however believed **YAZOOM** was in the latter stages of being in season. Mr Jenkins further advised the mare had appreciated the step up in distance and drop in class of today's race.

Race 8	MALLOCH McCLEAN GORE HANDICAP (1200M)

HERMIONE was declared a late scratching at 4.58pm on veterinary advice after the mare lashed out in the starting stalls and kicked the back gate resulting in a superficial injury to a hind leg.

I'M MAVERIC got its head up for some distance when racing keenly passing the 1000 metres.

I'M MAVERIC had to steady when held up passing the 400 metres and then raced in restricted room for several strides passing the 100 metres.

Apprentice rider **R Black** (KEVILDO) was reminded of her obligations to ride her mounts out fully to the finish of the race when circumstances permit.

Following the running of this event **KEVILDO** which returned to the birdcage with blood present in the nasal region underwent a post-race veterinary examination which revealed the gelding to have a minor laceration consistent with having struck its head on the starting gates.

Race 9	AON INSURANCE BROKERS HANDICAP (1200M)

ALLSTARS was declared a late scratching at 5.32pm after rearing over backwards in the starting gates on two occasions dislodging rider R Bishop. R Bishop was examined by the St John Ambulance Paramedics and found to be suffering from bruised ribs resulting in him being stood down from his remaining riding engagement today. Mr Bishop was advised a medical clearance would be required prior to him riding next.

DOCTOR EDEN raced keenly in the early stages and had to be steadied passing the 800 metres when **ONE DIREKTION** improved forward to lead.

BUCKWILD rolled out on the home turn taking **PATRICE** and **MAHBEER** wider on the track. **MAHBEER** then lay in early in the run home making contact with **PATRICE**.

Race 10	NZB INSURANCE PEARL SERIES RACE (1335M)

T Dieren replaced R Bishop as the rider for **LEGNANI** due to no senior rider being available.

There was a delay to the start of this event due to the runners arriving late to the start area.

GOLDEN CASTLE and **FOUR GEES** were both slow to begin.

LIBETTO raced wide throughout.

FASCINATE raced keenly for several strides passing the 900 metres and had to be steadied for some distance. **FASCINATE** again had to be steadied passing the 300 metres when **GALLANT BABE** (L Callaway) shifted out looking for clear racing room. L Callaway was advised to exercise care when shifting ground.

RAPT lay out in the run home then shifted out abruptly passing the 225 metres and had to be straightened.

Stewards ordered a post-race veterinary examination of **RAPT** after it was reported by rider Miss K Williams to have hung round the bends and to have been favouring the near side shoulder during the running. The subsequent examination revealed no abnormalities.
