Over the final stages **THE GORE HARPOON** (R Hannam) shifted outwards under pressure and made contact with **COTTA PIN** passing the 200 metres, then continued to hang out for the remainder of the race. R Hannam was shown footage of his ride and advised that he is expected to straighten his mount sooner than he did on this occasion. Prior to the authorisation of dividends connections of **COTTA PIN** which was placed 2nd viewed coverage of the incident but elected not to proceed with an objection against the winner.

When questioned regarding the performance of **CIDER** which disappointed, rider M Cameron advised that the gelding had travelled well until placed under pressure in the final straight and was of the opinion there may have been something amiss. A subsequent veterinary examination failed to reveal any abnormality.

Race 4 Andrew Fage Catering 1400

CALL ME HOLLY (D Turner) refused to parade in its preliminary, reared and dislodged the rider prior to making contact with the running rail so was late scratched by the Stewards at 3.09 pm. D Turner was unharmed. Connections were advised that **CALL ME HOLLY** must trial to the satisfaction of stewards prior to its next start. Trainer P Pascoe advised that the mare would no longer be persevered with as a racing proposition from his stable.

LADY ANNALEE was slow into stride.

ALY'S BELT raced keenly when wide in the run along the back straight.

Over the final stages **CATALINA DE LAGO** (K Myers) hung outwards under hard riding and dictated **SECRETARY MISS** (M Cameron) over extra ground, with both runners coming together and bumping several strides short of the finish. When questioned K Myers stated that her mount hung throughout, nevertheless she was advised that she is expected to straighten her mount sooner than she did on this occasion in future

Prior to the authorisation of dividends being signed off, Stewards observed a discrepancy in the Judge's initial call and alerted patrons after he incorrectly placed no 3 **ALY'S BELT** in 4th placing, the correct runner being no.11 **TIDDLY**. Placings were subsequently amended by the Judge as per Rule 641(5) prior to dividends being approved.

Race 5 Nufarm Spray IT Ltd 1600

MIDNIGHTCHICADEORO began awkwardly and was further hampered shortly after when runners either side shifted ground.

ENORMAS hung outwards leaving the barriers having to steady when awkwardly placed on the heels of **BLAZING OPAL**. **ENORMAS** continued to hang outwards rounding the first bend with the gelding racing wide without cover for the remainder.

LIGHT UP A SCREEN attempted a narrow run which did not eventuate fully near the 200 metres and consequently raced in restricted room for the remainder.

Race 6 Jason Holdem Contracting/Mack Transport 1600

When questioned regarding the performance of **HOSTAGE**, rider N Teeluck was of the opinion that the mare may be better suited to rain affected going.

Race 7Rich Hill Stud See Our Draft @ Karaka 2015 1400

LUMIERE BLUE over raced and had to be eased off heels when the pace ahead eased near the 800 metres. Also having to steady was **MOI OH MA** which was shortly after angled outwards and obliged to improve rounding the turn. **WILLBEOKAY** raced three wide without cover throughout.

CAUGHT BEHIND was held up for several strides over the final stages when unable to secure clear racing room. **OLIVIA MARY** returned to the enclosure with blood present in both nostrils. A subsequent veterinary inspection confirmed the mare to be a bleeder and is stood down for the mandatory three month period.

Race 8 Seaver Cycles & Masport / Ben Seaver Memorial 2100

MISCHIEVOUS MIS was trapped wide in the early and middle stages until near the 1000 metres.

B Lammas (MENDOZA) was advised to exercise care after he allowed his mount to shift ground near the 100 metres and bump **MISCHIEVOUS MIS.**
