RACE COMMENTS:

Race 1 WATER FORCE 3YO MAIDEN

GENERAL SUSSEX (J Parkes) began awkwardly and settled back.

PADDY BOURKE (R Myers) over raced in the early and middle stages having to be steadied for some distance.

THE WOLF (L Allpress) raced three-wide without cover throughout.

BRIENNE (N Teeluck) was momentarily held up near the 400 metres.

R Hannam (GATES OF EDEN) was reminded of his obligations with regard to his whip use on a horse out of contention.

L Allpress (THE WOLF) was reminded of her obligation to ride her mount out fully to the end of the race and leave no room for query after appearing to relax her ride short of the line.

When questioned on the performance of **THE WOLF, L Allpress** was of the opinion that the colt would be better suited by a firmer track and further distance than on offer today.

Race 2 H&T AGRONOMICS / AGRICOM HANDICAP

DANNY BOY (N Teeluck) shifted inwards at the start bumping with STAR OF O'FRAAJ (L Allpress).

STAR O'FRAAJ then shifted out simultaneously as JUST A LOVER (J Riddell) shifted in which resulted in crowding to DANNY BOY and GYPSY FAIR (D Mo).

JOBY (J Parkes) raced wide throughout.

GYPSY FAIR was inclined to lay in under pressure over the final 250 metres.

J Parkes admitted a charge of careless riding under Rule 638 (1) (d) in that shortly after the start he allowed his mount

JOBY to shift in when not clear of FETCHING (R Hannam) which was dictated inwards into the line of GYPSY FAIR (D Mo)

which was checked. **BROKEN BELT (R Goldsbury)** and **DANNY BOY (N Teeluck)** were also hampered in this incident, both having to steady. After consideration the Judicial Committee suspended Mr Parke's licence to ride in races from the conclusion of racing on 19th September 2015 until the close of racing of 2 October, 2015. (6 days).

When questioned on the performance of **BROKEN BELT** which dropped out quickly prior to the home turn, **R Goldsbury** was of the opinion that the fast early pace and the rise in class counted against the gelding on this occasion.

A Jones reported that KING VICTOR was not comfortable in the holding Heavy 10 footing.

Race 3 CR GRACE LTD HANDICAP

ZEDEEDUDADEEKO (R Myers) was slow away after beginning awkwardly

SHARE THE BLAME (J Riddell) over-raced throughout.

DOUBLE O SEVEN (L Hemi) raced wide throughout.

Apprentice **L Werner** was issued with a warning after she allowed her mount **NGARIO** to shift out across the heels of **DOUBLE O SEVEN** near the 600 when not sufficiently clear of **ZEDEEDUDADEEKO**.

Race 4 JOHN TURKINGTON FORESTRY / MANAWATU TOYOTA HANDICAP

WORD'S OUT (L Allpress) began awkwardly and then over-raced for some distance.

CAVALRY (R Hannam) was held up for a short distance passing the 400 metres.

When questioned into the disappointing run of **CAVALRY**, **R Hannam** was of the opinion the gelding may have been feeling the effects of recent racing.

Race 5 CP WOOL & CARRFIELDS LIVESTOCK MAIDEN

SANDALLY (K Myers) was slow away.

HALLOWED (R Myers) was tightened by runners on either side on jumping away and settled back.

RED THUNDER (M Dravitzki) over-raced for the majority of the event

MASTER FIN (T Johnson) raced wide throughout.

MWAADAN (R Goldsbury) was held up rounding the turn and when angled into clear running passing the 400 metres, directed **BELLE ZED (J Parkes)** wider. Apprentice **R Goldsbury** was advised to exercise greater care when shifting ground.

Race 6 NUFARM HANDICAP

DAL LAUREON (M Hills) and RED SUNSET (N Teeluck) were slow away.

ALLSTARS (L Allpress) over raced in the early stages.

R Myers reported that **WAIPATIKI GIRL** did not handle the track conditions.

Apprentice R Goldsbury the rider of **DAL TE EN TEE** admitted a charge under Rule 638 (3) (b) (ii) in that she used her whip excessively prior to the 200 metres. After consideration the Judicial Committee imposed a fine of \$300.00

Race 7 PILET CONTRACTING / PIONEER SEEDS HANDICAP

CLAPATHUNDA underwent a veterinary inspection and was cleared to start after being kicked by another runner leaving the birdcage.

BRAD THORN (N Teeluck) began awkwardly.

DEZ (K Myers) was denied a run near the 200 metres prior to being angled inwards to continue to improve. **K Myers** reported that the gelding raced very greenly throughout and would benefit from the experience.

WOW WHATA PRINCESS disappointed finishing well back. Rider **J Parkes** reported that the mare was unsuited to the holding heavy track conditions. A subsequent veterinary examination of **WOW WHATA PRINCESS** revealed no abnormality.

Race 8 MERIAL ANCARE METRIC MILE - GpIII

NORTH AND SOUTH (R Hannam) began awkwardly and settled back and then commenced to race keenly in the early and middle stages.

DUFFERS CREEK (L Hemi) over-raced through the back straight.

NORTH AND SOUTH was obliged to improve its position very wide around the turn.

THE FILLY (M Hills) was crowded near the 250 metres after DUFFERS CREEK shifted in and away from AUTHENTIC PADDY (D Bradley) simultaneously as TAURUS (J Riddell) shifted ground outwards.

When questioned regarding the run of **SPOKE TO CARLO** rider R Myers reported that the gelding had travelled well throughout but when pressured was unable to quicken appreciably in the holding track conditions, however had let down well over the concluding stages. Additionally trainer N Tiley advised that **SPOKE TO CARLO** was better suited to more rain affected going.

Race 9 MARSH INSURANCE HANDICAP

YIN DRAGON (J Riddell) shifted in abruptly at the start bumping with CHOP SUEY (N Teeluck) and forcing that runner inwards onto NOM DE BOSS (J Parkes). Affected in this incident was CHOPPER (D Mo) which settled back.

TE MATA'S HORSE (R Hannam) was slow away and then raced wide throughout.

NOM DE BOSS raced in restricted room for a short distance shortly after the start.

NOM DE BOSS had to steady near the 600 metres when outside **CHOP SUEY** which shifted ground outward marginally. **DAL AMORE (R Goldsbury)** had to steady in consequence when in restricted room.

L Allpress reported that **KING SAMBO** lay in across the top bend and through the final straight with rider **L Allpress** changing her whip to her left hand in an attempt to rectify this tendency.

Trainer L Latta could offer no reason for the improved performance of the winner RALPH'S GIFT.

J Parkes reported that **NOM DE BOSS** was never comfortable in the holding track conditions and did not respond when put under pressure in the home straight.
