RACE COMMENTS:

Race 1	TRU TEST MAIDEN
<p>T Collis was issued with a warning for presenting MASTER JACK to race with non-notified gear (side winkers). HIIQUE (D Bradley) began awkwardly and lost ground in the early stages. HIIQUE then raced greenly throughout. MANEO INVICTUS (R Hannam) shifted in abruptly at the start crowding SHADOWS CAST (L Allpress) in onto MASTER JACK (H Tinsley).</p> <p>WOODY STROBE (D Johnson) was slow to begin.</p> <p>MANEO INVICTUS was held up rounding the home turn only obtaining clear running passing the 150 metres.</p> <p>WARNER (R Myers) had to be steadied abruptly near the 200 metres when inside SMASH N GRAB (R Norvall). After questioning riders and viewing video footage it was established that WARNER, which had been several lengths in arrears of SMASH N GRAB in the early part of the straight had made ground rapidly and was had arrived near the</p>	

heels of **SMASH N GRAB** simultaneously as that runner lay in when weakening. Given all circumstances no further action was required other than to remind **R Norvall** of his obligations with respect to maintaining his correct line of running in the final straight.

When questioned on the run of **WOODY STROBE**, **D Johnson** was of the opinion the gelding would be better suited by a longer distance.

Race 2	PRATT QUARRIES HANDICAP

NIGELISSIMA and **CHAZELLE** were both slow away.

CYCLONE TRACY, **PENCURI**, **NIGELISSIMA** all over-raced in the early stages on a moderate tempo.

JACK'S BOY raced three-wide throughout.

ZEDBEE raced three-wide around the first turn so was taken forward near the 1400 metres to sit adjacent to the leader.

MR DARCEE'S GOLD was held up rounding the turn and the early part of the final straight.

CARLOW was held up passing the 300 metres and thereafter failed to obtain clear running for the majority of the final straight.

V Colgan (NIGELISSIMA) and **D Johnson (HIGHLY LIKELY)** were both issued with a warning for the manner in which they used their whips prior to the 200 metres.

CHAZELLE returned to the enclosure with blood present in both nostrils. A subsequent veterinary examination confirmed the mare to be a bleeder. Trainer J Collett was advised that **CHAZELLE** is now subject to a mandatory 3 month stand-down from racing. In addition **CHAZELLE** must undergo a veterinary examination and gallop in the presence Stewards before next racing.

Race 3	PGG WRIGHTSON HANDICAP

WHITE DIAMOND began awkwardly and got back.

ENCOSTOW was slow away.

KEILIB raced greenly approaching the crossing near the 1400 metres compelling the trailing **ALL CAN PARTY** to take evasive action which resulted in **TROUP ROAD** being hampered.

NICOSHINE over-raced for a short distance in the back straight.

The saddle on **SZYSLAK** shifted forward near the 900 metres placing Apprentice Baker at a significant disadvantage for the remainder of the race.

ENCOSTOW had difficulty obtaining clear running over the 350 metres and near the 150 metres had to shift out when awkwardly placed on heels.

RATPACK had difficulty obtaining clear running for the majority of the home straight.

Te Baker (SZYSLAK) was excused from weighing in under Rule 647 (1) (a) from weighing in after losing pieces of saddling gear during the running.

Race 4	POWER FARMING HANDICAP

THIEN LY became caste in its barrier after being fractious and was a late scratching on veterinary advice at 2.13pm.

JACKOFALL and **KONOHIKI** which had drawn on either side of **THIEN LY** were injured as a result of this incident also and were scratched on veterinary advice at 2.13pm.

As a result the start of this race was delayed 8 minutes.

YIN DRAGON and **ROSEOFPLATINUM** were slow to begin.

DARCI MAC over-raced in the early stages.

SLIMLINE was held up rounding the turn and then briefly approaching the 250 metres when attempting a run on the inside of **PEAK PERFORMER**.

ROSEOFPLATINUM was held up near the 300 metres until near the 100 metres.

FETCHING was held up rounding the turn and near the 350 metres had to be steadied when awkwardly placed near the heels of **LIME STREET** in order to obtain clear running.

Race 5	FEILDING HOTEL HANDICAP

DRAMATIST underwent a veterinary examination prior to being cleared to start after charging the gate.

The start of this race was 5 minutes late due to delay from the previous race.

POROTENE PARK raced three wide throughout.

RED MAFIA and raced wide with cover throughout.

LANGDON raced three-wide from the 1000 metres.

CITY CHIC was held up early in the run home only finding clear racing room near the 200 metres.

FLINT was unable to take advantage of a narrow run before it closed near the 300 metres and from then went to the line in restricted quarters.

TE HANA (shifted out and away from **FREDERICK WILLIAM** when that runner improved to its inside and in doing so made contact with **RED MAFIA**.

I SUGGEST was unable to obtain clear running throughout the home straight and finished the race off untested.

Stewards ordered a veterinary examination of DRESDEN PARK which tailed the field home and this revealed no abnormality. Rider L Allpress reported that the mare never hit out at any stage of the race.	
Race 6	COURTESY REDCRAZE BOWL HANDICAP
KAWI over-raced in the early and middle stages. MIGHTY SOLOMON raced wide throughout. MIGHTY MATT was held up round the turn and had difficulty obtaining clear running for the majority of the final straight. BETTER KEEPER was held up for a short distance near the 200 metres. ANNIESSTAR received veterinary attention after to the near hind leg after being galloped on during the running.	
Race 7	RATANUI DEVELOPMENT COMPANY HANDICAP
KERMIT began awkwardly losing ground. AWESOME DIVA shifting out on jumping making contact with SPENDAHOLIC BRILLIANT BRIGITTE was crowded shortly after the start having to be steadied. PRIORITISE shifted in shortly after the start inconveniencing EARL'S COURT . BLAME DE ANGLES over-raced in the early and middle stages. MASTER FINN raced wide in the early stages. ENDURE was held up throughout the final straight. L Allpress reported that KING SAMBO had hung throughout. SHE KNOWS was tightened and checked passing the 800 metres when inside IRISH WHISPER which was crowded inwards by PERRY MASON which was racing tight to the inside of NYMPH MONTE (L Hemi) which was taken in to obtain a position closer to the rail. Miss Hemi admitted a resultant charge of careless riding and after consideration the Judicial Committee suspended Miss Hemi's licence to ride in races from the conclusion of racing on Tuesday 3 rd October 2015 up to and including racing on Wednesday 11 th October 2015 (3 days) EFFECTAV (D Mo) commenced to lay in passing the 350 metres and near the 200 metres shifted in crowding MASTER FINN which had to steady and change ground outwards to obtain clear running. Apprentice Mo was issued with a warning and reminded that he must straighten his mounts, when they commence to shift ground, sooner than he did on this occasion.	
Race 8	RICOH FEILDING GOLD CUP - Listed
OUR GAZZA, RANSOMED AND BENZINA were slow to begin. BLATHWAYT shifted out on jumping bumping with CLASSCOROC AUTHENTIC PADDY returned to scale with blood present in a nostril. A subsequent veterinary examination revealed a minor laceration. BLIZZARD and BENZINI both raced keenly early and middle stages. AUTHENTIC PADDY over-raced in the early stages and was taken forward to lead near the 1600 metres. NOBLE WARRIOR raced wide for the majority. When questioned regarding the run of BENZINI rider R Myers reported that the mare had been disadvantaged by a wide draw and had also lay in throughout the final straight. BLATHWAYT shifted out and away from KING KAMADA near the 300 metres resulting in THORN PRINCE being inconvenienced.	
Race 9	IAN HUMPHREY MOTORS & HUMPHREY FAMILY HANDICAP
FIGURAC began very awkwardly and ran inward losing ground. CAFE CULTURE was slow to begin. LEEDS raced wide in the middle stages. KOLONEL KEV had to be steadied when awkwardly placed on heels near the 1200 metres. CENTRE CROSS raced keenly near the 1000 metres resulting in AUSTIN ROAD being forced wider on the track. KOLONEL KEV raced keenly near the 950 metres and shifted out bumping with CAFÉ CULTURE . AUSTIN ROAD and LEEDS came together and bumped passing the 600 metres resulting in LEEDS becoming unbalanced. KOLONEL KEV shifted out and away from MAITRE DU JEU near the 350 metres crowding AUSTIN ROAD out onto the hind quarters of LEEDS which was unbalanced. GUARANTOR was inclined to lay in throughout the final straight. SHADES OF GREY was held up over the latter stages of the final straight. JOBY lay out under pressure passing the 100 metres inconveniencing CENTRE CROSS . CAFÉ CULTURE was held up throughout the final straight and went to the line untested. THORN PASS and CENTRE CROSS came together passing the 50 metres and thereafter raced in restricted room for the remainder with both runners being unable to be ridden out to the finish. FIGURAC was checked and fell after the finish when in restricted room with rider H Tinsley taken to Palmerston North Hospital with a suspected concussion. Stewards opened and adjourned an investigation into this matter. When questioned regarding the improved performance of MISS BENCI connections advised that the mare had been working well and the win was not unexpected.
