RACE COMMENTS:

Race 1	COUNTRY FEASTS RATING 65 (1400m)			
BAHHARE BABE was hampered shortly after the start and got back.				
RESET THE TURBO raced keenly in the early stages.				
ROC CITY over-raced passing the 1100 metres when being steadied resulting in the trailing RESET THE TURBO over-racing				
and being shifted wider inconveniencing SAN MICHELE, ARE YOU MINE and BAHHARE BABE.				
RESET THE TURBO continued to race ungenerously for a short distance thereafter.				
SHARP BLADE raced keenly passing the 800 metres.				
RESET THE TURBO lay out passing the 600 metres having to be straightened.				
RESET THE TURBO ran wider rounding the home turn.				
When spoken to regarding the performance of favoured runner TREAT ME rider M McNab reported that TREAT ME was				
under pressure near the 400 metres and in his opinion the mare had failed to see out the distance of today's race.				
Race 2	KPMG PRIVATE ENTERPRISE MAIDEN (1400m)			
SEA TIGER dislodged rider S Muniandy in the preliminary and galloped a short distance before being re-captured				

SEA TIGER dislodged rider S Muniandy in the preliminary and galloped a short distance before being re-captured.

SEA TIGER was checked by the Veterinarian and cleared to start. S Muniandy was cleared to take his ride by St John ambulance staff.

HIRAKIMATA shifted inwards abruptly at the start and was slow through the initial stages losing considerable ground. **FEEL D'CASH** raced keenly in the early stages.

YOUR HONOUR raced wide throughout.

NIGHT NURSE which was laying inwards was steadied at the 600 metres when awkwardly placed on the heels of **LITTLE HAAST**.

Passing the 300 metres LITTLE HAAST which was laying out shifted out and made contact with SEA TIGER.

NIGHT NURSE shifted ground inwards to obtain clear running near the 200 metres.

LITTLE HAAST raced greenly in the final straight.

When spoken to regarding the performance of favoured runner **HIRAKIMATA** rider D Walsh reported that the gelding had failed to travel at any stage and despite his urgings had only battled over the concluding stages. Co-trainer M Brown advised that they would consider making gear adjustments prior to the gelding's next start.

Apprentice B Murray (LOS CABOS) was reminded of his obligations regarding his use of the whip prior to the 200 metres.

Race 3 RURAL LIVESTOCK MAIDEN (1200m)

The start was delayed due to LANE FROST and BOOTS N ALL being difficult to load.

STEVIEWINX was hampered shortly after the start and got back tailing the field throughout. The connections were advised that a warning had been placed against the filly's racing record. Trainer R McKay advised Stewards that the filly would be sent for a spell.

BONAPARTE raced keenly in the early stages.

NASA got its head up passing the 900 metres when being restrained.

FATHER WAYNE raced keenly for a short distance passing the 900 metres.

BONAPARTE raced wide throughout.

BONAPARTE made the final bend awkwardly.

MOBY lay inwards in the early part of the straight.

BOOTS N ALL lay in over the concluding stages and brushed with LANE FROST.

Rider B Moore (**BONAPARTE**) was reminded of her obligations regarding her use of the whip prior to the 200 metres. When questioned regarding the performance of favoured runner **FATHER WAYNE** rider C Johnson reported the gelding had over raced in the lead in the middle stages and despite his urgings had failed to run on over the concluding stages.

Race 4 NZB INSURANCE PEARL SERIES RACE (1200m)

OAKURA and TICKETS ON HER were both slow to begin.

IONA CASTLE became awkwardly placed on the heels of **YOURLIPS AR MOVIN** shortly after the start and had to steady. **UNICO** raced keenly in the early stages.

POP HIT (B Murray) lay inwards passing the 900 metres and shifted in placing **MULBERRY** in restricted room. **MULBERRY** had to steady and lost momentum. Apprentice B Murray was warned under Rule 638(1)(d) and reminded that he must make a greater effort in future.

ITS NO SECRET made the bend near the 800 metres awkwardly.

OAKURA raced wide throughout.

POP HIT had to steady passing the 600 metres when awkwardly placed on the heels of **UNICO**.

POP HIT lay inwards in the early part of the straight.

FASHION LASS was held up for a short distance passing the 200 metres.

Inside the 150 metres **UNICO** (T Moseley) shifted outwards under a ride and checked **POP HIT** (B Murray) and **FASHION LASS** which was attempting a marginal run to the inside of **TWILIGHT METEOR** when becoming awkwardly placed on the heels of that runner.**TWILIGHT METEOR** was unbalanced as result. **ITS NO SECRET** was hampered in consequence. Rider T Moseley defended a charge of careless riding and after viewing films and hearing all evidence the JCA upheld the charge. The JCA suspended Mr Moseley's licence to ride for two days from 9 November up to and including 13 November 2015.

OAKURA lay outwards over the concluding stages having to be straightened and proving a difficult ride.

Race 5 CANTERBURY EQUINE CLINIC RATING 65 (2200m)

KEYNOTE raced keenly in the early stages.

I'LLBEYOURPLATINUM got its head up passing the 1800 metres when being steadied.

SHE'S PAYBACK raced wide in the middle stages.

CARINATA improved wide and forward from the 800 metres.

KEYNOTE had to steady passing the 450 metres and shifted outwards to avoid the heels of the tiring **STONEMASON**.

Race 6 C.S. STEVENS MEMORIAL BANKS PENINSULA CUP (2200m)

SHE'S INSATIABLE began awkwardly and got its head up when being restrained shortly after the start. **SPEEDY JAX** over-raced in the middle stages.

LORD OF THE STARS returned to the birdcage with blood present in both nostrils. A post-race veterinary examination confirmed the gelding had bled and **LORD OF THE STARS** was stood down for the mandatory three month period.

Race 7 TELTRAC COMMUNICATIONS MAIDEN (2000m)

COOLIN ROO began awkwardly and was restrained to the rear on jumping.

ST LAMOUR got its head up and raced keenly passing the 1800 metres.

MR GUS raced wide in the early stages.

MINGOZZIE had to steady passing the 1600 metres when awkwardly placed on the heels of **HI YO UGO** which shifted inwards. Rider T Direen was reminded of her obligations when shifting ground.

Race 8 MICK & MELBA MURFITT MEMORIAL RATING 75 (1400m)

CORBYN began awkwardly and got back.

Trainer D Crozier lodged a Request for a Ruling with the JCA under Rule 632 in that **CORBYN** was denied a fair start when the gate failed to affix. The JCA determined that **CORBYN** had not been denied a fair start.

DO UNO WHOIAM was obliged to race three wide without cover throughout.

Race 9 IKANA MUSSELS MAIDEN (1400m)

ALYTH and RAISING HIGH were both slow to begin.

PROSPERITY shifted inwards on jumping and hampered **SCARLET PIMPERNEL** which got back and **UNFURL THE SAIL**. **PROSPERITY** raced keenly in the early stages.

LINDIS PASS raced wide in the early stages.

Passing the 1100 metres **JONA MAC** shifted outwards abruptly when being steadied forcing **UNFURL THE SAIL** wider. **LINDIS PASS** shifted wider on the track near the 1100 metres when awkwardly placed on the heels of **PERFECT JAZZ** and raced wide from that point on.

KISS LIKE THIS raced keenly in the early stages and made the bend near the 900 metres awkwardly when being restrained.

JONA MAC was forced wide on the final bend when awkwardly placed on the heels of KISS LIKE THIS.

ANCIENT raced greenly in the early part of the straight and lay inwards at the 200 metres having to be straightened. **ALYTH** shifted inwards passing the 200 metres to obtain clear running.

Race 10 FAMOUS GROUSE LINCOLN HOTEL RATING 65 (1400m)

HE'S A BIGDEEL shifted outwards on jumping and made contact with **WHY WAIT** getting back as a result. **KAHARAU** began awkwardly.

MANUIA raced wide in the early stages.

CARBIDE raced wide for a short distance passing the 900 metres.

JEAN'S WAY made the bend near the 800 metres awkwardly laying inwards and having to be straightened.

ZHANIM shifted inwards passing the 400 metres to obtain clear running.

JEAN'S WAY (T Moseley) shifted inwards near the 400 metres placing HE'S A BIGDEEL in restricted room . T Moseley was reminded of his obligations when shifting ground .

Simultaneously **MELANIE CLAIRE** (M McNab) shifted outwards marginally off the heels of the tiring **WHY WAIT** placing **MOONOFKLAIRESSA**, which had to steady, in restricted room for some distance.

M McNab was warned under Rule 638(1)(d) and instructed to make a greater effort when shifting ground.

MOONOFKLAIRESSA had to steady and shift outwards off the heels of JEAN'S WAY passing the 200 metres.

JEAN'S WAY continued to lay in over the concluding stages.
