RACE COMMENTS:

Race 1 SADDLERY WAREHOUSE INVERCARGILL MAIDEN (1200M)

Apprentice rider L Magorrian replaced R Bishop as the rider for **GAMMA CRUCIS** and was permitted to ride 1 kg over the carded weight due to no other senior rider being available. R Bishop was fined \$100.00 pursuant to Rule 330 (3) (c) for failing to make the contracted weight.

The start of this event was delayed approximately 3 minutes due to several runner proving reluctant to load.

RAISING AL was slow to begin.

BRIEF ENCOUNTER began awkwardly and got back as a result.

RAISING AL shifted outwards abruptly after jumping proving a difficult ride over the early stages.

ACCIDENTAL OFFSIDE raced wide from the 800 metres.

VELVET ROSE was steadied passing the 800 metres when awkwardly placed inside the heels of INBEE.

GAMMA CRUCIS was steadied near the 700 metres when the tempo of the race changed resulting in ERIN'S BABE, GUN

LAW, THAT'S NOT THE GO and BRIEF ENCOUNTER all over racing for some distance.

GAMMA CRUCIS lay out throughout.

ACCIDENTAL OFFSIDE lay inwards near the 200 metres.

Race 2 ILT FOUNDATION HANDICAP (2000M)

PETER PARROT was restrained to the rear of the field on jumping.

FLY ME TO DA MOON over raced in the early and middle stages.

SIR AMRON had to be steadied near the 1400 metres when awkwardly placed near the heels of **FLY ME TO DA MOON**.

THE GROOMSMAN made the bend near the 1400 metres awkwardly shifting wider as a result.

FLY ME TO DA MOON raced fiercely for a short distance passing the 1200 metres.

SIR AMRON got its head up on a number of occasions during the running due to the lack of tempo in the race.

THE GROOMSMAN raced keenly for a short distance passing the 1100 metres before being taken forward near the 1000 metres.

TUTOR was steadied passing the 900 metres when awkwardly placed to the inside of **THE GROOMSMAN** (R Cuneen) which shifted inwards. R Cuneen was warned pursuant to Rule 638(1)(d) and instructed he must ensure he gives runners sufficient room when shifting ground.

TUTOR then began to over race and was heavily restrained near the 700 metres when again on the heels of **THE GROOMSMAN**.

SIR AMRON lost contact with the body of the field near the 800 metres and was not persevered with in the final straight. Stewards ordered a post-race veterinary examination of **SIR AMRON** which detected no clinical abnormalities.

THE GROOMSMAN was steadied for a short distance passing the 600 metres.

TUTOR shifted ground outwards passing the 200 metres to obtain clear running then shifted inwards near the 70 metres and had to be straightened.

Rider D Bothamley reported **SIR AMRON** was not favoured by the prevailing track conditions.

Race 3 INVERCARGILL LICENSING TRUST HANDICAP (1800M)

Trainer **E Winsloe** was issued with a warning under Rule 616(4) after he presented **IRISH EXCUSE** to race in this event with the incorrect gear (Sidewinkers).

OOR WULLIE and BELLE D'OR came together on jumping resulting in BELLE D'OR getting back.

IRISH EXCUSE was steadied shortly after the start when becoming awkwardly placed on the heels of **COMANCHE GOLD** (D Bothamley). D Bothamley was warned under Rule 638(1)(d) to ensure he gives runners sufficient room when shifting ground.

HEXIE HAO got its head up on a number of occasions in the early stages.

IRISH EXCUSE was held up on the final bend.

COMANCHE GOLD was steadied at the 250 metres when awkwardly placed to the inside of **MOTORBOAT MIKE** (D Walsh). Inside the final 50 metres **MOTORBOAT MIKE** and **COMANCHE GOLD** brushed. **MOTORBOAT MIKE** then shifted outwards and made firm contact with **OOR WULLIE**.

HEXIE HAO which had raced in restricted room from the 100 metres had to steady near the 40 metres.

MOTORBOAT MIKE which returned to the birdcage with blood on its off hind leg underwent a post-race veterinary examination which revealed the gelding to have suffered a minor laceration.

Race 4 McCALLUMS GROUP MAIDEN (2000M)

YOUNG ISSY was declared a late scratching on veterinary advice at 1.02pm.

MRS NEVILL shifted outwards abruptly at the start hampering PADDYBLACK outwards onto PALMY GIRL.

PADDYBLACK and PALMY GIRL then jostled for a short distance.

TANIWHA was restrained to the rear of the field on jumping.

SATIN JITTERBUG began awkwardly and got back as a result.

WEELYWONG, TANIWHA and PADDYBLACK all over raced for some distance in the early stages.

WEELYWONG raced wide throughout.

DREAM DIVINE over raced for a short distance near the 800 metres having to be steadied.

DREAM DIVINE was held up for a short distance on the final bend and shifted out near the 200 metres making contact with **TANIWHA**

Passing the 200 metres **MRS NEVILL** was placed in restricted room and had to steady when **CHILI PEPPER** shifted inwards and **PADDYBLACK** shifted out.

Race 5 McKNIGHT & BROWN HANDICAP (2000M)

TAP OUT which was found to be lame after arriving around at the start area underwent a pre-race veterinary examination and was declared a late scratching at 3.34pm.

EMILIO was hampered shortly after the start when **TEDESCO** shifted outwards and **LADY PLATINUM** shifted inwards.

HONOR AND CHERISH began awkwardly.

DREAMWORLD was slow to begin.

Passing the 1700 metres **PETER PARKER** which was racing keenly had to steady for some distance when awkwardly placed to the inside of **APRIL JOY** (K Kalychurun) which shifted in. **K Kalychurun** was warned under Rule 638(1)(d) and reminded to ensure he gives runners sufficient room when shifting ground.

PETER PARKER raced keenly passing the 1400 metres and shifted outwards when awkwardly placed on the heels of **TEDESCO** resulting in **KOTOTAMA** being hampered.

KOTOTAMA raced wide without cover throughout.

CENTAVADA was steadied for some distance near the 800 metres when over racing.

LADY PLATINUM was held up for some distance passing the 500 metres finding clear running passing the 200 metres.

EMILIO was reported by its rider R Bishop to have made abnormal breathing noises during the running. Stewards ordered a post-race veterinary examination of **EMILIO** which revealed no obvious abnormalities. Trainer J Dalton advised it was her intention to have the gelding scoped prior to racing next.

Race 6 SPEIGHTS HANDICAP (1335M)

THEM OR US began awkwardly and got its head up when being restrained in the early stages.

DOCTOR EDEN got its head up on a number of occasions passing the 1200 metres.

THEM OR US raced keenly for a short distance passing the 1100 metres.

DOCTOR EDEN lay inwards passing the 150 metres and had to be straightened.

Race 7 MARQUEE & PARTY HIRE MAIDEN (1335M)

I DON'T KNOW was slow to begin.

CHANCERY LANE was hampered shortly after the start when MANAMANUP shifted inwards.

MANAMANUP raced wide through the early and middle stages.

CHANCERY LANE raced wide from 800 metres.

I DON'T KNOW was steadied off heels for a distance passing the 450 metres.

LYDIA raced in restricted room passing the 300 metres when attempting a marginal run between **I DON'T KNOW** which shifted inwards and **PAYMENT PENDING**.

Race 8 CHRISTMAS at the RACES Sat 12 Dec HANDICAP (1335M)

ROYAL DOLLAR bounded at the start losing several lengths.

AKAL shifted outwards at the start making contact with **SALLY GETCHA GUN** on its outside.

PACIFIC TAP raced keenly in the early stages.

READYWHENYOUARE raced wide in the early stages.

INDIAN PEARL raced wide throughout.

READYWHENYOUARE shifted outwards near the 350 metres and became awkwardly placed on the heels of **LANDALES GOLD** with **READYWHENYOUARE** having to steady for a short distance.

Passing the 350 metres **SIR JACK REMINGTON** shifted outwards forcing **CLAREVILLE FLIGHT** wider. **AKAL** which was attempting a marginal run to the outside was steadied after making contact with **ROYAL DOLLAR**.

READYWHENYOUARE attempted a marginal run to the inside of **LANSDALES GOLD** which shifted inwards near the 200 metres and had to steady. **WILD WINGS** was placed in restricted room for a short distance as a result.

READYWHENYOUARE raced in restricted room for a short distance passing the 100 metres.
