#### RACE COMMENTS:

# Race 1 PALAMOUNTAINS SCIENTIFIC NUTRITION F&M MAIDEN 1600

THIRTYLOVE was slow to begin.

**SWISS BOUQUET** skied its head and raced keenly for a short distance rounding the first turn when being restrained to trail. **TARIHIRA** raced wide without cover throughout.

**BIT OF CRUMPET** raced wide going into the first bend covering extra ground, prior to being taken forward near the 1,100 metres.

**DREAM DANCER** had to be eased near the 800 metres when over-racing.

Shortly after entering the home straight **DREAM DANCER** shifted out simultaneously as **HONEY QUEEN** was being angled out to improve. This resulted in **HONEY QUEEN** shifting out further than what Rider J Riddell had anticipated making firm contact with **KIRRA BELLE** which was bumped and became unbalanced. J Riddell was shown footage of his ride and advised to exercise more care when in similar circumstances.

When questioned into the disappointing run of SWISS BOUQUET Rider J Parkes had no excuses.

## Race 2 JOLT COFFEE HOUSE MAIDEN 1340

**PRINCE OZ** became fractious and charged the front of its gate resulting in trauma to its nose. **PRINCE OZ** then underwent a veterinary examination and was declared a late scratching at 1.01pm.

BARBOSSA shifted in on jumping and bumped with GET LUCKY.

VALOUR was slow to begin.

**GET LUCKY** raced ungenerously in the early stages and when making the bend near the 900 metres, commenced to race erratically, shifted in making heavy contact with **RAWINIA** which was badly unbalanced and lost ground. **GET LUCKY** then continued to race ungenerously.

**DAN CUGAT** hung outwards rounding the turn.

BATTLE CREEK shifted in when struck with the whip near the 250 metres and bumped with VALOUR.

#### Race 3 STEVO'S DISTRIBUTORS 1340

**ON THE HILL** was slow to begin and settled well back.

Passing the 1,200 metres **SHADOW FOX** (J Parkes) commenced to hang in and away from **TIGER TIM** and a short distance further on shifted inward dictating **BUSTA** inward in to the line of **CHELA CHOI** (D Mo) which contacted the heels of **BUSTA** and fell dislodging rider **Apprentice D Mo** who was transferred to Wanganui Hospital with a suspected concussion. **CHELA CHOI** was uninjured in this incident. In consequence the trailing **ON THE HILL** was badly hampered when taking evasive action to avoid the fallen **CHELA CHOI**. After interviewing riders and viewing footage the incident was considered beyond the control of Rider J Parkes.

WILLS ROAD was crowded and checked passing the 900 metres when racing to the inside of SHADOW FOX which was dictated inwards by TIGER TIM (J Riddell) which was improving forward to the lead and shifted in when not clear. Also affected in this incident was ASTRID which had to be steadied off the heels of WILLS ROAD. J Riddell the rider of TIGER TIM defended a charge of careless riding under Rule 638 (1) (d). After deliberations the JCA found the charge proved and J Riddell's licence to ride in races was suspended from the conclusion of racing on 5 December up to and including 10 December – three days.

WILLS ROAD raced in restricted room for a short distance near the 50 metres.

### Race 4 LOADERS LANDSCAPE SUPPLIES 1200

MISS KAYLEE which was fractious in the barriers prior to the start began awkwardly.

KONOHIKI and SHILLELAGH came together and bumped at the start.

AWESOME DIVA began awkwardly and shifted out on jumping crowding ROSEOFPLATINUM which lost ground.

PLEASURE PALACE was slow to begin.

KINGOFPLATINUM had to steady and shift ground inwards near the 500 metres when in restricted room.

### Race 5 FOMS, YOUR PARTNERS IN FORESTRY MAIDEN 2040

**ANY STREAM WILL DO** and **BLUSHING MOSS** came together after both began awkwardly.

**RATHGAR** over-raced in the early stages when being steadied.

**SCARAMOUCHE** raced wide rounding the first turn.

**KININMONT** raced three-wide in the early stages.

When the pace eased going into the back straight **DAL DUNVEGAN** came back on to **BLAZING OPAL** which when steadied went back on to **SUCHAPALAVA** which also had to steady.

**OURS** raced keenly in the middle stages.

Over the final stages **OURS** was denied a marginal run between **CARNABY** and **BLAZING OPAL** which both shifted ground. Prior to the authorisation of dividends the connections of **OURS** viewed coverage but elected not to proceed with an objection.

### Race 6 WANGANUI STEELFORMERS 1600

**CRISTAL** began awkwardly losing several lengths.

**LA BECANE** made the first corner very awkwardly and ran **STAR OF GREENBEEL** very wide resulting in both runners losing ground. **LA BECANE** hung throughout and was not able to be competitive. Co-Trainer G Lowry was advised that the gelding must trial prior to its next start.

LA BECANE when hanging was jostled when weakening when runners improved round it near the 600 metres

**GERARDASUN** raced three-wide without cover.

**CRISTAL** lay out when racing greenly and made contact with **GERARDASUN** entering the final straight. **GERARDASUN** was then dictated wider. A short distance further on **CRISTAL** again lay out again making contact with **GERARDASUN**.

Rider K Smith (ZCASTLE) was reminded of his obligations re excessive use of the whip.

Following the race a veterinary inspection of **LA BECANE** revealed significant lameness which will require a veterinary clearance prior to the gelding's next start.

Race 7 DAVE HOSKIN CARRIERS 1600

THE BEAMA and BETTER KEEPER were slow to begin.

**OVERTHERIVER** raced wide rounding the first turn and then raced three-wide for the majority.

**TIE ME DOWN** was inclined to lay out when under pressure in the early part of the home straight.

## Race 8 CIVICS @ CAMBRIDGE THOROUGHBRED LODGE WANGANUI CUP

The connections of **WAIKAHA** requested and were given permission to scratch their runner following the unavailability of a suitable rider.

**ROSE OF VIRGINIA** underwent a veterinary examination at the barriers after being kicked prior to the start and was passed fit to start.

FREDERICK WILLIAM shifted out on jumping crowding GREY GURU out on to VINCENT STREET.

I SUGGEST was slow to begin.

**FREDERICK WILLIAM** was crowded for a short distance passing the winning post on the first occasion when inside **I SUGGEST** (S Wynne) which shifted in. Miss Wynne was advised to exercise care when in similar circumstances.

**TYNE COT** lay in under pressure over the final 250 metres.

LANGDON contacted the heels of TYNE COT and blundered at the entrance of the final straight, when laying out.

### Race 9 CARPET MAINTENANCE & CLEANING 2040

**LETSGETITON** was slow to begin.

**SEALED BY A DANCE** got its head up near the winning post on the first occasion when being restrained to trail and made the turn incorrectly losing ground.

SEALED BY A DANCE hung in when placed under pressure in the early part of the home straight.
