RACE COMMENTS:

Race 1	Avondale Trials @ 8 December 1380
<p>THE FIRE INSIDE (M Coleman) and CASTLE RIDGE (A Collett) were both a little slow to begin. CHIPANDCHASE (D Johnson) lay in early in the final straight becoming awkwardly placed on the heels of CASTLE RIDGE. Approaching the 250 metres PACKING TYCOON (L Magorrian) shifted in when being ridden out crowding and checking CASTLE RIDGE (A Collett) which lost ground. Apprentice Rider L Magorrian was charged under Rule 638(1)(d) to which he pleaded guilty and was suspended from the conclusion of racing on 6 December 2015 up to and including racing on 12 December 2015, 4 riding days.</p>	
Race 2	NZB Insurance Pearl Series Race 1100
Rider S Spratt was dislodged from O'RACHAEL during the preliminary. After being quickly recaptured and ridden to the	

start the filly underwent a pre race veterinary inspection and was passed fit to race.

HOT MOVE (L Innes) and **O'RACHAEL** were both slow away after their respective barrier gates failed to open correctly. As a result **HOT MOVE** also began awkwardly further hampering **O'RACHAEL** with both runners losing several lengths.

A request for a ruling was sought under Rule 632 as to **HOT MOVE** being denied a fair start due to a barrier gate malfunction. After viewing the relevant videos **HOT MOVE** was declared a non runner.

As **O'RACHAEL** had finished in second placing no further action could be taken regarding this runner under the provisions of Rule 632.

LONE WARRIOR (S Collett) was slow away and then was further hampered by **FLAME N FORTUNE** (U Holmquist) which shifted in.

TESIA (C Lammas) began awkwardly.

I AM GRACIE (T Thornton) over-raced through the early and middle stages.

LONE WARRIOR commenced to over-race approaching the 800 metres making the bend awkwardly.

FLAME N FORTUNE raced wide until improving forward to sit outside the leader passing the 800 metres.

Passing the 300 metres **TESIA** when attempting a tight run to the outside of **SKELTER** (M McNab) which was laying out made contact with the hind quarters of **FLAME N FORTUNE** with that runner becoming briefly unbalanced.

HAPI GIRL (A Collett) began awkwardly making contact with **ANTONIO GIUSEPPE** (O Bosson).

WAVE RACER (T Thornton) hung out for a short distance passing the 600 metres when racing keenly and then hung out over the final 200 metres.

VINEVALE (M Cameron) was slow to begin.

LULU (C Dell) began awkwardly and was steadied when being corrected by its rider.

HE ROCKS (S Spratt) raced ungenerously when being steadied in the early stages.

Passing the 800 metres **PENNY BLACK** (L Magorrian) commenced to race ungenerously when being steadied becoming awkwardly placed on the heels of **MACKENZIE KATE** (D Johnson) which shifted out. As a result **PENNY BLACK** then shifted out abruptly forcing **REGINA GIOVANNA** (J Whiteside) wide on the track. **PENNY BLACK** then raced ungenerously when racing wide for the remainder of the race with **REGINA GIOVANNA** being obliged to race four wide for the remainder of the race.

Approaching the 600 metres **ZEANI** (O Bosson) became awkwardly placed on heels and raced ungenerously for a distance.

Approaching the 550 metres **ZEANI** had to steady briefly when becoming awkwardly placed inside the heels of **PENNY BLACK** which lay in.

HE ROCKS had difficulty obtaining clear running early in the final straight.

CONNAUGHT (M Du Plessis) and **HEART BEAT** (L Magorrian) both began awkwardly losing ground.

CINEMATIC (A Collett) began awkwardly and then was further hampered by **GLAMAZON** (A Schwerin) which shifted in abruptly on jumping away.

GLAMAZON raced wide without cover throughout.

JAIDES JEWELL (K Myers) was held up early in the final straight having to shift out near the 300 metres to obtain clear running.

Approaching the 200 metres **HEART BEAT** lay in under pressure and then had to be briefly steadied off the heels of **CINEMATIC** which was taken out by **GLAMAZON**.

Passing the 150 metres **CINEMATIC** lay in under pressure making contact with **GLAMAZON**.

Race 6	Simtrack Overhead Starting Gates 1300

SNEAKYSID (R Norvall) shifted in when leaving the barriers crowding **BANNERMAN** (T Thornton) which had been slow to begin.

I'M ALL EARS (Z Nor Azman) was slow to begin.

LADY PIMPERNEL (A Schwerin) shifted out when leaving the barriers hampering **SAKHEE'S STAR** (U Holmquist).

BANNERMAN raced keenly in the early stages and was obliged to race wide without cover and hung outwards, running wide when making the final bend

LADY PIMPERNEL commenced to lay out under pressure in the final straight inconveniencing **SISTER O'REILLY** (S Spratt) near the 350 metres and then forcing that runner wider on the track before being hampered passing the 200 metres with **SISTER O'REILLY** then having to steady and shift inside **LADY PIMPERNEL** to obtain clear running. **LADY PIMPERNEL** continued to shift out and could not be ridden out over the final 100 metres. Apprentice Rider A Schwerin admitted a resultant breach of careless riding with her license to ride in races suspended by the Judicial Committee 14 – 26 December, inclusive 5 riding days

GOODIEGOODY (T Thornton) and **SOCIETY PRINCESS** (C Lammass) were both slow to begin.

MISTRAHMA (K Myers) began awkwardly and then was steadied.

BRILLEAUX (R Norvall) shifted in abruptly when leaving the barriers crowding **BAMURRU** (S Collett) on to **PROMISE TO PAY** (S Spratt) which was hampered losing ground.

GOODIEGOODY raced keenly in the early stages.

SOCIETY PRINCESS raced keenly approaching the 1000 metres becoming awkwardly placed on heels having to be firmly restrained.

CHANCERY (L Innes) raced wide without cover.

LAUBERHORN (M Hills) made the bend passing the 900 metres awkwardly, shifting out and hampering **VAN GOGH** (M Du Plessis).

FANNY BLANKERS (O Bosson) raced in restricted room over the concluding stages.

Passing the 300 metres **BRILLEAUX** had to steady when in restricted room to the inside of **GOODIEGOODY** which was laying in under pressure.
