RACE COMMENTS:

Race 1 ALLEN TRADING COMPANY 2000

WON TON (D Hirini) was crowded leaving the barriers losing ground.

COUNTDOWN (B Hutton) commenced to over-race near the 1300 metres having to shift wider on the track to avoid heels. **COUNTDOWN** then was obliged to race three wide without cover.

Approaching the 1000 metres **MIO KIWI** (D Nolan) commenced to over-race shifting outwards making contact with **MISS DRAMA QUEEN** (A Collett) which then shifted outwards abruptly away from **MIO KIWI**.

Apprentice B Hutton admitted a charge of careless riding in that he permitted his mount **COUNTDOWN** to shift inwards when not sufficiently clear forcing **PENTIRE BABE** (T Thornton) inwards crowding **ARMANDO** (R Elliot) which was severely checked near the 700 metres. After hearing submissions the Judicial Committee imposed a suspension of B Hutton's licence to ride in races from the conclusion of racing today Sunday 21 February until the conclusion of racing on Sunday 28 February, 4 riding days.

R Elliot was issued with a warning for his whip use on ARMANDO.

Following this race the track was upgraded to Good(3).

Race 2 ELECTRINET MILE

CLIFFORD (R Myers) and **BLACKHAVEN** (L Allpress) came together leaving the barriers.

CLIFFORD raced greenly and ran wide crossing the junction onto the course proper approaching the 1200 metres.

AMPERAGE (A Collett) raced keenly outside the leader through the early and middle stages.

BELLE OF MAPPERLEY (D Nolan) was held up behind the weakening **RATPACK** (B Hutton) near the 600 metres shifting outwards to avoid that runners heels with **CALL ME MAINA** (T Thornton) having to steady as a result.

J Parkes the rider of MACARIO was issued with a warning for his whip use prior to the 200 metres.

When questioned regarding the performance of **AMPERAGE** rider A Collett advised after over-racing the gelding was quickly beaten once placed under pressure early in the final straight. A post-race veterinary examination did not reveal any abnormality.

MACARIO returned to the saddling enclosure with blood present in the right nostril. Following a post-race veterinary examination the filly was deemed not to be classed as a bleeder.

A post-race veterinary examination of **BELLE OF MAPPERLEY** did not reveal any abnormality.

Race 3 CIVIL PROJECT SOLUTIONS 1200

JUST JIFFI (A Jones) was slow away.

ESBEEDEE (L Allpress) jumped away awkwardly hampering **MURASAKI** (D Nolan).

INDY (U Holmquist) over-raced in the early stages and was then wide without cover from near the 1000 metres.

SCOUT (R Elliot) had to be steadied when awkwardly placed on heels approaching the 400 metres.

Race 4 VINTECH PACIFIC LTD SPRINT

STAR OF GREENBEEL (R Myers) was slow away.

HEY MR (C Lammas) jumped away awkwardly hampering **THEDEPOT** (T Thornton).

STEELFIX (U Holmquist), BORN HAPPY (A Jones) and JAIDES JEWELL (D Hirini) all raced wide without cover.

UNCONQUERED (L Magorrian) shifted outwards under pressure over the final 100 metres inconveniencing **PAUA EYES** (R Goldsbury).

THEDEPOT had some difficulty obtaining clear running in the final straight.

Race 5 GILLIES ELECTRICAL & REFRIGERATION LTD 1400

ROGART and **JAYLA MONET** both underwent veterinary inspections at the start following incidents in the mounting yard with both horses being past fit to run.

SUNSPEAR (J Parkes) jumped away awkwardly getting its head up.

CASTLE HILL (R Myers), RED SHEERAN (L Allpress) and HIGHWAYMAN (R Goldsbury) were all a little slow to begin.

JAYLA MONET (V Gatu) began awkwardly making contact with ZEDSATIONAL (D Nolan) further hampering RED SHEERAN.

HIS NIBS (D Hirini) raced three wide without cover.

PANELLA (A Jones) was held up passing the 450 metres.

ROGART (C Lammas) lay out rounding the final turn and early in the straight with **ZEDSATIONAL** which was improving to its outside being dictated wider making contact with **FLAVOURING** (A Collett) which then had to be checked to avoid the heels of **HIS NIBS**.

ASTON PARK (T Thornton) shifted inwards under pressure approaching the 200 metres.

Race 6 GFS-GISBORNE FINANCIAL SERVICES 2000

SOUTHERNMAN (J Parkes) was slow to begin.

NEK MINNIT (V Gatu) began awkwardly making contact with **TEENA ROX** (A Collett).

HILARIOUS (L Magorrian) jumped away awkwardly from the outside barrier.

HILARIOUS raced wide without cover before improving forward to lead near the 700 metres.

SILK CHARDONNAY (A Jones) improved forward wide from the 1000 metres to sit outside the leader near the 700 metres.

CAJUN had to be restrained when awkwardly placed on heels near the 700 metres.

CAJUN shifted inwards under pressure placing **CASEY MARIE** (R Myers) and **BITETHEBULLET** (T Thornton) in restricted room near the 175 metres.

NEK MINNIT was unable to obtain clear running until inside the final 100 metres.

A post-race veterinary inspection of **TEENA ROX** which disappointed did not reveal any obvious abnormality. Rider A Collett was unable to offer any excuses.

Race 7 NARELLAN POOLS NZ POVERTY BAY CUP

SANASAR (J Parkes) and **BROADWALK** (L Magorrian) began awkwardly losing ground with **BROADWALK** then racing very ungenerously shortly after losing further ground.

KEEPING TOM (A Collett) raced three wide without cover.

SCAPOLO raced keenly when being restrained in the middle stages.

COLONEL CARRERA had difficulty obtaining clear running until near the 150 metres.

When questioned regarding the performance of **SANASAR** rider J Parkes was of the opinion that the gelding would now be better suited over more ground.

Race 8 SEE YOU AT LONE STAR GISBORNE MILE

WAIT A SEC (C Lammas) began awkwardly losing ground.

GAGARIN (R Goldsbury) and KRASE (R Elliot) were crowded shortly after the start having to be steadied.

Apprentice L Magorrian defended a charge of careless riding in that he permitted his mount **TAVIGARDE** to shift inwards making firm contact with **MURDOCH** which was forced inwards into the line of **ROUGH RULER** which clipped a heel and

blundered near the 850 metres dislodging rider R Myers. After hearing all relevant evidence and submissions the Judicial Committee found the charge to be proven suspending L Magorrian's licence to ride in races from the conclusion of racing on Sunday 28 February until the conclusion of racing on Thursday 24 March, 14 riding days.

Hampered as a result of this incident were AMUN RA, WAIT A SEC, CHOP SUEY, KRASE and GAGARIN.

R Myers was attended to by Ambulance personnel suffering bruising to the left arm.

TAVIGARDE, which was inclined to lay inwards under pressure in the final straight, shifted inwards inconveniencing **TANIA** near the 350 metres. When looking to obtain clear running **TAVIGARDE** again shifted inwards near the 200 metres hampering the weakening **NOT ALLOWED** (J Parkes). L Magorrian was issued with a warning.

CHOP SUEY (D Hirini) hung inwards throughout the final straight forcing **WAIT A SEC** inwards across the heels of **AMUN RA** near the 300 metres. **CHOP SUEY** was unable to be fully ridden out as a result.
