# **RACE COMMENTS:**

## Race 1 TONY WILSON LIVESTOCK 1200

**FOGARTY FEGEN** shifted inwards abruptly after jumping away losing ground (6 lengths). This resulted in Rider M Dravitzki losing the use of her inside iron for some distance until regaining it near the 900 metres.

**DUVALL** hung throughout the race and as a result could not be ridden out to advantage in the home straight.

**TARDY CHARDY** was held up for a short distance on the home turn.

FOGARTY FEGEN raced greenly in the home straight and had to be straightened by the rider.

**TELLYAWHAT** was inclined to shift in under pressure in the home straight and had to be straightened off the heels of **ELEONORA** near the 50 metres. Rider R Jones reported that **TELLYAWHAT** was feeling the firm track.

Race 2 WANGANUI INSURANCE BROKERS / BULLOCK & ASSOCIATES LAWYERS 1200

**NAUGHTY KNUCKLES** began awkwardly.

**BRITT EKLAND** was momentarily held up in the early part of the home straight.

Race 3 WANGANUI MOTORS 1650

TWO GEE'S raced keenly early and had to be shifted wide to avoid heels in the run along the back straight.

**ACCLAIM** was inclined to shift in under pressure in the home straight and had to be straightened on several occasions.

THE SNOW QUEEN raced in restricted room over the final stages when TWO GEE'S shifted out under pressure. This resulted in THE SNOW QUEEN being dictated out making contact with the hind quarters of VERDI. THE SNOW QUEEN was

accidentally struck over the head in the incident by the whip of the rider of **TWO GEE'S**, R Norvall. After questioning riders and viewing footage of the final stages **R Norvall** was issued with a warning under Rule 638 (1) (d) and advised that he is expected to straighten his mount sooner than he did on this occasion.

**ACCLAIM** sustained superficial cuts after being galloped on during the race.

# Race 4 CR GRACE / TAYLOR PRESTON 1650

**SCAPOLO** had a tendency to over-race in the early stages.

**NIPPIN** returned to the enclosure sore in the near front leg. Connections were advised that a veterinary clearance is required prior to the gelding's next start.

When questioned into the run of **SCAPOLO** Rider H Tinsley stated that the gelding may not have been entirely suited to the Good 2 track and was unable to quicken sufficiently when asked in the home straight.

## Race 5 POWERWORX 1400

MASTER WONG (R Elliot) became fractious in the barrier prior to the start and reared. When initially questioned Starter B Clement advised that in his opinion the gelding had not made contact with any part of the starting apparatus and he was happy to affect a start. However on returning to the enclosure Stewards ordered a veterinary examination of MASTER WONG which revealed two small abrasions – one above the left eyelid and one on the forehead consistent with the gelding having hit its stall when rearing. Rider R Elliot subsequently reported that a buckle on the blinkers on MASTER WONG had broken causing them to have become displaced. Starter B Clement was advised by stewards that in any similar situation in future, he is expected to exercise better judgement and have that runner removed and checked.

#### KINGOFPLATINUM was slow away.

**GILT** over-raced in the back straight.

**GILT** shifted wide under pressure in the home straight.

## Race 6 STEELFORM ROOFING GROUP WAVERLEY CUP 2200

**RED KING** began awkwardly.

When questioned into the run of **CHEESE MAKER** which disappointed, Rider D Hirini had no tangible excuse other than the gelding may not have been suited to the Good 2 track. A subsequent veterinary examination did not reveal any obvious abnormality.

## Race 7 WAVERLEY HARVESTING / BIG BLADE 2200

ARYA was slow away and then was further hampered when the riderless horse shifted inwards into its line shortly after.

**OOEE** commenced to buck shortly after the start and dislodged Rider R Jones who was uninjured. Trainer P Nelson was advised that **OOEE** would require to trial satisfactorily prior to next racing. P Nelson advised that he would make alterations to the gelding's gear prior to its next start.

**MIDNIGHT FLYER** and **PRIORTISE** both over-raced in the home straight on the first occasion. **MIDNIGHT FLYER** then shifted out bumping with **PRIORTISE** when being steadied simultaneously as **CITY EXPRESS** (M Tanaka) shifted in marginally. Rider M Tanaka was advised to exercise greater care.

**KEANDRA** had to be steadied going in to the 1,400 metres to avoid the riderless horse.

MIDNIGHT FLYER had to be steadied when racing upon to heels near the 600 metres.
