#### **RACE COMMENTS:**

 Race 1
 Hydroflow 1400

 HEAD OFFICE (G Cooksley) and THE BRAVE ONE (S McKay) both began awkwardly losing ground.

 PROCRASTINATE (B Hutton) raced in restricted room for a distance passing the 1200 metres and then was obliged to race wide without cover.

**HARDCASE** (A Collett) shifted out passing the 400 metres to obtain clear running making contact with **PROCRASTINATE** which became unbalanced. A Collett was advised she must exercise greater care when shifting ground.

Race 2 Ginde 1300

WILIJONMCBRIDE (L Magorrian) began awkwardly making heavy contact with RAQISA (S McKay).

**QUANTUM** (BR Jones) began awkwardly and then had to steady when crowded.

ASTARA (S Collett) raced ungenerously when being steadied from near the 800 metres.

**SHADOWS** (T Thornton) raced greenly throughout.

**RAQISA** became awkwardly placed on the heels of **WILIJONMCBRIDE** which shifted out approaching the 600 metres. As a result **RAQISA** then shifted back on to **SHADOWS** which was hampered. **WILIJONMCBRIDE** continued to shift out making contact with **CAVALLUCCI** (D Turner) which was forced wider on the track. Apprentice L Magorrian was reprimanded by Stewards and advised he must exercise greater care when shifting ground.

**QUANTUM** had to shift out approaching the 200 metres to obtain clear running.

Race 3 Adesso 2200

**DOURO** (L Innes) was crowded soon after leaving the barriers.

**OCEAN BOUND** (U Holmquist) commenced to over-race for a distance when awkwardly placed inside the heels of **PENTIRE BABE** (T Thornton) which shifted in passing the 2000 metres when not fully clear. Rider T Thornton was issued with a warning and advised she must exercise greater care when shifting ground. **OCEAN BOUND** then over-raced through the middle stages.

When questioned regarding the performance of **DOURO** Rider L Innes was unable to offer any tangible excuses.

Race 4 Raymor 1600

**RULE THE WORLD** (U Holmquist) lay out under pressure approaching the 100 metres inconveniencing **THUNDER DOWN UNDER** (Z Moki).

Race 5 Celebrating Rangipo 1600

PRINCE OF PASSION (L Innes) was slow to begin.

**SANTIAGO** (L Magorrian) shifted in passing the 1400 metres making contact with the hind quarters of **MAXIMUM HEIGHT** (A Jones) which became briefly unbalanced. As a result **SIERRA BEEL** (S Collett) had to briefly steady. Apprentice L Magorrian was advised to exercise greater care.

**SOUND PROPOSITION** (S McKay) raced wide without cover for the majority of the race.

Race 6Te Akau Racing Celebrates Heroic Valour 1200

**MAKARIOS** (L Magorrian) lay in and away from **SCUSA** (L Innes) soon after leaving the barriers crowding **QIKCAT** (A Collett) on to **SHEZA FLOJO** (G Cooksley) which was hampered losing ground. Contributing was outward movement from **VITESSE** (S Collett).

SILENCER (R Elliot) began awkwardly.

**PARISDOTCON** (T Thornton) steadied away from the heels of **DE NIRO** (S McKay) approaching the 1100 metres. As a result **QIKCAT** was crowded on to **VITESSE** which had to steady. Rider S McKay was issued with a warning and advised that he must ensure he is clear when shifting ground.

**SILENCER** was obliged to race wide early stages, before being asked to improve forward.

**DE NIRO** shifted out under pressure hampering **PARISDOTCON** which was steadied near the 50 metres. Rider S McKay was severely reprimanded by Stewards issued with a warning.

Apprentice Rider R Elliot was spoken to regarding his riding tactics adopted aboard **SILENCER** with R Elliot explaining he had been asked to ride **SILENCER** in a forward position and after beginning fairly he then tried to ride the mare forward becoming trapped wide.

SILENCER lost the right hind plate during the running.

### Race 7 80's & 90's Party @ Ellerslie 23<sup>rd</sup> April 1200

Trainers L O'Sullivan and A Scott were issued with a warning after **FASCINATION STREET** was presented to race with incorrect gear.

There was a delay to the start of the running of this event due to **STATHAM** requiring farrier attention at the start. There was a further delay due to **BLACK MASCARA** (T Thornton) being removed from the barriers after becoming awkwardly positioned then refusing to re-enter, being a late scratching at 3.45pm. The connections were advised that **BLACK MASCARA** will be required to barrier trial to the satisfaction of Stewards prior to racing next. **SHEZHARDTOCATCH** (L Satherley) was crowded when leaving the barriers, losing ground.

**CAELLUM** (A Collett) began awkwardly.

**AAJA NACHLE** (Z Nor Azman) was steadied passing the 1100 metres when in restricted room to the inside of **PROCUREMENT** (L Magorrian) which shifted in. L Magorrian was advised to exercise greater care.

Approaching the 1000 metres **FASCINATION STREET** (S Collett) was steadied when racing in restricted room to the inside of **FULLY FUNDED** (BR Jones).

**STATHAM** (G Cooksley) raced wide without cover throughout.

**SHEZHARDTOCATCH** became awkwardly placed passing the 400 metres when attempting a run to the inside of **AAJA NACHLE** which shifted in simultaneously. **SHEZHARDTOCATCH** was then steadied and shifted to the outside of **AAJA NACHLE** to obtain clear running.

SPOKE TO CARLO (L Innes) lay in when placed under pressure early in the final straight.

**FULLY FUNDED** was briefly held up when looking to obtain clear running near the 200 metres.

**PROCUREMENT** shifted out under pressure over the final 100 metres.

Race 8 Mico 1600

**DALEZINGA** (D Turner) began awkwardly.

**NAILED IT** (L Satherley) became awkwardly placed on heels when the pace steadied passing the 1100 metres and shifted back on to **UNDISCOVERED** (G Cooksley) which had to shift off that runner's heels and was obliged to race three wide.

WAIPIPI LAD (BR Jones) over-raced in the middle stages.

When shifting out to obtain clear running approaching the 200 metres **SNOW SECRET** (B Hutton) made brief contact with **DALEZINGA** which shifted in slightly.

Race 9 Auckland Co-op Taxis 1400

**SISTERHOOD** (T Thornton) was crowded soon after leaving the barriers.

MIGHTY ME (BR Jones) was slow to begin.

**COHABITATE** (D Turner) was hampered when leaving the barriers.

**ANNABELINDA** (S McKay) commenced to over-race when being steadied passing the 1200 metres and continued to race ungenerously through the middle stages.

**OPERA KNIGHT** (R Elliot) over-raced for a distance passing the 1200 metres.

BONNY EMILIA (G Cooksley) and SISTERHOOD both raced keenly through the middle stages.

YOUWANTMORE (S Collett) raced ungenerously in the early and middle stages.

**SISTERHOOD** was held up rounding the final turn and early in the final straight, shifting out passing the 200 metres to obtain clear running.

**HEART OF TH'CASTLE** (A Collett) commenced to give ground appreciably when placed under pressure approaching the 400 metres with **HEART OF TH'CASTLE** then laying in passing the 350 metres simultaneously as **BITETHEBULLET** (L Magorrian) shifted in to avoid that runner's heels. As a result **BITETHEBULLET** shifted into the line of **ALL THE ANSWERS** (Z Moki) which clipped a heel and blundered and when recovering, then clipped a heel of **HEART OF** 

**TH'CASTLE** and blundered again. **HEART OF TH'CASTLE** was then eased down and underwent a veterinary examination following the race which found the filly to have suffered from cardiac arrhythmia with Trainer W Larsen

being advised that he must provide a clear ECG for **HEART OF TH'CASTLE** following a trial.

Following the race a veterinary examination of **BITETHEBULLET** revealed abrasions of the right hind cannon.

ALL THE ANSWERS underwent a veterinary examination following the race which could find no abnormalities.

**HEART OF TH'CASTLE** lost the right hind plate during the running.

**BONNY EMILIA** lost the right front plate during the running.
