## SUPPLEMENTARY:

<b>South Canterbury RC – Friday 18 March 2016</b> <b>Race 5 – Port FM Rating 65 1600</b> An inquiry into the fall of <b>HOT PROPERTY</b> (S Wynne) which clipped heels near the 250 metres was concluded. It was established that <b>HOT PROPERTY</b> which had been attempting a marginal run between <b>HIGH SOCIETY</b> (K Kalychurun) and <b>I'LLBEYOURPLATINUM</b> (R Black) was bumped by <b>HIGH SOCIETY</b> when that runner shifted outwards slightly when struck with the whip resulting in <b>HOT PROPERTY</b> then becoming awkwardly placed on the heels of <b>I'LLBEYOURPLATINUM</b> which then shifted inwards slightly. In the circumstances it was not felt that any rider had been culpable of riding carelessly.

## RACE COMMENTS:

<b>Race 1</b>	<b>DAN REARDON RACING STABLES RATING 75 (2000m)</b> <b>MOONOFKLAIRESSA</b> and <b>MORGAN BET</b> began awkwardly and came together shortly after the start. <b>MOONOFKLAIRESSA</b> over raced in the early stages. <b>SHOW MACCOOL</b> was crowded leaving the barriers between <b>MCMAY</b> and <b>SOUTHERN RAIDER</b> and got back as a result. <b>SHOW MACCOOL</b> then raced wide in the early and middle stages. <b>MORGAN BET</b> (J Lowry) lay in rounding the turn near the 1600 metres, making contact with <b>THE REAL DEAL</b> causing crowding to <b>KIRINA BELLE</b> which was forced inwards, resulting in <b>MCMAY</b> having to be steadied and dropping back onto <b>ROSHEEN</b> which was hampered having to be checked. J Lowry was advised to exercise greater care.

**KOLAMAN** raced wide rounding the turn into the back straight near the 1600 metres and commenced to over race then improving forward to lead near the 1200 metres. When questioned regarding his riding tactics on **KOLAMAN**, apprentice D Chin stated that his instructions had been to obtain cover in the early stages but after being unable to do so the gelding had commenced to race fiercely and he had been unable to get the gelding to come back to him.

**SHOW MACCOOL** was briefly crowded when weakening near the 150 metres.

Apprentice rider K Kalychurun reported that **THE REAL DEAL** had hung throughout.

Rider R Black reported that **MOONOFKLAIRESSA** had felt indifferent in its action on pulling up and may have been mildly distressed. A post race veterinary inspection of **MOONOFKLAIRESSA** did not reveal any apparent abnormality.

When questioned regarding the performance of **SOUTHERN RAIDER**, rider M Chui advised that the mare had never travelled on the bit and had been disappointing.

**Race 2** | **CANTERBURY EQUINE CLINIC TWO-YEAR-OLD (1000m)**

**S Wynne** replaced J Lowry on **GEMMA JANE** when J Lowry was 0.5 kg overweight.

**FLO JOH'S BABE** shifted inwards on jumping causing tightening to **THISTIGERDIDIT**, **LA DIOSA** and **GEMMA JANE** which was checked losing ground.

**DISTURBANCE** got it head up and raced keenly in the early stages.

**THISTIGERDIDIT** (D Chin) raced three wide without cover, running wider rounding the final turn. Apprentice D Chin was spoken to and advised that he must make a greater attempt to prevent his mounts shifting wider than necessary, allowing other runners to improve to his inside.

**RESIDENTIAL** had difficulty obtaining clear running throughout the final straight. Apprentice K Mudhoo was spoken to regarding the manner in which he had persisted in attempting to obtain a run to the inside of **STROWAN** when there had been insufficient room to do so.

Apprentice **K Mudhoo** admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 200 metres being fined the sum of \$250 by the Judicial Committee.

Apprentice **R Cuneen** (**DISTURBANCE**) had his whip knocked out of his hand approaching the 200 metres.

**Race 3** | **THE PAUL MURPHY BULLERITES PETERSENS JEWELLERS LADIES BRACELET 3YO (1000m)**

**PASSAMAQUODDY** was slow to begin.

**FINAL SAY** shifted outwards on jumping, making contact with **FLYTIME** which then bumped with **SNIPARINDA** resulting in **FIRST SERVE** also being hampered.

**FIRST SERVE** over-raced in the early stages and had to be steadied when becoming awkwardly placed on the heels of **ENZO'S LAD** near the 400 metres.

**SNIPARINDA** was held up passing the 400 metres until near the 150 metres.

**ENZO'S LAD** raced wide throughout.

**ENZO'S LAD** shifted outwards under pressure making contact with **FIRST SERVE** approaching the 100 metres.

**Race 4** | **SELWYN RAKAIA VET SERVICES OPEN HANDICAP (1200m)**

**CLARA JANE** jumped away awkwardly and then got its head up and raced ungenerously while being restrained shortly after the start.

**RED DIRT GIRL** and **KINAGAT** over raced in the early stages.

**MADAME JAMAI** over raced when being restrained in the early to middle stages.

**MADAME JAMAI** was held up early in the final straight and continued to have difficulty obtaining clear running for the remainder of the race.

Apprentice **A Chan** (**KING MONTROSE**) dropped his whip near the 300 metres. **KING MONTROSE** was inclined to shift ground outwards throughout the final straight, making contact with **KINAGAT** near the 200 metres.

**Race 5** | **YALDHURST WOOLS & NZWTA LTD BENCHMARK 75 (1400m)**

The start of this race was delayed due to **LETSAVAFLING** being reluctant to parade to the start with a further delay when **BIG HOSS** was declared a late scratching at 2.54 pm on veterinary advice after behaving in a very unruly manner prior to loading. The connections were advised that **BIG HOSS** is required to trial to the satisfaction of a Stipendiary Steward prior to racing next.

**BRUEGEL** began awkwardly and got back as a result.

**LETSAVAFLING** began awkwardly and shifted outwards on jumping, inconveniencing **BACK IN THE DAY**. **LETSAVAFLING** then over raced in the early stages.

**PAINTBALL** shifted inwards in the early stages and made contact with **KASUNDI**.

**BRUEGEL** over raced badly in the early stages.

**BRUEGEL** and **PAINTBALL** raced wide throughout.

**BRUEGEL** hung outwards rounding the turn. **BRUEGEL** then commenced to lay in in the final straight, with rider M Chui swapping his whip to the right hand near the 200 metres and in doing so dropped his left rein having to regather. M Chui advised that the gelding raced greenly throughout.

**PAINTBALL** and **KASUNDI** came together on a number of occasions in the final straight when both runners shifted ground under pressure. Riders D Chin and G Jogoo were advised to exercise greater care.

When questioned regarding the poor performance of **LETSAVAFLING**, apprentice rider S Wynne was of the opinion that the filly's reluctance to parade may have had an adverse effect on its performance, and added that the mare would be better suited with more easing of the ground. A post race veterinary inspection of **LETSAVAFLIGHT** did not reveal any obvious abnormality other than an elevated heart rate. Trainer L Robinson indicated that **LETSAVAFLING** would now be freshened.

**Race 6** | **SEATON FAMILY MEMORIAL HORORATA GOLD CUP (1800m)**

**TIMY TYLER** raced keenly in the middle stages.

**EL CHICO** was held up in the early stages of the run home.

When questioned regarding the performance of **KAHARAU**, rider T Moseley advised that the gelding had been freshened after last racing on 6 February, had travelled well throughout today's race and initially responded once placed under pressure before only battling over the concluding stages. T Moseley added that in his opinion the gelding would derive benefit from today's race. Co-trainer K Rae advised that he had been disappointed with the performance of **KAHARAU** today but at this stage would be pressing on with its preparation.

**Race 7** | **R REDPATH LIMITED BENCHMARK 65 (1800m)**

**MISTER SPIDERMAN** was slow to begin before being further hampered by **CLEM** which was taken out by **THE MAN**.

**LION ROCK HILL** raced wide and without cover throughout.

**VELLUTO** was held up rounding the final turn passing the 600 metres before obtaining clear running near the 350 metres.

**CANTINA** was held up rounding the final turn and continued to have clear difficulty finding clear running throughout the final straight.

**I'LLBEYOURPLATINUM** was held up in the early stages of the run home.

Passing the 200 metres **AVOW** which was weakening had to be steadied when crowded for room between **CLEM** and **LA MUSIQUE**.

**LION ROCK HILL** was eased down over the concluding stages, with rider L Callaway reporting that the gelding felt indifferent in its action. A post race veterinary inspection of **LION ROCK HILL** found the gelding to be slightly lame.

**Race 8**

**BRIDGET TOWN** required farrier attention behind the barriers causing a delay to the start of this race.

**IT AINT OVER** was slow to begin.

**BRIDGET TOWN** shifted outwards on jumping away making contact with **MERCI CHERIE**. **BRIDGET TOWN** and **MERCI CHERIE** were then inconvenienced by **COULEE** which lay outwards in the early stages.

Near the 1200 metres **LOCKET** (G Jogoo) shifted inwards when not fully clear of firstly **CHARMONT** and then **FEELIN THE LOVE** which both had to be steadied. Apprentice G Jogoo was issued with a warning and advised to ensure he is fully clear when shifting ground in future.

**ILLUMINATI** over raced when being restrained near the 1200 metres.

**CHARMONT** had to be steadied when crowded for room by **THE DIAMOND ONE** (D Bothamley) near the 1000 metres. D Bothamley was issued with a warning. **FEELIN THE LOVE** which was racing in restricted room to the inside of **CHARMONT** reacted poorly when being restrained, raced ungenerously getting its head up and laying out away from the running rail.

**FEELIN THE LOVE** made the bend awkwardly approaching the 600 metres and shifted outwards with **FEELIN THE LOVE** continuing to have a tendency to lay out rounding the bend.

**Race 9**

**HALO PETE** was slow to begin.

**MOREIRA** began awkwardly.

**FLAG THE GROOM** raced ungenerously when being restrained approaching the bend near the 1000 metres.

**M Chui** admitted a charge of careless riding in that he angled his mount **QUEEN SERENE** outwards passing the 400 metres when there was insufficient room to do so, forcing **WHERE'S STEVIE** outwards resulting in **FUGAWI** being checked and making contact with the hindquarters of **MOREIRA**, with **OPIHI RANGER** also being hampered. M Chui was suspended by the Judicial Committee from the conclusion of racing today until the conclusion of racing on Saturday 9 April, 2 riding days. An inquiry was opened and adjourned into the use of the whip by **P Shaikh** (PRINCE RANSOM) in the final straight, as his employer had left the course.

**OPIHI RANGER** was inclined to lay inwards under pressure throughout the final straight with rider **R Black** dropping her whip passing the 100 metres.
