RACE COMMENTS:

Race 1 GARRARD'S HORSE & HOUND 1580

TWO GEE'S (M Dravitzki) began awkwardly shifting out making contact with I SEE FIRE (S McKay) which had also began awkwardly shifting that runner outwards making contact with the hind quarters of **MATANGI BOY** (Z Moki) which became briefly unbalanced crowding **LICAVOLI** (V Gatu) which lost ground.

COLOMBIAN PRINCE (A Jones) stumbled badly on jumping away shifting outward making firm contact with **LADY FERNER** (L Magorrian).

Shortly after the start **LADY FERNER** shifted in crowding **READY TO RUMBLE** (A Sims). L Magorrian was advised to exercise care.

I SEE FIRE and LADY FERNER came together on two occasions near the 1400 metres with LADY FERNER then commencing to over-race through the middle stages.

LICAVOLI raced three wide without cover throughout.

LADY FERNER was denied clear running near the 200 metres, with **LADY FERNER** then shifting inwards inconveniencing **READY TO RUMBLE** (A Sims) and being further held up for the remainder of the race.

Race 2 PAPER PLUS & TOYWORLD TE AWAMUTU 1400

CUTTING UP ROUGH (Z Nor Azman) began awkwardly.

LOVE GAME (U Holmquist) began awkwardly shifting out making contact with **CELLAR** (L Magorrian) with that runner shifting away then making contact with the hind quarters of **ROCKSUN** (S McKay) which became briefly unbalanced.

LOVE GAME over-raced in the early stages making the 1100 metre bend awkwardly.

LOVE GAME was steadied when awkwardly placed on the heels of **CELLAR** which shifted in approaching the 400 metres. L Magorrian was issued with a warning.

SHAMELESS (D Danis) and CELLAR came together entering the final straight.

CELLAR was steadied when crowded between **SHAMELESS** and **CUTTING UP ROUGH** which both shifted ground near the 175 metres.

Race 3 TE ATA REST HOME 1150

JESSICOVA (V Gatu) began awkwardly, and then was further hampered losing ground (3L).

MADDEE FAE (R Elliot) made the bend near the 800 metres awkwardly.

NIGHT VOYAGE (S McKay) lay in making contact with **SENASSY** (Z Nor Azman) near the 300 metres. **NIGHT VOYAGE** then lay in under pressure throughout the final straight.

SENASSY shifted in under pressure over the concluding stages forcing **HUSH LITTLE SISTA** (D Danis) into the line of **MOONLIGHT SONG** (A Jones) which had to steady.

Race 4 CROWE HORWATH 1150

SHONALI (L Magorrian) began awkwardly losing ground.

LUPITA (S McKay) shifted in shortly after jumping away dictating **BUFFALO JOE** (V Gatu) in on to **ENDEAN EXPRESS** (B Hutton) which was crowded having to be steadied. S McKay was issued with a warning.

SHONALI lay out rounding the bend passing the 800 metres.

COLOURFUL ACHIEVER (R Elliot) shifted out abruptly near the 600 metres before being straightened.

SHONALI was steadied when awkwardly placed on heels near the 400 metres.

WINDSTORM (A Jones) shifted out slightly near the 300 metres placing SHONALI in restricted room.

Race 5 TIMMO'S ITM 2000

KEANDRA (M Dravitzki) began awkwardly and had to steady shortly after becoming awkwardly placed inside the heels of **SKY IDEA** (Z Moki).

SOUTHERN POWER (A Jones) shifted out passing the 1000 metres, and then raced three wide without cover for the remainder of the race.

SKY IDEA shifted out to obtain clear running near the 500 metres making contact with **STRAIGHT FURROW** (B Hutton) for a distance.

Race 6 NZB INSURANCE PEARL SERIES RACE 1150

Apprentice M Dravitzki admitted a charge of careless riding in that she permitted her mount **THE SECRET'S OUT** to shift outwards when not sufficiently clear of **THE KEEPT LADY** (L Magorrian) which was checked near the 250 metres. After hearing submissions the Judicial Committee suspended Ms Dravitzki's licence to ride in races from the conclusion of racing on Saturday 9 April until the conclusion of racing on Saturday 23 April, 3 riding days.

Apprentice A Jones was questioned regarding her riding tactics in the early and middle stages when outside the leader on a strong pace. Miss Jones stated that her mount **A'LAROSE** which was resuming from a long spell had raced very keenly but agreed with Stewards that she had erred in not making a greater attempt to restrain the mare in the early stages.

Race 7 NZB INSURANCE PEARL SERIES RACE 1400

Permission was granted for **ORANGE ROUGHIE** (U Holmquist) to race without blinkers as notified.

LIKEWISE (A Sims) began awkwardly, and then was further hampered when **SPAWN OF ELAIA** (V Gatu) shifted in with **LIKEWISE** having to be steadied losing ground.

INDIAN MAID (L Magorrian) began awkwardly shifting in hampering **CAPISTRANO PEARL** (M Dravitzki) which had to be steadied losing ground.

CAPISTRANO PEARL had to be briefly steadied near the 1000 metres when awkwardly placed inside the heels of **INDIAN MAID**.

SPAWN OF ELAIA raced wide without cover from the 1000 metres.

Race 8 NIGEL PITCON AUTO ELECTRICAL 1580

HUSHED (H Noorman) completed a circuit of the track at a moderate pace during the preliminary before being pulled up, and on returning to the barriers underwent a pre-race veterinary inspection being passed fit to run.

NATHALIE FALMET (S McKay) was slow to begin (3L).

HUSHED began awkwardly shifting in making firm contact with **BEAR** (L Magorrian) with apprentice Noorman being unbalanced. **HUSHED** then shifted out making contact with the hind quarters of **ARCHDUCHESS** (B Hutton) which became unbalanced.

MY PALOMA (M Dravitzki) over-raced in the early stages.

CELTIC BOY (U Holmquist) raced wide without cover throughout.

HUSHED lay out rounding the bend near the 600 metres with **BEAR** then improving to its inside. **HUSHED** then raced in restricted room between **BEAR** and **ARCHDUCHESS** for a distance before clipping a heel of **ARCHDUCHESS** near the 400 metres and blundering badly dislodging its rider. Badly hampered as a result were **MY PALOMA** and **NATHALIE FALMET.**

Apprentice Noorman was attended to by the Course Doctor and Ambulance Personnel being transferred to Waikato Hospital for further evaluation of possible shoulder/rib injuries. **HUSHED** was uninjured. As Stewards were unable to
