## RACE COMMENTS:

Race 1	West Brook Winery 1400
<p><b>PRAISE DAN</b> (S McKay) was crowded when leaving the barriers, losing ground.</p> <p><b>MIK JAGGER</b> (S Collett) jumped away awkwardly crowding <b>BATTLEFIELD</b> (U Holmquist) on to <b>CALL ME BOB</b> (K McCulloch) with <b>CALL ME BOB</b> being further hampered by <b>COPPER COATED</b> (L Satherley) which shifted inwards when leaving the barriers.</p> <p><b>COPPER COATED</b> and <b>PRAISE DAN</b> raced ungenerously when being restrained in the early stages with <b>PRAISE DAN</b> continuing to over-race in the middle stages, being allowed to improve forward to lead near the 800 metres. Passing the 400 metres <b>READY TO DREAM</b> (C Lammas) lay in becoming awkwardly placed on the heels of <b>CALL ME BOB</b> having to be briefly steadied.</p> <p><b>KNIGHTS VALLEY</b> (B Hutton) lay in under pressure passing the 250 metres inconveniencing <b>CALL ME BOB</b>.</p> <p><b>Rider K McCulloch</b> advised following the race that she was feeling unwell and after being attended to by St John</p>	

Ambulance personnel was stood down from her remaining rides.	
<b>Race 2</b>	<b>Nankang Tyres 2000</b>
<p><b>KALINDA</b> (L Magorrian) was slow away.</p> <p><b>IRISH GEM</b> (S Collett) got its head up when being restrained going into the first turn near the 1800 metres.</p> <p><b>KALINDA</b> had to shift out approaching the 1000 metres when becoming awkwardly placed on the heels of <b>SING FOR THE SUN</b> (V Ravikumar).</p> <p><b>WAJA</b> (L Satherley) had to steady and shift inwards passing the 400 metres when becoming awkwardly placed on the heels of <b>LUCKY RUBY</b> (T Thornton).</p> <p><b>MR DOOLE</b> (H Moki) lay out under pressure over the final 250 metres.</p>	
<b>Race 3</b>	<b>The Lew Gordon 2000</b>
<p><b>SO TRUE</b> (S McKay) initially refused to leave the barriers on terms with the field eventually jumping away losing considerable ground (10L). Trainer Mrs K Fursdon was advised that <b>SO TRUE</b> is required to barrier trial satisfactorily prior to racing next.</p> <p><b>HEEZA DREIMER</b> (T Wenn) improved forward when wide to lead passing the 1800 metres the gelding got its head up and ran wide around the bend until approaching the 1400 metres then settled in mid field.</p> <p><b>ROYAL SCEPTRE</b> (V Gatu) raced wide without cover for the majority of the race.</p> <p><b>CAN YOU HEAR ME</b> (V Colgan) raced ungenerously when leaving the straight on the first occasion and continued to before settling passing the 1400 metres.</p> <p><b>Apprentice Rider T Wenn</b>, the rider of <b>HEEZA DREIMER</b>, was reminded of her obligations when riding her mounts out to the finish of a race.</p> <p>When questioned regarding the performance of <b>LORIGGIO</b> Rider L Magorrian advised that the gelding had hung badly throughout. A post race veterinary examination did not reveal any obvious abnormality. Co-trainer Mr P Williams indicated that the gelding will now be sent for a spell.</p> <p><b>CAN YOU HEAR ME</b> was not persevered with in the final straight with Rider V Colgan advising that the gelding had been a beaten runner prior to the home turn. A post race veterinary examination found the gelding to have blood present in the nostril area with an endoscopic examination confirming <b>CAN YOU HEAR ME</b> as a bleeder, now subject to the mandatory 3 month stand down from racing with a veterinary clearance required prior to trialing or racing next.</p> <p>Rider M Cameron advised that his mount <b>ALL THE DRAMA</b> had not felt comfortable in today's holding track conditions.</p>	
<b>Race 4</b>	<b>GCS Logistics International Freight 2000</b>
<p><b>SHE'S ALL CLANG</b> (V Colgan) jumped in the air at the start losing ground.</p> <p><b>STAGEHAND</b> (T Wenn) was slow away.</p> <p><b>MARTINI LASS</b> (C Lammas) jumped away awkwardly having to be steadied when becoming awkwardly placed on the heels of <b>SPAWN OF ELAIA</b> (L Magorrian).</p> <p><b>JEM RUNNER</b> (S Spratt) made the first turn near the 1800 metres awkwardly, running wide forcing <b>MARTINI LASS</b> over extra ground.</p> <p>Approaching the 600 metres <b>LIKEWISE</b> (R Scott) became awkwardly placed on the heels of the weakening <b>BIG 'N' RICH</b> (T Thornton) losing ground as a result.</p> <p><b>JEM RUNNER</b> lay out under pressure over the final 300 metres having to be straightened on at least two occasions.</p>	
<b>Race 5</b>	<b>AJC Members 1200</b>
<p><b>CRITICS CHOICE</b> (V Gatu) and <b>MANDILARIA</b> (L Satherley) jumped away awkwardly, losing ground.</p> <p><b>WHERE THERES SMOKE</b> (T Wenn) began awkwardly when jumping inwards at the start.</p> <p><b>SMOOCHY</b> (Z Nor Azman) and <b>FLORENCE IN FRANCE</b> (S McKay) were slow to begin.</p> <p>Near the 900 metres <b>BELLE OF SAKHEE'S</b> (A Schwerin) made contact with the running rail when crowded to the inside of <b>SOLMIZATION</b> (M Cameron) which lay inwards.</p> <p>Near the 900 metres <b>RIGHT SAID FRED</b> (R Scott) made contact with the running rail becoming unbalanced for a short distance.</p> <p><b>BEAUTY'S ROSE</b> (S Weatherley) commenced to lay in under pressure passing the 400 metres and approaching the 300 metres made firm contact with <b>JUSTRUSH</b> (V Colgan) which was shifting out to obtain clear running with <b>BEAUTY'S ROSE</b> continuing to race greenly for the remainder of the race.</p> <p>Approaching the 250 metres <b>JUSTRUSH</b> had to be steadied for a short distance when awkwardly placed on the heels of <b>RIGHT SAID FRED</b> which shifted out under pressure.</p> <p><b>CRITICS CHOICE</b> was held up over the concluding stages.</p>	
<b>Race 6</b>	<b>AJC On Facebook 1200</b>
<p><b>CONRWIN</b> (A Schwerin) jumped in the air at the start losing ground.</p> <p><b>SONO VELOCE</b> (G Cooksley) was slow away.</p> <p><b>LATIN ROSE</b> (M Cameron) shifted out shortly after jumping away making firm contact with <b>SHEBANG</b> (B Hutton) which was crowded having to be steadied.</p> <p>Approaching the 900 metres <b>PERSUASIVE</b> (S Weatherley) shifted in when not clear of <b>LATIN ROSE</b> which was badly</p>	

hampered, shifting in abruptly with **SHEBANG** having to be steadied as a result. Apprentice Rider S Weatherley admitted a breach of careless riding under Rule 638(1)(d) and was suspended by the Judicial Committee from the conclusion of racing on 20 July 2016 up to and including racing on 27 July 2016, 4 riding days.

Passing the 450 metres **PERSUASIVE** when attempting to improve forward became awkwardly placed on the heels of **PRINCESS NICOLE** (U Holmquist), clipping a heel and blundering.

**PERSUASIVE** shifted in to obtain clear running passing the 250 metres and was held up until passing the 200 metres before obtaining clear running.

**CONRWIN** lay out under pressure over the final 150 metres.

**UABASSO** (L Magorrian) underwent a veterinary examination at the barriers after an incident in the tie-up stall prior to leaving the Bird Cage and was subsequently late scratched at 3.48pm.

**PRINCESS RAAJ** (R Elliot) was slow away.

**LORD SNOW** (C Lammas) lay out under pressure in the final straight.

**BETTERBEGOOD** (R Scott) raced in restricted room near the 50 metres.

<b>Race 8</b>	<b>Goodwin Property Management 1600</b>

**NULLA CREEK** (Z Nor Azman) blundered when leaving the barriers.

**ALL THE ANSWERS** (S Collett) shifted out when leaving the barriers with **EEZEMOOVA** (R Scott) shifting away from that runner crowding **CARDON BOY** (T Wenn) which made contact with **ODISHA** (V Colgan) which had begun slowly.

**DARCI GLITTER** shifted in abruptly from the outside barrier crowding **KINGSGRAVE** (M Coleman), **SINGLE SHOT** (V Gatu), **RUBEE** (T Thornton), **SPRITZ** (M Cameron) and **ROCKET QUEEN** (C Lammas) all of which were hampered to varying degrees with **SPRITZ** and **ROCKET QUEEN** losing ground.

**EEZEMOOVA** had to steady when racing in restricted room to the inside of **ALL THE ANSWERS** passing the 700 metres which was taken in by **EL LUCHADOR** (R Elliot) which shifted in when placed under pressure. Apprentice Rider R Elliot was advised he must exercise greater care.

Rider G Cooksley reported that **DARCI GLITTER** had hung throughout and as a result could not be ridden out fully.
