RACE COMMENTS:

Race 1	DE GEEST CONSTRUCTION R65 1600M
PASSAMAQUODDY began awkwardly and lost ground. DRUMGOLD shifted in at the start crowding IVANSKAVINSKYSKVAR which lost ground. PASSAMAQUODDY had to be steadied off heels passing the 1300 metres when racing keenly. The saddle slipped forward on DRUMGOLD in the early stages with rider T Moseley electing to shift ground outwards at the	

1100 metres taking **HABITUDE** wider on the track at this point. **DRUMGOLD** was then allowed to stride forwards to sit outside the leader. **I'LLBEYOURPLATINUM** raced wide throughout and got its head up when being steadied passing the 800 metres. **MIDNIGHT CAPPA** raced keenly through the middle stages.

Passing the 850 metres **BORN A ROYAL** shifted outwards when insufficiently clear of **HABITUDE** who was checked. Apprentice A Chang admitted a breach of Rule 638(1)(d) Careless Riding with the JCA imposing a suspension of 2 days from the 23 July up to and including 4 August 2016. **BORN A ROYAL** then shifted ground back inwards momentarily crowding **CRISTALLO** and **BLUE POOL BLUR** passing the 700 metres.

Race 2	LIQUORLAND OAMARU R65 1600M

ODI ET AMO and **HOT PANTS** were slow to begin. **STOKERS ROCK** began awkwardly. **MORGAN BET** began awkwardly and lost ground.

STOKERS ROCK raced wide without cover in the early stages. **DIVA'S HALO** raced keenly in the early stages. **SHANTAV** raced wide throughout. **REGALO REAAL** gave ground from the 700 metres.

Passing the 350 metres **HOT PANTS** shifted ground outwards dictating the **THE LION QUEEN** outwards onto **LINDIS PASS** who was forced outwards into the line of **SHANTAV** who had to steady. R Yatim was issued with a warning under Rule 638(1)(d) Careless Riding.

HOT PANTS and **THE LION QUEEN** brushed on a number of occasions over the concluding stages.

STOKERS ROCK lay out throughout the run home and could not be ridden to full advantage over the final 100 metres and in the shadows of the post momentarily crowded **PATRICK ERIN**.

Race 3	MCKEOWN GROUP LTD MAIDEN 1200M

S Muniandy reported to the Stewards that he was unwell and was stood down by the paramedics for his remaining rides and was replaced as per the schedule above.

SUNFLOWER began awkwardly. **MOTHER SUPERIOR** was slow to begin. **CIVIC RECEPTION** raced wide through the early stages. **FLYING SARDINE** was slow through the early stages.

SUNFLOWER (M Chui) shifted inwards when under pressure passing the 75 metres resulting in the improving **FLYING SARDINE** having to be steadied and as a consequence was held up over the concluding stages. M Chui was advised to exercise greater care.

Also at this point **OUR CHARLIE** shifted inwards under pressure and had to be straightened.

When spoken to regarding the improved performance of **SUNFLOWER** trainer A Carston advised the improvement was due to the addition of blinkers today.

Race 4	BRACKENS PRINT LTD 2YO 1200M

The start of this event was delayed due to runners arriving late at the start area and several runners proving difficult to load.

WIZE ACT was slow to begin. **ZAKYNTOS** was crowded at the start when runners either side shifted ground. **PICKUP** was crowded shortly after the start and had to steady.

ZAKYNTOS got its head up when making the bend by the 900 metres awkwardly.

DIAMOND CORTZ raced wide for the majority of the event and lay in early in the run home with rider K Mudhoo using the whip in the left hand.

Passing the 800 metres **GALISINI** had to be steadied away from heels when racing keenly and in doing so resulting in the trailing **WIZE ACT** having to be heavily restrained at this point.

ZAKYNTOS also lay outwards rounding the home bend. Passing the 300 metres **GALISINI** had to be steadied when improving onto the heels of **REALLY SOMETHING**.

Rider S Wynne (**WIZE ACT**) reported that her mount had felt indifferent in its action throughout the running Stewards ordered a post-race veterinary inspection of **WIZE ACT** which revealed no abnormalities.

Race 5	NZB INSURANCE PEARL SERIES RACE R65 1200M

There was a delay to this race due to the runners arriving late at the start area.

ELUSIVE BOXERS and **ENTREE** raced very wide into the first bend with **ENTREE** racing wide throughout.

ARYACRAZY had to be steadied racing into the bend at the 900 metres when crowded by **MARGARITA MOVER** which shifted in marginally and **FADE TO GREY** which lay out momentarily. **ARYACRAZY** had to be steadied again passing the 700 metres when racing keenly and improving onto the heels of **MARGARITA MOVER**.

The saddle on **ENTREE** slipped backwards passing the 600 metres with rider K Mudhoo being unable to ride his mount to any advantage from this point in the race.

Race 6	GLENMOA FARMS LTD WAITAKI RIVER TROPHY OPEN HCP 1200M

FIVE KINGS stood in the barriers as the start was affected eventually jumping 200 metres behind the rest of the field losing

all chance. The connections of **FIVE KINGS** were advised the gelding must barrier trial to the Stewards satisfaction. **STARLIGHT ANGEL** got its head up when being steadied in the early stages. **SIGNIFY** raced greenly rounding the final bend. **SOMETHINGS BURNING** lay out in the concluding stages and made contact with **SIGNIFY** in the shadows of the post.

Race 7	RON WILLIAMSON R75 1400M

Rider D Bothamley admitted a breach of Rule 330(3)(c) in that he failed to make the contract weight for **DOCTOR EDEN** and was replaced by T Moseley, with the JCA imposing a fine of \$100.

BACK IN THE DAY was slow to begin.

TOMMYRA had to be steadied outwards off heels passing the 400 metres.

ZUCCHERO lay out throughout the run home taking **ENZEDJEWEL** and **MARE MIA** wider on the track passing the 250 metres mark.

LUKE lay out over the final 100 metres shifting wider on the track.

When spoken to regarding the performance of **PINZANO** which finished in last place rider S Wynne advised that in her opinion the mare had not handled the holding nature of todays Slow 7 track combined with the fact the mare had lay out from the 600 metres. Stewards ordered a post-race veterinary inspection of **PINZANO** with the subsequent inspection revealing no obvious abnormalities

Race 8	CROMBIE & PRICE LTD OAMARU CUP OPEN HCP 1600M

RIC O'SHEA began awkwardly and lost ground.

AMUN RA raced wide throughout.

RIC O'SHEA was held up early in the run home, when passing the 200 metres had to be steadied off heels and shifted outwards to find clear racing room.

Rider J Morris reported **DALWHINNIE** had not been comfortable with todays prevailing track conditions and had dipped on a number of occasions throughout the journey.

When spoken to regarding the performance of favoured runner **KEEPA TRAMP** rider T Moseley reported that when placed under pressure **KEEPA TRAMP** had failed to respond he also reported the gelding had experienced abnormal breathing over the concluding stages, Stewards requested a post-race veterinary examination which revealed no obvious abnormalities.

Race 9	THE CROMBIE CUP R75 2200M

STARBUCK shifted out at the start crowding **LA NOUVELLE VAGUE** who lost ground.

LUCILLE raced wide into the first bend.

LA NOUVELLE VAGUE was slow throughout the early to middle stages despite the efforts of rider L Callaway.

LUCILLE gave ground from the 600 metres finishing a distant last with a post-race veterinary examination of **LUCILLE** revealing no obvious abnormalities. Trainer C Anderton advised blood tests would be taken from the mare in coming days.

Passing the 150 metres **REVOLUTION EARTH** had to be steadied when crowded by **STARBUCK** (K Kalychurun) which shifted in under pressure, K Kalychurun was advised to exercise care.

ODABELLA raced in restricted room early in the run home. **OPERA KNIGHT** lay out over the concluding 100 metres shifting wider on the track.
