**ZAFRENZY** (K McCulloch) got its head up and raced ungenerously for a short distance leaving the straight on the first occasion.

Passing the 200 metres **SMEDLEY** (L Magorrian) shifted to the inside of **AFFOGATO** (A Collett) to obtain clear running with **AFFOGATO** then laying in, dictating **SMEDLEY** in on to **CANTERINO** which had to be briefly steadied.

**CHATEAU FIONN** (S Collett) shifted in abruptly on jumping away, hampering **ANNABELINDA** (L Magorrian) which lost ground (3L).

Approaching the 1400 metres **CELTIC BOY** (U Holmquist) raced in restricted room to the inside of **FIAMETTE** (Z Nor Azman) which shifted in with **CELTIC BOY** then being steadied. Rider Z Nor Azman was advised he must exercise greater care.

FIAMETTE got held up for a distance passing the 500 metres.

When questioned regarding the performance of **FIAMETTE** Apprentice Rider Z Nor Azman could offer no excuses other than he was not helped by being held up passing the 500 metres.

When questioned regarding the performance of **NINA ARORA** Rider K McCulloch advised the filly had been disappointing but may prefer further easing of the ground. **NINA ARORA** underwent a veterinary examination which could find no obvious abnormalities.

Rider S Collett advised Stewards that **CHATEAU FIONN** had felt uncomfortable when asked for an effort in the final straight, undergoing a subsequent veterinary examination which could find no obvious abnormalities. Trainer S Cole advised **CHATEAU FIONN** is to undergo an ECG on return to its stable.

Rider Z Nor Azman (FIAMETTE) was reminded of his obligations with regards to his whip use prior to the 200 metres.Race 8Harcourts High Tea At The Races - 6 August

**SILENCER** (Z Nor Azman) began awkwardly, shifting out making contact with **ASTRID** (S Spratt) forcing that runner out on to the hind quarters of **SO IT GOES** (L Magorrian) which became briefly unbalanced.

ALL ROADS (K McCulloch) began awkwardly, shifting out crowding SASANOF'S HERO (BR Jones) which had to be steadied.

SILENCER made contact with the running rail passing the 1300 metres.

HUNAPO (R Elliot) raced three wide until passing the 800 metres.

When questioned regarding the performance of **HUNAPO** the connections were of the opinion that the mare did not get 1400 metres and would keep her racing in the immediate future to shorter distances.

When questioned regarding the performance of **ASTRID** Rider S Spratt advised she had been asked to ride the filly in a forward position with the mare failing to respond when placed under pressure and otherwise could offer no tangible excuse.
