### **RACE COMMENTS:**

## Race 1 WOODS GROUP HURDLE

**DOCTOR HOOK** (E Goodinson) misjudged the fence near the 100 metres on the first occasion and landed very awkwardly dislodging its rider. The riderless **DOCTOR HOOK** then made heavy contact with **ZAMORA** (W Gordon) badly hampering that runner. Also inconvenienced were **COOLANGATTA** (A Browne), **MR BROWN** (M Mitchell) and **TELL ME MORE** (G Walsh). **DOCTOR HOOK** and rider E Goodinson were both uninjured.

**NOTHING** badly misjudged the fence near the 900 metres dislodging rider R Cole. Both horse and rider were uninjured.

**ZAMORA** and **HER SON** (M Cropp) were retired from the race prior to the second last fence when well beaten.

MR BROWN put in a poor jump at the second to last fence.

**MR BROWN** knuckled after jumping the last fence and fell. M Mitchell was uninjured. **MR BROWN** was winded and lay on the track for a period before regaining its feet. A post-race veterinary examination did not reveal any obvious abnormality other than some blood being present in the right nostril as a result of external trauma.

Rider S Karnicnik was spoken to regarding persevering with a horse when it is clearly out of contention, being advised that in the Stewards view **SINISTA** should have been retired from the race prior to the second last fence.

Race 2 FORGOTTEN HIGHWAY ADVENTURES HURDLE

**PUDDLE ALLEY** was a late scratching at 10.55 am on veterinary advice.

**BEVERLEY BECK** (E Goodinson) was slow away.

THENAMESBOND (A Browne) misjudged the second fence landing awkwardly inconveniencing NGATIRA GOLD (A Kuru).

**MAHARISHI** (M Cropp) and **NGATIRA GOLD** both misjudged the fence near the 300 metres on the first occasion landing awkwardly.

MAHARISHI hit the fence near the 1100 metres.

MASTER MICHAEL (S Karnicnik) put in a poor jump at the fence near the 900 metres.

**NGARIO** (S Fannin) and **MONI NUI** (M Mitchell) put in poor jumps at the final fence.

A Browne (THENAMESBOND) was spoken to regarding his whip use.

A Browne reported that in his opinion **THENAMESBOND** may have held its breath.

Rider S Karnicnik (MASTER MICHAEL) was spoken to regarding his whip use on a horse that was out of contention.

**THENAMESBOND** lost the left front plate during the running.

#### Race 3 MAKETU GENTLEMENS CLUB 3YO

LOLA JANE (C Lammas) was slow away.

**WAWRINKA** (R Elliot) raced in restricted room making contact with **MOTUMAN** (T Thornton) which was forced onto **ONLY IF** (C Grylls) near the 700 metres.

C Grylls (**ONLY IF**) and R Elliot (**WAWRINKA**) both reported that their respective mounts had failed to cope with today's very testing track conditions.

#### Race 4 KEANO @ SENTRY HILL FARM 1215

Trainer Mr J Bliss admitted a charge of neglect in saddling after omitting the lead bag when saddling **HOTSHOT LASS** (R Myers) being fined \$300 by the Judicial Committee.

**FANNY BLANKERS** (C Lammas) shifted outwards shortly after jumping away forcing **PEG** (V Gatu) out onto **RUBY RUEBEN** (Z Nor Azman) which was crowded losing ground when having to be steadied.

AVISTAR (M Hills) over-raced in the early and middle stages.

Apprentice Z Nor Azman (RUBY RUEBEN) was issued with a warning for his whip use prior to the 200 metres.

When questioned regarding the performance of **AVISTAR** rider M Hills advised that the gelding had failed to handle todays very heavy and testing track conditions.

#### Race 5 BUSY BEES CLEANING 1400

K McCulloch (ONEFORTHEDITCH) was issued with a warning for her whip use prior to the 200 metres.

C Lammas was fined \$400 by the Judicial Committee after admitting a charge in that he failed to ride his mount **I'M BRONSON** out to the finish of the race when there was a chance of it finishing in a higher placing (fifth) for which stake money was payable.

### Race 6 TAUMARUNUI RACING CLUB MEMBERS 1560

MERITAGGIO (S Collett) over-raced in the early stages.

**TAAXMAN** (E Farr) had to steady when racing in restricted room passing the 500 metres.

When questioned regarding the performance of **MERITAGGIO** rider S Collett advised that after racing keenly when leading in its most recent start she had ridden the mare further back in the field in an attempt to get it to settle, then when after travelling well it had hit a flat spot once placed under pressure approaching the 400 metres, but found the line well over the concluding stages.

C Lammas (UNDERTHEMOONLIGHT) was issued with a warning for his whip use prior to the 200 metres.

# Race 7 WARREN SINTON SPRINT

**DUFFERS CREEK** (S Wahab) was presented with incorrect gear. The stable representative was advised that a warning would be placed on record.

EL PESCADO (C Lammas) was slow away.

**OHOPE PRINCE** (R Elliot) over-raced in the early and middle stages.

KINDALEICA (C Grylls) had to be steadied off the heels of PAN DULCE (R Myers) near the 700 metres.

When questioned regarding the performance of **OHOPE PRINCE** apprentice R Elliot advised that the gelding had failed to cope with today's very heavy track conditions.

### Race 8 WOODS CONTRACTING TAUMARUNUI GOLD CUP

PERFECT START (C Lammas) and SECOND INNINGS (L Magorrian) were slow away.

When questioned regarding the performance of **REKA** rider C Grylls was unable to offer any excuses, but advised the gelding had been a beaten runner by the 800 metres. A post-race veterinary examination did not reveal any abnormality other than an elevated heart rate.

R Myers advised that her mount **KATIE MCKEEN** had never really travelled in today's track conditions, and had been unable to quicken once placed under pressure.

Apprentice L Magorrian (SECOND INNINGS) dropped his whip passing the 300 metres.

# Race 9 TAUMARUNUI & DISTRICTS RSA 2200

KALINDA (L Magorrian), WEE BISKIT (M Cropp) and GAGARIN (S Wahab) were all slow away.

THAT'S HOW IT GOES (E Farr) raced keenly in the early stages.

**ST SATURNIN** (B R Jones) commenced to give ground passing the 900 metres, and was not persevered with over the final 600 metres. A post-race veterinary examination did not reveal any abnormality other than an elevated heart rate.

**UNDISCOVERED** (U Holmquist) required veterinary treatment after pulling up lame in the right foreleg. Trainer Mr T Wenn was advised that a veterinary certificate of fitness will be required prior to **UNDISCOVERED** racing next.

# Race 10 JOE BRADLEY MEMORIAL 1400

**TRICKLE DOWN** (L Magorrian), **ADRIATIC PEARL** (B R Jones) and **THIRD TIME LUCKY** (R Myers) were all slow away. When questioned into the disappointing performance of **ADRIATIC PEARL** rider B R Jones advised that the mare may have choked down.
