Hawke's Bay Racing - 1 October 2016

**Race 6 SACRED FALLS HAWKES BAY GUINEAS**

Trainer S Marsh advised Stewards that **UGO FOSCOLO** underwent blood tests on return to his stable which returned clear of any abnormality, it is now his intention to continue on with the colt's preparation.

Trainer J Richards advised Stewards that he was satisfied with the recovery of **HEROIC VALOUR** following its performance on Saturday, Mr Richards confirmed it is now their intention to race the colt in blinkers at his next start.

**Race 7 STELLA ARTOIS 1400**

Trainer K Little advised Stewards that in the days following **LUCYINRIO** underwent a veterinary examination which did not reveal any obvious abnormality other than a laceration to the tongue of the mare.

**Race 8 LIVAMOL CLASSIC**

Trainer A Forsman advised Stewards that **MIME** had come through the run well, however it is now his intention to freshen the mare prior to racing next.

Canterbury Racing – North Canterbury - 1 October 2016

**Race 2 WELSH & ASSOCIATES RISK INSURANCE SPECIALISTS RATING 75 (1200m)**

Trainer S Richards advised Stewards that in the days following its performance **MADAME JAMAI** underwent a veterinary examination and blood tests which both failed to reveal any obvious abnormality. It is now his intention to freshen the mare and add blinkers prior to racing next.

**RACE COMMENTS:**

**Race 1 NZ All Golds Maiden 3YO (1100m)**

**MADAM BULLBARS** (D Prastiyou) – Late scratched at 1.35pm after refusing to enter the barriers. Trainer B Gillovic was advised that MADAM BULLBARS will be required to trial to the satisfaction of Stewards prior to racing again.

**PINE TOFF LAGER** (D Johnson) – Underwent a pre-race veterinary examination at the start and was cleared to run. Shifted out to obtain clear running passing the 300 metres.

**LADY BULLBARS** (M Du Plessis) – Crowded shortly after the start having to be steadied, then raced ungenerously in the early and middle stages. Made the bend near the 800 metres awkwardly. When questioned regarding the performance Rider M Du Plessis advised that the filly had got back further than intended and had not been entirely comfortable in today's track conditions.

**CASCATA** (S Weatherley) – Raced wide without cover throughout.

**SECRET STASH** (C Grylls) – Raced three wide without cover throughout.

**LUANA MANA** (M Coleman) – Held up for clear racing room early in the final straight.

**ORPHEA** (L Innes) – Raced in restricted room early in the final straight.

**Race 2 West Brook Wines 1100**

**LIGHT SHADOW** (L Satherley) – Slow to begin.

**FIRE JET** (D Prastiyou) – Crowded and hampered losing ground passing the 900 metres to the inside of BUFFALO LASS which lay in and away from ANOTHER GIRL. Rider S Weatherley was issued with a warning and advised that he must make a greater attempt to relieve pressure when his horses are shifting ground. When questioned regarding the

performance Apprentice Rider D Prastiyou advised that the gelding had struggled with the impost of 59 kilograms in a fresh condition on a track that he had not been entirely suited to.

**Race 3 Henderson Maiden (1200m)**

**MOET MOLLY** (L Satherley) – Began awkwardly. Commenced to over-race approaching the 800 metres.

**EQUILIBRIUM** (S Weatherley) – Began awkwardly losing ground.

**WHERE THERES SMOKE** (L Magorrian) – Raced ungenerously when being restrained passing the 1100 metres.

**PERFECT BEAT** (D Prastiyou) – Raced keenly in the early and middle stages.

**PISTOL PETE** (S Spratt) – **Rider S Spratt** admitted a breach in that she used her whip in an excessive manner prior to the 200 metres with the Judicial Committee imposing a fine of \$300.

**Race 4 Little Wonder @ Regal Fern Lodge 1200**

**CALLIGRAPHY** (V Gatu) – Slow to begin. Commenced to race ungenerously when being restrained off the heels of **KAREN IRIS** which shifted back when laying in passing the 1000 metres. **CALLIGRAPHY** then made the bend awkwardly near the 900 metres losing ground.

**WONDER WOMAN** (S Weatherley) – Began awkwardly.

**PRAIRIE CREEK** (R Elliot) – Raced wide without cover throughout. Lay in when placed under pressure in the final straight.

**DAN THE MAN** (A Sims) – Shifted out under pressure early in the final straight becoming awkwardly placed on heels near the 250 metres.

**KAREN IRIS** (L Satherley) – Steadied when placed in restricted room approaching the 400 metres.

**SMOOCHY** (B Hutton) – Briefly held up passing the 300 metres.

**Race 5 New Lynn 1300**

**BOJANGLES** (D Prastiyou) – Raced three wide without cover throughout.

**SIR HAROLD** (L Magorrian) – Held up entering the final straight having to shift ground inwards to obtain clear running.

**RAY'S LEGACY** (T Thornton) – Held up entering the final straight. Rider T Thornton was at a loss to explain the performance with **RAY'S LEGACY** undergoing a subsequent veterinary examination which could find no obvious abnormalities. Trainer N Bishara advised the gelding would undergo blood tests on return to his stable.

**Race 6 NZB Insurance Pearl Series Race (1300m)**

**AMOUR LA VIE** (L Innes) – Over-raced in the early to middle stages. Shifted out to obtain clear running near the 400 metres making contact with **EDEN ROSE**. When questioned regarding the performance, Rider L Innes advised the filly had failed to handle the existing track conditions.

**EDEN ROSE** (M McNab) – Bumped 400 metres.

**MAHANA** (V Gatu) – Commenced to lay out around the final bend and continued to lay out for the remainder of the race.

**DESTINY ONE** (C Grylls) – When questioned regarding the performance Rider C Grylls advised the filly had failed to handle the existing track conditions.

**Race 7** | **AJC Members Maiden (1600m)**

**LULU L'AMOUR** (S Weatherley) – Slow to begin.

**LONE WARRIOR** (S Spratt) – Raced ungenerously when being restrained passing the 1300 metres.

**STAN'S TUF TIGER** (A Sims) – Briefly unbalanced when contacted by MISS MAZZY passing the 400 metres.

**BOLD WARRIOR** (L Innes) – Lay out under pressure approaching the 250 metres making brief contact with APPREHEND.

**APPREHEND** (M Cameron) – Briefly contacted 250 metres.

**Race 8** | **Goodwin Property Management 1600**

**MIO KIWI** (R Elliot) – Steadied near 900 metres when awkwardly placed inside heels.

**WHITTAKER** (M Cameron) – Became awkwardly placed on heels when laying out approaching the 400 metres. WHITTAKER underwent a veterinary examination following the race which could find no apparent abnormalities.

**CRITICS CHOICE** (A Schwerin) – Apprentice Rider **A Schwerin** was issued with a warning regarding her use of the whip prior to the 200 metres.

**BRILLEAUX** (T Wenn) – Apprentice Rider **T Wenn** admitted a breach in that she used her whip in an excessive manner prior to the 200 metres with the Judicial Committee fining her \$300.
