Race 1	RIVERSTONE CAFÉ MAIDEN (2100 metres)				
AL MUNRO - reared at the start.					
TRISHA LEA – slo	TRISHA LEA – slow away.				
KEEPING FAITH - shifted in under pressure and bumped KOWHAI KERRY near the 250 metres.					
KOWHAI KERRY – disappointed, rider R Myers had no excuses.					
Race 2	VETS ON RIVERBANK MAIDEN (1200 metres)				
ANNALIESE LINCOLN - tightened at the start and got back.					
<b>ROADWORX</b> – awkward at the start, shifting out bumping outside runner					
SUO LIN NANG – began awkwardly, raced keenly in the early and middle stages.					

**RAYAS** – over-raced when steadied for a short distance towards the end of the back straight and was in restricted room near the 800 metres.

**POPCORN** – shifted out under pressure in the home straight.

Race 3	GARDNER HOMES HANDICAP (1200 metres)			
<b>TIGGER TAHNEE</b> (D Turner) – began awkwardly.				

**SPARCLING THYME** - hampered at the start and got back.

Over the final stages **TALK THE TORQUE** (T Johnson) shifted ground inwards simultaneously as **WHATWEDO** (Z Moki) shifted out, resulting in **WATCH YOUR MAN** (N Teeluck) having to check. Prior to the authorisation of dividends **N Teeluck** viewed footage of the final stages but elected not to proceed with an objection against the third placed **TALK THE TORQUE**. After questioning riders, **T Johnson** was issued with a warning under Rule 638(1)(d) and advised that he is expected to straighten his mount sooner than he did on this occasion. Stewards took into account outward movement from **WHATWEDO** when assessing the degree of interference.

**FARCE** - L Allpress had no tangible excuse other than being wide throughout.

### Race 4 HUNTING AND FISHING OTAKI MAIDEN (1400 metres)

Permission was sought and given by the stewards to shift the stalls forward several metres to avoid a bad patch of ground near the 1400 metre start.

**SAUVIGNON** (C-M Waddell) began very awkwardly and lost several lengths. Apprentice jockey Waddell was shown footage of the start in the presence of senior rider H Tinsley. Connections were advised that a warning is placed against **SAUVIGNON** with regard to its barrier manners. Trainer G Haigh advised the mare's future would be reassessed.

### Race 5 NZB INSURANCE PEARL SERIES RACE (1600 metres)

**THIRD TIME LUCKY** (Z Moki) – slow away, improved on to heels and over the final stages had to shift inwards near the finish to improve.

**ACUTELYGOLD** – raced keenly in the early and middle stages.

Race 6 DARIN BALCOMBE FAREWELL MAIDEN (1600 metres)

JITZU (D Bradley) – slow away.

FINAL ROSE -. A subsequent veterinary inspection did not reveal any abnormality.
